SECTION 2: Title 1, Chapter 16, Section 50, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

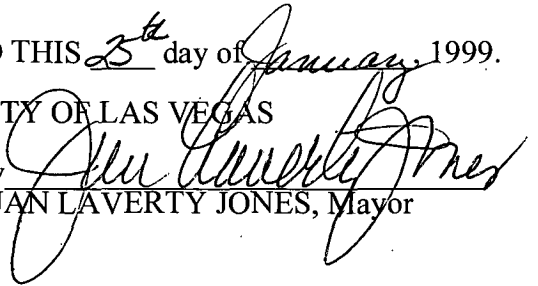
SECTION 3: If any section, subsection, subdivision, paragraph, sentence, clause or

10 1983 Edition, in conflict herewith are hereby repealed.
