ORDINANCE NO. 5152

AN ORDINANCE AMENDING THE GENERAL PLAN OF THE CITY OF LAS VEGAS, NEVADA, AS ADOPTED BY ORDINANCE NO. 3636, TO ADOPT AS A PART THEREOF THAT CERTAIN DOCUMENT ENTITLED THE "NORTHWEST SECTOR PLAN"; PROVIDING THAT, EXCEPT AS OTHERWISE SPECIFIED, THE DOCUMENT SO ENTITLED REPLACES AND SUPERSEDES THAT CERTAIN DOCUMENT ENTITLED THE "NORTHWEST AREA GENERAL PLAN AMENDMENT TO THE CITY OF LAS VEGAS GENERAL PLAN," AS ADOPTED BY ORDINANCE NO. 4049 AND SUBSEQUENTLY AMENDED; DESCRIBING THE INTERRELATIONSHIP BETWEEN THE DOCUMENT HEREIN ADOPTED AND THE PROVISIONS OF THE GENERAL PLAN ITSELF; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HERewith.

Summary: Adopts the Northwest Sector Plan
as part of the City's General Plan.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN
AS FOLLOWS:

SECTION 1: The General Plan of the City of Las Vegas, Nevada, as adopted by Ordinance No. 3636 and as subsequently amended, is hereby amended further by adopting as a part thereof that certain document entitled the "Northwest Sector Plan," the provisions of which were approved by the Planning Commission on the 15th day of April, 1999, and copies of which shall be on file in the office of the City Clerk and in the Planning and Development Department.

SECTION 2: The provisions of the Northwest Sector Plan shall replace and supersede the provisions of the document entitled "Northwest Area General Plan Amendment to the City of Las Vegas General Plan," as adopted by Ordinance No. 4049 and subsequently amended, except for the provisions of the following, which shall remain in full force and effect:

(A) Section 5.11 (Electrical Power Distribution), including its corresponding Map 9; and

(B) Section 5.12 (Goals, Objectives, Policies and Programs).

SECTION 3: To the extent practicable, all provisions of the City of Las Vegas General Plan shall apply to the area governed by the Northwest Sector Plan, but the provisions of the Northwest Sector Plan shall govern to the extent of any inconsistency.

SECTION 4: If any section, subsection, subdivision, paragraph, sentence, clause or

1 phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional, or invalid
2 or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or
3 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the
4 City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision,
5 paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections,
6 subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional,
7 invalid or ineffective.

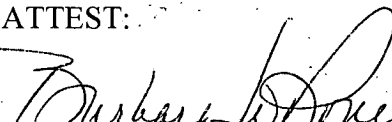
8 SECTION 5: All ordinances or parts of ordinances or sections, subsections, phrases,

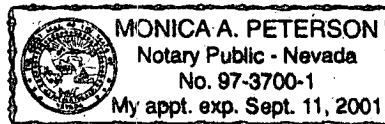

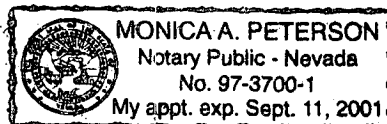
