AN ORDINANCE RELATING TO ADMINISTRATION; AMENDING TITLE 2, CHAPTER 2, SECTIONS 50 AND 60, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, TO CHANGE THE DATES FOR REGULAR SCHEDULED MEETINGS OF THE LAS VEGAS CITY COUNCIL TO THE FIRST AND THIRD WEDNESDAY OF EACH MONTH; SETTING THE EFFECTIVE DATE FOR THE ORDINANCE; PROVIDING FOR OTHER MATTERS RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

Summary: Changes the dates of regularly scheduled meetings of the Las Vegas City Council and other matters relating thereto.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN
AS FOLLOWS:

SECTION 1: Title 2, Chapter 2, Section 50 of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended as follows:

2.02.050 The Council shall meet in regular session twice each month, on the [second and fourth Mondays] first and third Wednesdays in each month, unless one or both of the meetings is canceled as provided for in Section 2.02.060; provided, however, that at least one regular Council meeting is held during each month.

SECTION 2: Title 2, Chapter 2, Section 60, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

2.02.060 (A) A regular meeting of the City Council shall be canceled if it falls on a [Monday] Wednesday which is a legal holiday and shall be held on the first successive day which is not a holiday; provided, however, that the City Council may, at any regular meeting thereof which is held prior to the meeting which is canceled by virtue of this Subsection, establish a different date for such regular meeting.

(B) A regular meeting of the City Council may be canceled in advance thereof by the Mayor or by any two members of the City Council if it appears that a quorum of the City Council may not be present at such meeting, and all matters which were scheduled for consideration at that meeting may:

1 (1) Automatically be placed on the agenda for the next regular meeting of
2 the City Council, and the City Clerk shall give notice of such cancellation and rescheduling by any
3 means reasonably calculated to give notice thereof to all interested parties, or

4 (2) Be considered at a meeting that has been set by the City Council as a
5 rescheduling of the canceled meeting, provided that notice of the rescheduling is published in the
6 manner provided for the publication of notices which are required by Article VIII of the City Charter.

7 (C) If a majority of the members of the City Council fails to appear at any regular
8 or special meeting thereof, the member or members in attendance may recess such meeting to a time
9 certain or cancel the same pursuant to Subsection (B) of this Section. If the meeting is recessed to a
10 time certain, no notice of the new date and time need be given.

11 SECTION 3: This ordinance shall become effective upon adoption and publication and
12 the meeting dates shall be changed to the first and third Wednesday of each month beginning with the
13 first monthly meeting of August, 1999.

14 SECTION 4: If any section, subsection, subdivision, paragraph, sentence, clause or
15 phrase in this ordinance or any part thereof is for any reason held to be unconstitutional or invalid or
16 ineffective by any court of competent jurisdiction, such decision shall not affect the validity or
17 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the
18 City of Las Vegas, Nevada, hereby declares that it would have passed each section, subsection,
19 subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more
20 sections, subsections, subdivisions, paragraphs, sentences, clauses, or phrases be declared
21 unconstitutional, invalid or ineffective.

22 SECTION 5: All ordinances or parts of ordinances, sections, subsections, phrases,
23 sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas,

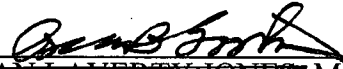

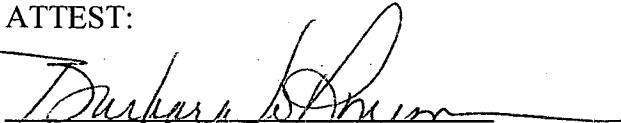

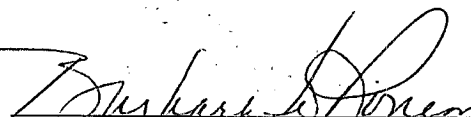

1 by the Mayor or by any two members of the City Council if it appears that a quorum of the City
2 Council may not be present at such meeting, and all matters which were scheduled for consideration
3 at that meeting may:

4 (1) automatically be placed on the agenda for the next regular meeting of
5 the City Council, and the City Clerk shall give notice of such cancellation and rescheduling by any
6 means reasonably calculated to give notice thereof to all interested parties, or

7 (2) be considered at a meeting that has been set by the City Council as
8 a rescheduling of the canceled meeting, provided that notice of the rescheduling is published in the
9 manner provided for the publication of notices which are required by Article VIII of the City
10 Charter,

11 (C) If a majority of the members of the City Council fails to appear at any regular
12 or special meeting thereof, the member or members in attendance may recess such meeting to a
13 time certain or cancel the same pursuant to Subsection (B) of this Section. If the meeting is
14 recessed to a time certain, no notice of the new date and time need be given.

15 SECTION 3: This ordinance shall become effective upon adoption and publication
16 and the meeting dates shall be changed to the first and third Wednesday of each month beginning
17 with the _____ monthly meeting of _____, 1999.

18 SECTION 4: If any section, subsection, subdivision, paragraph, sentence, clause or
19 phrase in this ordinance or any part thereof is for any reason held to be unconstitutional or invalid
20 or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or
21 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of
22 the City of Las Vegas, Nevada, hereby declares that it would have passed each section, subsection,
23 subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or
24 more sections, subsections, subdivisions, paragraphs, sentences, clauses, or phrases be declared
25 unconstitutional, invalid or ineffective.

1 SECTION 5: All ordinances or parts of ordinances, sections, subsections, phrases,
2 sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas,
3 Nevada, 1983 Edition, in conflict herewith are hereby repealed.

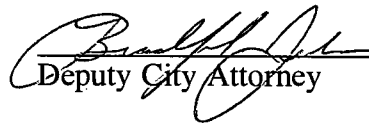

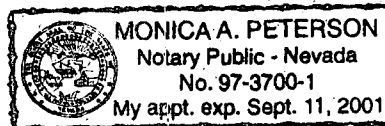

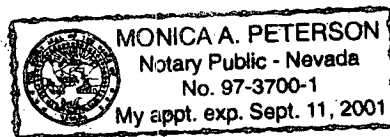
