15 THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY
16 ORDAIN AS FOLLOWS:

17 SECTION 1: That certain document entitled "A Supplemental Document
18 Amending The Uniform Administrative Code, 1994 Edition," adopted by Ordinance No. 3906 of
19 the City of Las Vegas as part of Title 16, Chapter 2, Section 10, of the Municipal Code of the
20 City of Las Vegas, 1983 Edition, is hereby amended by adding thereto the provisions set forth
21 as Sections 2 and 3 of this Ordinance.

22 SECTION 2: Section 303 of the Uniform Administrative Code, 1994
23 Edition, is hereby amended by adding thereto a new subsection, designated as Subsection 303.6,
24 reading as follows:

25 **303.6** The Building Official may establish an Express Plan Review System to
26 facilitate the expedited review of building plans on behalf of applicants who request
and qualify for such review. The Building Official may also establish such
procedures as are deemed necessary or advisable in order to implement the Express
Plan Review System, including reasonable conditions and limitations upon which
the use of the System is made available. The fee for such service shall be as set

1 forth in Subsection 304.3.10.

2 SECTION 3: Section 304 of the Uniform Administrative Code, 1994
3 Edition, is hereby amended by adding thereto a new subsection, designated as Subsection
4 304.3.10, reading as follows:

5 **304.3.10** The fee for Express Plan Review pursuant to Subsection 303.6 shall be
6 \$600.00 per hour (calculated to the next quarter hour) of time during which review
7 staff are engaged in the review process. In order to use the Express Plan Review
8 System, the applicant shall pay a separate, non-refundable administrative fee in the
9 amount of \$500.00 for each set of plans to be reviewed. The hourly fee for
10 Express Plan Review and the administrative fee may be adjusted from time to time
11 by resolution of the City Council. The fees described in this Section are
12 independent of and in addition to any other fee, including regular plan review fees.

13 SECTION 4: If any section, subsection, subdivision, paragraph, sentence,
14 clause or phrase in this ordinance or any part thereof is for any reason held to be unconstitutional
15 or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the
16 validity or effectiveness of the remaining portions of this ordinance or any part thereof. The City
17 Council of the City of Las Vegas, Nevada, hereby declares that it would have passed each section,
18 subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that
19 any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses, or phrases
20 be declared unconstitutional, invalid or ineffective.

21 SECTION 5: All ordinances or parts of ordinances, sections, subsections,
22 phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las

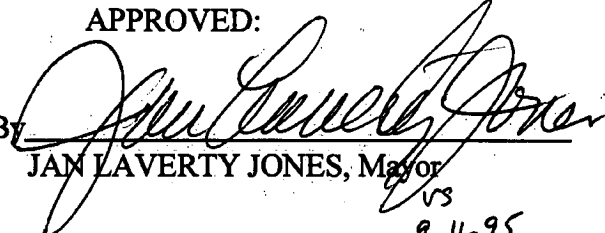

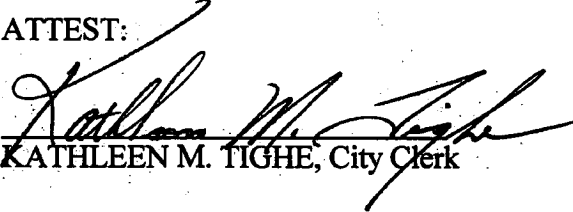

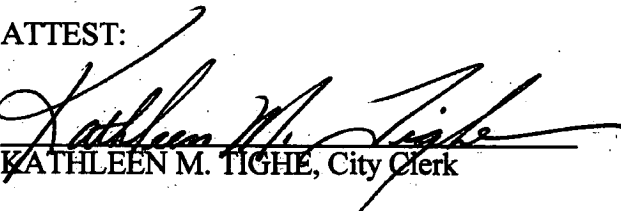
