14 SECTION 1: Title 2, Chapter 9, Section 10 of the Municipal Code of the City
15 of Las Vegas, Nevada, 1983 Edition, is hereby amended as follows:

16 2.09.010 The departments of the City shall consist of the following:

17 [(A) Building and Safety;]

18 [(B)](A) City Attorney;

19 [(C)](B) City Clerk;

20 [(D) Community Planning and Development;]

21 [(E)](C) Detention and Enforcement;

22 [(F)](D) Economic and Urban Development;

23 [(G)](E) Finance and Business Services;

24 [(H)](F) Fire Services;

25 [(I)](G) General Services;

26 (H) Human Resources;

1 [(J)](I) Municipal Court;

2 [(K)](J) Parks and Leisure Activities;

3 (K) *Planning and Development*;

4 [(L) Human Resources;]

5 [(M)](L) Public Works.

6 SECTION 2: Title 2, Chapter 9, Section 20 of the Municipal Code of the City
7 of Las Vegas, Nevada, 1983 Edition, is hereby amended as follows:

8 2.09.020 The Department of [Building and Safety] *Planning and Development*
9 shall consist of the following divisions:

10 (A) [Building inspection]*Comprehensive Planning*;

11 (B) [Electrical inspection]*Geographic Information Systems*;

12 (C) [Plumbing inspection]*Current Planning*;

13 (D) [Plans check]*Permits*;

14 (E) [Contract/subdivision]*Inspections*;

15 (F) [Office administration]*Neighborhood Planning*;

16 (G) *Neighborhood Response*;

17 (H) *Neighborhood Resources*;

18 (I) *Neighborhood Improvements*.

19 SECTION 3: Title 2, Chapter 9, Sections 50 of the Municipal Code of the City
20 of Las Vegas, Nevada, 1983 Edition, is hereby repealed.

21 SECTION 4: Whenever in the Las Vegas Municipal Code the term "Department
22 of Building and Safety" appears, the new title, "Department of Planning and Development" shall
23 be substituted. Whenever in the Las Vegas Municipal Code the term "Department of Community
24 Planning and Development" appears, the new title, "Department of Planning and Development"
25 shall be substituted. Whenever in the Las Vegas Municipal Code the terms "Director of Building

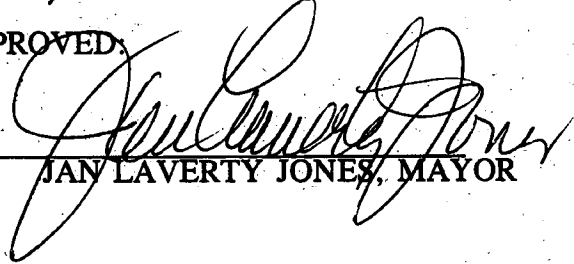
1 and Safety", "Director of Community Planning and Development" or "Director" (used in a
2 context referring to the Director of the Department of Building and Safety or the Director of
3 Community Planning and Development) should appear, the term "Director of Planning and
4 Development" shall be substituted.

5 SECTION 5: If any section, subsection, subdivision, paragraph, sentence, clause
6 or phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional, or
7 invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the
8 validity or effectiveness of the remaining portions of this ordinance or any part thereof. The City
9 Council of the City of Las Vegas hereby declares that it would have passed each section,
10 subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that
11 any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases be
12 declared unconstitutional, invalid or ineffective.

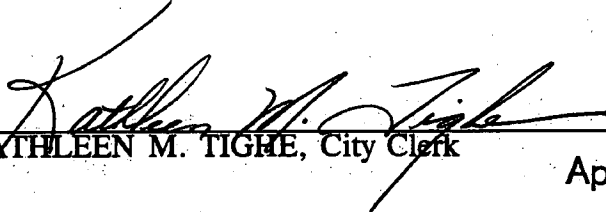
13 SECTION 6: All ordinances or parts of ordinances, sections, subsections,

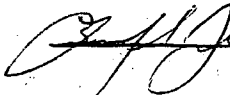

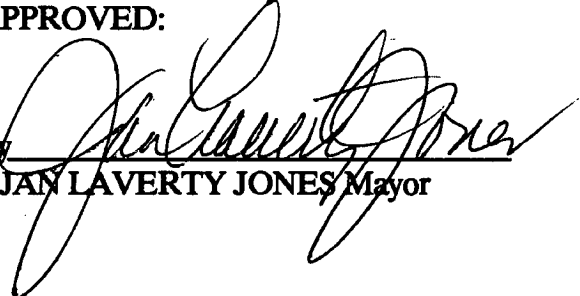

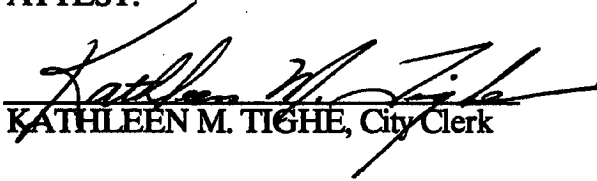
