FIRST AMENDMENT

AN ORDINANCE CONCERNING CITY OF LAS VEGAS, NEVADA, SPECIAL IMPROVEMENT DISTRICT NO. 1405 (RAMPART BOULEVARD), CITY OF LAS VEGAS, NEVADA, SPECIAL IMPROVEMENT DISTRICT NO. 1407 (BUFFALO DRIVE), CITY OF LAS VEGAS, NEVADA, SPECIAL IMPROVEMENT DISTRICT NO. 1413 (ALPINE/TRENT AREA) AND CITY OF LAS VEGAS, NEVADA, SPECIAL IMPROVEMENT DISTRICT NO. 1414 (LAKE MEAD BOULEVARD); AUTHORIZING THE ISSUANCE, IN A SINGLE ISSUE, OF REGISTERED SPECIAL ASSESSMENT, LOCAL IMPROVEMENT BONDS, SERIES OCTOBER 1, 1995, FOR SAID DISTRICTS IN THE PRINCIPAL AMOUNT OF \$2,249,000.00 TO FINANCE THE CONSTRUCTION AND INSTALLATION OF CERTAIN LOCAL IMPROVEMENTS; ACCEPTING A BID FOR THE PURCHASE OF SUCH BONDS; APPROVING, RATIFYING AND CONFIRMING ALL ACTION PREVIOUSLY TAKEN IN CONNECTION WITH EACH OF SAID DISTRICTS; PROVIDING FOR THE ISSUANCE AND SALE OF FULLY REGISTERED BONDS IN VARIOUS DENOMINATIONS; PRESCRIBING THE FORM OF SAID BONDS; PROVIDING THE SOURCE OF PAYMENT AND OTHER DETAILS IN CONNECTION THEREWITH AND OTHER MATTERS RELATING THERETO; AND PROVIDING THAT SAID ORDINANCE SHALL BECOME EFFECTIVE THE DAY FOLLOWING THE PUBLICATION THEREOF, BY TITLE ONLY, IN A NEWSPAPER PUBLISHED AND OF GENERAL CIRCULATION WITHIN SAID CITY.

Summary: Authorizes

WHEREAS, the City Council of the City of Las Vegas (the "City Council" and the "City", respectively, herein) in the County of Clark and State of Nevada (the "State" herein), has taken all of the requisite legal action that is preliminary to and in the creation of those certain special improvement districts that have been designated and identified as "City of Las Vegas, Nevada, Special Improvement District No 1405 (Rampart Boulevard)", "City of Las Vegas, Nevada, Special Improvement District No. 1407 (Buffalo Drive)", "City of Las Vegas, Nevada, Special Improvement District No. 1413 (Alpine/Trent Area)" and "City of Las Vegas, Nevada, Special Improvement District No. 1414 (Lake Mead Boulevard)" (said Districts being referred to herein individually as

“Improvement District No. 1405”, “Improvement District No. 1407”, “Improvement District No. 1413” and “Improvement District No. 1414”, respectively, or generically as a “District” and sometimes collectively as the “Districts”) for the purposes of providing for the construction and installation therein of certain local improvements and of defraying the entire cost and expense thereof by special assessments against the assessable lots and parcels of property within each assessment unit of the respective Districts according to the benefits that were anticipated would be derived from such improvements by the respective lots and parcels that were proposed to be so assessed, all in accordance with the provisions of the Nevada Revised Statutes (“NRS” herein) that provide therefor; and

WHEREAS, the City Council, pursuant to Ordinance No. 3740 that was duly passed, adopted and approved on the 6th day of October, 1993, created Improvement District No. 1405, ordered the construction and installation therein of the proposed local improvements (the "District 1405 Project" herein) and determined to defray a portion of the entire cost and expense of the District 1405 Project by special assessments, according to the benefits as aforesaid, against the respective assessable lots and parcels of property that would be benefited thereby; and

WHEREAS, the City Council, pursuant to Ordinance No. 3756 that was duly passed, adopted and approved on the 17th day of November, 1993, created Improvement District No. 1407, ordered the construction and installation therein of the proposed local improvements (the "District 1407 Project" herein) and determined to defray a portion of the entire cost and expense of the District 1407 Project by special

assessments, according to the benefits as aforesaid, against the respective assessable lots and parcels of property that would be benefited thereby; and

WHEREAS, the City Council, pursuant to Ordinance No. 3743 that was duly passed, adopted and approved on the 20th day of October, 1993, created Improvement District No. 1413, ordered the construction and installation therein of the proposed local improvements (the "District 1413 Project" herein) and determined to defray a portion of the entire cost and expense of the District 1413 Project by special assessments, according to the benefits as aforesaid, against the respective assessable lots and parcels of property that would be benefited thereby; and

WHEREAS, the City Council, pursuant to Ordinance No. 3716 that was duly passed, adopted and approved on the 16th day of June, 1993, created Improvement District No. 1414, ordered the construction and installation therein of the proposed local improvements (the "District 1414 Project" herein) and determined to defray a portion of the entire cost and expense of the District 1414 Project by special assessments, according to the benefits as aforesaid, against the respective assessable lots and parcels of property that would be benefited thereby; and

WHEREAS, the City Council, pursuant to Ordinance No. 3902 that was duly passed, adopted and approved on the 5th day of July, 1995 (the "District 1405 Assessment Ordinance" herein), levied assessments in the aggregate amount of \$926,864.00 against the assessable lots and parcels of property that have been benefited by the District 1405 Project, and, at the close of the 30-day cash payment period on the

24th day of August, 1995, there remained unpaid valid assessments against such lots and parcels in the aggregate amount of not less than \$926,864,000.00; and

WHEREAS, the City Council, pursuant to Ordinance No. 3911 that was duly passed, adopted and approved on the 19th day of July, 1995 (the "District 1407 Assessment Ordinance" herein), levied assessments in the aggregate amount of \$955,263.00 against the assessable lots and parcels of property that have been benefited by the District 1407 Project, and, at the close of the 30-day cash payment period on the 24th day of August, 1995, there remained unpaid valid assessments against such lots and parcels in the aggregate amount of not less than \$849,997.49; and

WHEREAS, the City Council, pursuant to Ordinance No. 3912 that was duly passed, adopted and approved on the 19th day of July, 1995 (the "District 1413 Assessment Ordinance" herein), levied assessments in the aggregate amount of \$324,821.00 against the assessable lots and parcels of property that have been benefited by the District 1413 Project, and, at the close of the 30-day cash payment period on the 24th day of August, 1995, there remained unpaid valid assessments against such lots and parcels in the aggregate amount of not less than \$262,001.46; and

WHEREAS, the City Council, pursuant to Ordinance No. 3903 that was duly passed, adopted and approved on the 5th day of July, 1995 (the "District 1414 Assessment Ordinance" herein), levied assessments in the aggregate amount of \$456,582.00 against the assessable lots and parcels of property that have been benefited by the District 1414 Project, and, at the close of the 30-day cash payment period on the

24th day of August, 1995, there remained unpaid valid assessments against such lots and parcels in the aggregate amount of not less than \$212,402.05; and

WHEREAS, the unpaid valid assessments in each District are payable in twenty (20) substantially equal semiannual installments of principal, with interest in all cases on the unpaid and deferred installments from the effective date of the respective Assessment Ordinances, i.e., the 25th day of July, 1995, at a rate per annum that may not exceed by more than one percent (1%) the highest rate of interest that is borne by the bonds that are hereinafter authorized to be sold (the effective interest rate on which may not exceed by more than three percent (3%) the "Index of Twenty Bonds" that was most recently published in The Bond Buyer before the date on which the bids for the purchase of such bonds were received), both principal and interest being payable semiannually at the Office of the City Treasurer of the City (the "City Treasurer" herein) on the 25th days of January and July in each year, commencing on the 25th day of January, 1996; and

WHEREAS, the City Council has determined, and by this Ordinance does so determine, that it is necessary and in the best interests of the City, each of the Districts and the inhabitants thereof that the City issue in a single issue, pursuant to NRS 271.485, as the same was amended in Section 2 of Chapter 16, Statutes of Nevada 1995, its City of Las Vegas, Nevada, Special Improvement District Nos. 1405 (Rampart Boulevard), 1407 (Lake Mead Drive), 1413 (Alpine/Trent Area) and 1414 (Lake Mead Boulevard) Special Assessment, Local Improvement Bonds, Series October 1, 1995 (the "Bonds" herein), in the aggregate principal amount of \$2,249,000.00, which is an amount that does not exceed the aggregate amount of the assessments that were levied upon the lots and parcels

of property within the combined Districts that remained payable in installments at the close of such 30-day cash payment period, nor does the portion of the principal amount of the Bonds that is attributable to any one District exceed the total uncollected assessments that were levied in that District; and

WHEREAS, the City Council has elected, and by this Ordinance does so elect, to have NRS Chapter 348 apply to the Bonds; and

WHEREAS, the City received sealed bids for the purchase of the Bonds and publicly opened the same in Las Vegas, Nevada, on Wednesday, the 6th day of September, 1995; and

WHEREAS, the City Council has determined, and by this Ordinance does so determine, that the bid that was submitted by Prudential Securities, Incorporated, of New York, New York (the "Purchaser" herein), for the principal amount thereof,\* a premium of \$ Ø \_\_\_\_\_,\* \*\*less a discount of \$33,294.20,\*\* and the interest that will accrue thereon from the date of the Bonds to the date of the delivery of the Bonds at the interest rate or rates that are herein designated, is the best responsible bid for the purchase of the Bonds, which proposal is hereby formally accepted; and

WHEREAS, the City Council has heretofore, pursuant to that certain Resolution that was duly passed, adopted and approved on the 3rd day of June 1992, established the City of Las Vegas Special Improvement District Surplus and Deficiency Fund (the "Surplus and Deficiency Fund" herein) in accordance with NRS 271.428.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

Section 1. That this Ordinance shall be known, and may be cited by the short title, as the "Improvement District Nos. 1405, 1407, 1413 and 1414 Bond Ordinance".

Section 2. That it shall be the duty of the City to receive, collect and enforce the payment of each of the assessments in the several Districts that has been made and levied for the purpose of defraying, in part, the cost and expense of the District 1405 Project, the District 1407 Project, the District 1413 Project and the District 1414 Project (individually a "Project" and collectively the "Projects" herein), each of the installments of such assessments, all of the interest thereon (at a rate that is to be hereafter determined) and all of the penalties, if any, that have accrued thereon, all as is provided by law and in the manner and at the time or times that are specified in the respective Assessment Ordinances and in this Ordinance, and to pay and disburse such assessments, including the installments thereof, the interest thereon and the penalties, if any, in connection therewith to any person who is lawfully entitled to receive the same.

Section 3. That the City Treasurer be, and he hereby is, designated by the City Council to implement the provisions of Section 2 of this Ordinance, and, in so doing, he shall be, and hereby is, authorized, empowered and directed to receive, collect and enforce, and it shall be his duty to receive, collect and enforce, the payment of each of the assessments that have been made and levied for the purpose of defraying, in part, the cost and expense of the Projects, each of the installments of such assessments, all of the interest thereon (at a rate that is to be hereafter determined), and all of the penalties, if any, that have accrued thereon, all as is provided by law and in the manner and at the time

or times that are specified in the respective Assessment Ordinances and in this Ordinance, and to pay and disburse such assessments, including the installments thereof, the interest thereon and the penalties, if any, in connection therewith to any person who is lawfully entitled to receive the same, all in accordance with the ordinances and resolutions of the City that have heretofore been, or are hereafter to be, adopted. All of the monies that are received from such assessments from and after the 24th day of August, 1995, the 30th day following the effective date of each of the Assessment Ordinances, both principal and interest, shall be placed in a separate fund that is to be designated as the "City of Las Vegas, Nevada, Special Improvement District Nos. 1405, 1407, 1413 and 1414 Bond Fund" (the "Bond Fund" herein) and shall be used, as soon as the funds are available for such purpose, to pay the principal of, the interest on and any prior redemption premium that is due in connection, with the Bonds, and for no other purpose whatsoever, and, as security for such payment, the Bond Fund is hereby exclusively pledged to such payment, except as is herein otherwise specifically provided. The City Treasurer shall be, and he hereby is, also authorized, empowered and directed to receive and collect, and it shall be his further duty to receive and collect, the surplus monies, if any, that are attributable to any of the Districts pursuant to NRS 271.428, to place all of such surplus monies in the Surplus and Deficiency Fund and to hold on deposit and disburse the same in any manner that is authorized by NRS 271.428, including without limitation for the payment of the principal of, and the interest on, the Bonds, to the extent that is necessary, if any payment from the Surplus and Deficiency Fund is necessary.

Section 4. That, if the owner of any lot or parcel of property that is assessed for any of the Projects shall be delinquent in the payment of either the principal of any installment of the assessment that has been levied upon such lot or parcel or the interest on such installment, or both, it shall be the duty of the City Council forthwith to cause the Purchaser and the owner of the lot or parcel with respect to which such delinquency exists to be notified in writing of such delinquency, and, if such delinquency shall not be paid within ten (10) days after such notice has been given, the City Council shall forthwith cause the City Treasurer and the other officers of the City to foreclose the special assessment lien upon the lot or parcel with respect to which such delinquency exists by any method that is now or may hereafter be provided by law. If such foreclosure is not filed and prosecuted within a reasonable time, the owner of any of the Bonds may file and prosecute a foreclosure action in the name of the City and may also proceed against the City in the manner that is specified in each Assessment Ordinance. All of the net proceeds from collecting any delinquent assessment shall be deposited in the Bond Fund (or, to the extent that is specified in Section 8 of this Ordinance, deposited in the general fund of the City) and, in any event, in an amount that is not less than the principal amount of such assessment and the interest that had accrued thereon to the date of such collection.

Section 5. That, for the purpose of defraying the entire cost and expense of the Projects (except to the extent that funds are available for such purpose from that part of such assessments that have heretofore been paid and except to the extent that other funds are available for such purpose), there shall be issued in the name of the City, the

City's fully registered (i.e., registered as to the payment of both the principal and the interest thereon) special assessment bonds that are designated as the "City of Las Vegas, Nevada, Special Improvement District Nos. 1405 (Rampart Boulevard), 1407 (Buffalo Drive), 1413 (Alpine/Trent Area) and 1414 (Lake Mead Boulevard) Special Assessment, Local Improvement Bonds, Series October 1, 1995", in the aggregate principal amount of \$2,249,000.00, which Bonds shall be dated as of the 1st day of October, 1995, and, except as is provided in Section 12 of this Ordinance, shall be in the denomination of \$5,000 each (except for the one Bond that has the October 1, 1996, maturity date, which will be in the denomination of \$1,000.00, or any integral multiple thereof that does not exceed \$5,000.00), and such Bonds may be in any denomination that is an integral multiple of \$5,000; provided, however, that no Bond may be in a denomination that exceeds the principal that becomes due on any maturity date, and no Bond may be issued for more than one maturity. The Bonds shall bear interest, at the rates per annum that are hereinafter designated, from the most recent interest payment date to which such interest has been paid or duly provided for, or, if no interest has been paid, from the date of the Bonds, to their respective maturities, payable on the 1st day of April, 1996, and semiannually thereafter on the 1st days of October and April in each year. The Bonds shall mature serially on the 1st day of October in each of the amounts and years that are designated as follows:

The Bonds shall be payable in lawful money of the United States of America without deduction for exchange or collection charges at the Office of the City Treasurer in the Las Vegas City Hall Complex, 400 East Stewart Avenue, Las Vegas, Nevada 89101. If, upon the presentation of any Bond, at or after its maturity, the payment thereof is not made as is herein provided, interest thereon shall continue at the same rate per annum until the principal thereof is paid in full. The principal of, the interest on and any prior redemption premium that may be due in connection with, any Bond shall be payable to the registered owner thereof as the same is identified in the registration records that are kept by the City Treasurer, being both the registrar (i.e., the transfer agent) (the "Registrar" herein) and the paying agent (the "Paying Agent" herein) for the Bonds, upon the maturity thereof and upon the presentation and surrender of such Bond to the Paying Agent. Except as is otherwise provided in Section 12 of this Ordinance, the payment of the interest on any Bond shall be made to the registered owner thereof by way of a check or draft that is mailed by the Paying Agent, on or before each interest payment date (or, if such interest payment date is not a business day, on or before the next succeeding business day), to the registered owner thereof, at such owner's address as it last appears in the registration books that are kept by the Registrar (or by such other arrangement as may be mutually agreed upon between the Paying Agent and any registered owner), on the fifteenth day of

the calendar month that precedes each interest payment date (the "Regular Record Date" herein) or on a special record date (the "Special Record Date" herein) if one is established by the Paying Agent for the payment of any defaulted interest on the Special Record Date. All such payments shall be made in lawful money of the United States of America.

Section 6. That each of the Bonds shall be subject to prior redemption from any monies that are legally available for that purpose, at the option of the City, from any maturity (in any order of maturity and by lot within a maturity), on any interest payment date that is prior to its maturity, at a price that is equal to the principal amount thereof, the interest that will have accrued thereon to the redemption date and a premium that is equal to three percent (3%) of the principal amount of the Bond that is so redeemed. The prior redemption premium shall be paid from the three percent (3%) prepayment premium with respect to the special assessments that is provided for in each Assessment Ordinance; provided, however, that nothing that is contained herein shall prevent the payment of any such redemption premium from any other funds that may be available for that purpose. If less than all of the Bonds, or less than all of the Bonds that have a single maturity, are being called, such Bonds will be selected by the Paying Agent by lot, giving proportionate weight to Bonds in denominations that are larger than \$5,000, all in such a manner as the Paying Agent may determine. Whenever it is considered to be advisable by the City Treasurer, and whenever funds are available for such purpose, he, as the Paying Agent, may call a suitable amount of the Bonds for payment. In the case of a Bond that has a denomination that is larger than \$5,000, a portion of such Bond (\$5,000 or any integral multiple thereof) may be redeemed, in which case the Registrar shall,

without charge to the owner of such Bond, authenticate and issue a replacement Bond or Bonds in an amount that is equal to the unredeemed portion thereof. Unless such notice is waived by the registered owner of a Bond that is to be redeemed, a notice of redemption shall be given by the Registrar, in the name of the City, by mailing such notice not less than thirty (30) days and not more than sixty (60) days prior to the redemption date, by registered or certified mail, to the registered owner (initially Cede & Co., as the nominee of The Depository Trust Company (the "DTC" herein), the securities depository for the Bonds) of each Bond that is to be redeemed and to the Purchaser. The failure to give such notice to the registered owner of any Bond, or any defect in such notice, shall not affect the validity of the proceedings for the redemption of any other Bond. All such notices shall be dated and shall state: (1) the redemption date, (2) the redemption price, (3) if less than all of the outstanding Bonds are to be redeemed, the identification (and, in the case of a partial redemption, the respective principal amounts) of the Bonds that are to be redeemed, (4) that on the redemption date the redemption price will become due and payable upon each Bond, or portion thereof, that is called for redemption and that the interest thereon shall cease to accrue from and after such date and (5) the place at which such Bonds are to be surrendered in exchange for the payment of the redemption price, which place of payment shall be the office of the Paying Agent. After such notice has been given in the manner that is hereinabove provided, each of the Bonds that is called for redemption shall become due and payable on the designated redemption date, and, upon the presentation thereof, the City will pay the redemption price for each of the Bonds that is called for redemption. The installments of the interest that become due prior to and on

the redemption date shall be payable in the manner that is provided herein for the payment of interest. A certificate by the Registrar that a notice of redemption has been given in the manner that is set forth herein shall be conclusive, and the receipt by the owner of any Bond of a notice of redemption shall not be a condition precedent to the redemption of that Bond.

Section 7. That, except as is otherwise provided in Section 12 of this Ordinance, the person in whose name a Bond is registered in the registration books that are kept by the Registrar shall be deemed and regarded to be the absolute owner thereof for all purposes, and the payment of the principal of, the interest on and any prior redemption premium that may be due in connection with, any Bond shall be made only to, or upon the written order of, the registered owner thereof or his legal representative (except as is provided above for the payment of interest to the registered owner thereof as of the Regular Record Date or a Special Record Date). The registration of any Bond may be changed upon the transfer of such Bond in the manner and subject to the conditions and limitations that are specified herein. All of the payments that are made in the manner that is specified herein shall be valid and effectual to discharge the liability of the City upon the respective Bonds in connection with which such payments are made, to the extent of the sum or sums that are so paid. Each Bond shall be fully transferable by the registered owner thereof in person or by his duly authorized attorney in the registration records that are kept by the Registrar upon the presentation of such Bond, together with a duly executed written instrument of transfer that is satisfactory to the Registrar. The Registrar shall require the owner or transferee to pay any tax or other governmental charge that is

required to be paid with respect to such transfer and a charge that is sufficient to reimburse the Registrar for the cost of preparing and authenticating a new Bond. The Registrar shall not be required to transfer any Bond during the period of fifteen (15) days that next precedes any date on which any of the Bonds are being selected for call for prior redemption or to transfer any Bond after the mailing of the notice that calls such Bond, or any portion thereof, for redemption. No exchange charge shall be levied in the case of an exchange that results from an optional redemption of a part of a Bond.

Section 8. That the Bonds and the interest thereon shall be payable from the Bond Fund, which will contain the receipts upon the collection thereof from the special assessments that were levied against, and secured by a lien upon, the assessable lots and parcels of property within the several Districts.

Whenever there is a deficiency in the Bond Fund, the deficiency must first be paid out of the Surplus and Deficiency Fund (to the extent of the monies that are available therein) before any payment is made out of the general fund of the City. In the event that the Bond Fund is insufficient to pay the Bonds, both principal and interest, as they become due, and the monies, if any, that are then contained in the Surplus and Deficiency Fund are not sufficient for that purpose, such deficiency must be paid out of the general fund of the City (the "General Fund" herein).

In the event that deficiencies are paid out of the General Fund, all of the net proceeds from the collection of the delinquent assessments with respect to which such payments from the General Fund were made shall be returned to and deposited in the General Fund when the Bonds, both principal and interest, have been fully paid and

discharged. If the General Fund is insufficient to pay any such deficiency promptly, the City Council shall levy, and it shall be its duty to levy, a general (ad valorem) tax upon all of the property within the City that is by law taxable for state, county and municipal purposes, that is fully sufficient, after making a due allowance for probable delinquencies, to provide for the prompt payment of the Bonds, both principal and interest, as they become due, but subject to the limitation that is imposed by NRS 361.453 and by Section 2 of Article 10 of the Constitution of the State. The Bonds, and the interest thereon, are payable solely from the assessments, the monies, if any, that are then contained in the Surplus and Deficiency Fund, the General Fund and the proceeds of such general tax that are pledged to the payment thereof.

Section 9. That, pursuant to NRS 271.515, the Mayor, the City Clerk and the City Treasurer, other than any of them who may have heretofore done so, shall each file with the Secretary of State his or her manual signature, certified to be such under oath. Thereafter, each of the Bonds shall be signed and executed in the name of the City with an engraved, imprinted, stamped or otherwise reproduced facsimile of the signatures of the Mayor and the City Treasurer, shall be attested with a facsimile of the signature of the City Clerk, shall be authenticated by the manual signature of the Registrar, in the manner that is hereinafter specified, and shall bear an engraved, imprinted, stamped or otherwise reproduced facsimile of the seal of the City affixed thereto. The Bonds that bear the signatures of the officers of the City who are in office at the time of the signing thereof shall be the valid and binding obligations of the City (subject to the requirement of authentication by the Registrar in the manner that is hereinafter specified), notwithstanding

the fact that, before the delivery thereof and the payment therefor, any or all of the persons whose signatures appear thereon shall have ceased to fill their respective offices. Any officer who is authorized or permitted herein to sign any Bond at the time of its execution and at the time of the execution of the signature certificate with respect to the Bonds may adopt, as and for his or her own facsimile signature, the facsimile signature of his or her predecessor in office in the event that such facsimile signature appears upon such Bond. No Bond shall be valid or obligatory for any purpose unless the certificate of authentication, substantially in the form that is hereinafter specified, has been duly executed by the City Treasurer, as the Registrar, and such certificate of authentication of the Registrar upon any Bond shall be the only competent evidence that such Bond has been duly issued and delivered. The Registrar's certificate of authentication shall be deemed to have been duly executed by the Registrar if it is manually signed by him. If any Bond is lost, stolen, destroyed or mutilated, the Registrar shall, upon his receipt of such evidence or information that relates thereto, such indemnification and such reimbursement for expenses as he may reasonably require, register and deliver to the registered owner thereof a replacement for such Bond that bears the same number as the Bond that is being so replaced. If such lost, stolen, destroyed or mutilated Bond shall have matured, the Registrar may direct the Paying Agent to pay such Bond in lieu of such replacement.

Section 10. That, except as is otherwise provided in Section 12 of this Ordinance, the books and records for the registration and transfer of the Bonds shall be kept by the City Treasurer, who is hereby appointed by the City Council as the Registrar (i.e., the transfer agent) for the Bonds. Each Bond shall be fully transferable by the

registered owner thereof in person or by his duly authorized attorney in the registration records that are kept by the Registrar upon the presentation of such Bond, together with a duly executed written instrument of transfer that is satisfactory to the Registrar. Except as is otherwise provided in said Section 12, upon the surrender for transfer of any Bond to the Registrar, duly endorsed for transfer by the registered owner thereof or by his attorney who has been duly authorized in writing by such registered owner to endorse the same or accompanied by an assignment (in a form that is satisfactory to the Registrar) that has been duly executed by such registered owner or by his attorney who has been duly authorized in writing by such registered owner to execute the same, the Registrar shall authenticate and deliver, in the name of the transferee or transferees, a new Bond or Bonds of a like aggregate principal amount and of the same maturity, bearing a number or numbers that are not contemporaneously outstanding. Bonds may be exchanged by the Registrar for Bonds of other authorized denominations that have, in the aggregate, an equal principal amount and have the same maturity. The Registrar may require the owner or transferee of such new Bond or Bonds to pay any tax or other governmental charge that is required to be paid with respect to such transfer and may charge a sum that is sufficient to pay the cost of preparing and authenticating such new Bond or Bonds. No such charge may be levied in the case of an exchange that results from an optional redemption. The Registrar shall not be required to transfer or exchange (i) any Bond that is subject to redemption during a period that begins at the opening of business fifteen (15) days before the date of the mailing by the Registrar of a notice of the prior redemption of Bonds and ends at the close of business on the date of such mailing or (ii) any Bond after

the mailing of the notice that calls such Bond, or any portion thereof, for redemption, in the manner that is specified herein. Whenever any Bond shall be surrendered to the Paying Agent upon the payment thereof, or to the Registrar for its replacement, in the manner that is specified herein, such Bond shall be promptly canceled and destroyed by the Paying Agent or the Registrar, as the case may be, and a certificate of such destruction shall be prepared by the Paying Agent or the Registrar, as is appropriate.

Section 11. That, subject to the registration provisions hereof, the Bonds shall be fully negotiable and shall have all of the qualities of negotiable paper, and the owner or owners thereof shall possess all of the rights that are enjoyed by the holders of negotiable instruments under the provisions of the Uniform Commercial Code-Investment Securities.

Section 12. A. That, notwithstanding the foregoing provisions of Sections 5 to 11, inclusive, of this Ordinance, the Bonds shall initially be evidenced by one Bond for each maturity in which the Bonds mature in denominations that are equal to the aggregate principal amount of the Bonds that mature for that maturity. The Bonds, as they are initially delivered, shall be registered in the name of Cede & Co., as the nominee of the DTC. The Bonds may not thereafter be transferred or exchanged except:

(1) To a successor of the DTC or its nominee, which successor must be both a "clearing corporation", as that term is defined in NRS 104.8102(3), and a qualified and registered "clearing agency" under Section 17A of the Securities Exchange Act of 1934, as amended;

(2) Upon the resignation of the DTC or a successor or a new depository pursuant to paragraph (1) or this paragraph (2), respectively, of this Subsection A, or a determination by the City Council to the effect that the DTC or such successor or new depository is no longer able to carry out its functions, and the designation by the City Council of another depository institution, to such other depository institution in accordance with Subsection (B) of this Section 12; provided, however, that such new depository institution must be both a "clearing corporation", as that item is defined in NRS 104.8102(3), and a qualified and registered "clearing agency" under Section 17A of the Securities Exchange Act of 1934, as amended, to carry out the functions of the DTC or such successor or new depository and must be acceptable to both the City Council and the depository that is then holding the Bonds; or

(3) Upon the resignation of the DTC or a successor or a new depository under paragraph (1) or paragraph (2), respectively, of this Subsection A, or a determination by the City Council to the effect that the DTC or such successor or new depository is no longer able to carry out its functions, and the failure by the City Council, after a reasonable investigation, to locate another qualified depository institution for the Bonds under said paragraph (2) to carry out such depository functions, to such persons, in accordance with Subsection (B) of this Section 12, as are identified in written transfer instructions that are satisfactory to the Registrar.

B. That, in the case of a transfer to a successor to the DTC or its nominee pursuant to paragraph (1) of Subsection A of this Section 12 or a designation of a new depository pursuant to paragraph (2) of said Subsection A, and upon the receipt

by the Registrar of the outstanding Bonds, together with written instructions for such transfer that are satisfactory to the Registrar, a new Bond for each maturity of the Bonds that are then outstanding shall be issued to such successor or new depository, as the case may be, or its nominee, as is specified in such written transfer instructions. In the case of a resignation or a determination pursuant to paragraph (3) of said Subsection A and the failure by the City Council, after a reasonable investigation, to locate another qualified depository institution for the Bonds, as is provided in said paragraph (3), and upon the receipt by the Registrar of the outstanding Bonds, together with written instructions for such transfer that are satisfactory to the Registrar, new Bonds shall be issued in the denomination of \$5,000, or any integral multiple thereof, in the manner that is specified in, and subject to the limitations that are imposed by, Section 5 of this Ordinance, registered in the names of such persons, and in such denominations, as are set forth in such written transfer instructions; provided, however, that the Registrar shall not be required to deliver such new Bonds within a period of less than sixty (60) days after the date of his receipt of such written transfer instructions.

C. That the City Council, the Registrar and the Paying Agent, and each of them, shall be entitled to treat the registered owner of any Bond as the absolute owner thereof for all of the purposes hereof and any applicable law, notwithstanding any notice to the contrary that has been received by any or all of them, and neither the City Council nor the Registrar nor the Paying Agent shall have any responsibility for transmitting the payments on the Bonds to the beneficial owners of the

Bonds that are held by the DTC or by any successor or new depository that is named pursuant to said Subsection A.

D. That the City Council, the Registrar and the Paying Agent shall endeavor to cooperate with the DTC, or with any successor or new depository that is named pursuant to paragraph (1) or paragraph (2), respectively, of said Subsection A, in effectuating the requirements of the Bonds by arranging for the payment of the Bonds in such a manner that the funds that represent such payments are available to the depository on the dates on which the same are due.

E. That, upon any partial redemption of any maturity of the Bonds, Cede & Co. (or its successor), in its discretion, may request the City to issue and authenticate a new Bond or shall make an appropriate notation on the Bond that indicates the date and the amount of such prepayment; provided, however, that, in the case of a final maturity, the Bond must be presented to the Paying Agent prior to any payment.

Section 13. That, pursuant to NRS 271.505, the Bonds shall contain a recital that they are issued pursuant to NRS Chapter 271, which recital shall conclusively impart full compliance with all of the provisions of said Chapter, and all of the Bonds that contain such recital shall be incontestable for any cause whatsoever after their delivery for value.

Section 14. That, subject to the provisions of this Ordinance, the Bonds, and the certificates thereon, shall be, substantially, in the following form, with such omissions, insertions, endorsements and variations as may be required by the circumstances, may be required or permitted by this Ordinance or may be consistent with

this Ordinance and are necessary or appropriate in order to conform to the rules and requirements of any governmental authority or any usage or requirement of law with respect thereto:

Fund" (sometimes referred to herein simply as the "Bond Fund") that contains the receipts, upon the collection thereof, from the special assessments that have been levied against, and secured by a lien upon, the assessable lots and parcels of the property that have been specially benefited by certain public improvements that have been constructed and installed in "City of Las Vegas, Nevada, Special Improvement District No. 1405 (Rampart Boulevard)", "City of Las Vegas, Nevada, Special Improvement District No. 1407 (Buffalo Drive)", "City of Las Vegas, Nevada, Special Improvement District No. 1413 (Alpine/Trent Area)" and "City of Las Vegas, Nevada, Special Improvement District No. 1414 (Lake Mead Boulevard)" (sometimes herein referred to collectively as the "Districts") and remain unpaid from and after the 24th day of August, 1995, which Bond Fund is, and shall continue to constitute, a sinking fund for, and the same shall be deemed to be specially appropriated to, the full and prompt payment of such bonds, and the interest thereon, and shall be used for no other purpose whatsoever; provided, however, that in the event that the Bond Fund is insufficient to pay such bonds, and the interest thereon, as the same become due, and the monies, if any, that are then contained in the City's special surplus and deficiency fund are not sufficient for that purpose, the deficiency shall be paid out of the City's general fund. Section 15. That, when the Bonds have been duly executed and authenticated, they will be delivered to the Purchaser upon the City's receipt of the purchase price that has been agreed upon. The printing, distribution and execution of a final official statement for the Bonds, as supplemented (the "Official Statement" herein), that is substantially in the form that is now before the City Council, with such amendments, additions and deletions as are in accordance with the facts, are not inconsistent herewith

and are approved by the execution of the Official Statement by the officials that are designated therein; and

C. The execution of such certificates as may be reasonably required by the Purchaser, relating, inter alia, to the signing and registration of the Bonds, the tenure and identity of the officials of the City Council and of the City, the delivery of the Bonds, the designation of the City Treasurer as the Paying Agent and the Registrar for the Bonds, the receipt of the purchase price for the Bonds, the exemption of the interest on the Bonds from federal and state income taxation, and, if it is in accordance with the facts, the absence of litigation, pending or threatened, that may affect the validity of the Bonds. It shall be the duty of the proper officers of the City hereafter to take all action that may be necessary in order for the City to comply with the provisions of NRS Chapter 271, as the same may hereafter be amended and supplemented from time to time.

Section 18. That any owner of any one or more of the Bonds may, either at law or in equity, by suit, action, mandamus or other appropriate proceeding in any court of competent jurisdiction, protect the liens that are created by this Ordinance on the proceeds from the collection of such special assessments and may, by suit, action, mandamus or other appropriate proceeding, enforce and compel the performance of any duty that is imposed upon the City by the provisions of this Ordinance or of any ordinance that has heretofore been adopted that relates to the District, including without limitation the segregation of the special assessments, the proper application thereof and the appointment of a receiver. The failure of the owner of any Bond to proceed as aforesaid shall not

relieve the City or any of its officers, employees or agents of any liability for its or his failure to perform any such duty.

Section 19. That the City hereby covenants, for the benefit of the registered owners of the Bonds, that it will not take any action or omit to take any action with respect to the Bonds, the proceeds thereof, any other funds of the City or any facility of the City, the acquisition of which is financed with the proceeds of the Bonds, if such action or omission (i) would cause the interest on the Bonds to lose its exclusion, for federal income tax purposes under Section 103 of the Internal Revenue Code of 1986, as amended (the "Tax Code" herein), from the gross income of the receipts thereof or (ii) would cause the interest on the Bonds to lose its exclusion from the alternative minimum taxable income, as that term is defined in Section 55(b)(2) of the Tax Code, of such recipients, except to the extent that such interest is required to be included in the adjusted current earnings adjustment that is applicable to corporations under Section 56 of the Tax Code in calculating the alternative minimum taxable income of such corporations. The foregoing covenant shall remain in full force and effect, notwithstanding the payment in full or the defeasance of the Bonds, until the date on which all of the obligations of the City in fulfilling such covenant under the Tax Code have been met.

Section 20. That, pursuant to NRS 271.520, the Bonds, their transfer and the income therefrom shall forever be and remain free and exempt from taxation by the State or any subdivision thereof, except for the tax on estates that is imposed by NRS Chapter 375A and the tax on generation-skipping transfers that is imposed by NRS Chapter 375B.

Section 21. A. This Section constitutes the written undertaking of the City, for the benefit of the owners of the Bonds (which, for the purposes of this Section only, include the beneficial owners of Bonds), which is required in order to allow the Purchaser of the Bonds to comply with Rule 15c2-12 that was promulgated by the Securities and Exchange Commission (the “SEC” herein) under the Securities Exchange Act of 1934, as amended, (17CFR Part 240 § 240.15c2-12) (the “Rule” herein).

B. For purposes of this Section the following definitions shall apply:

i. “Annual Financial Information” means the financial information and operating data with respect to the City of the type that are set forth under those captions in the Official Statement and are specified in the discussion under the caption “Continuing Disclosure Undertaking” in the Official Statement, which financial information and operating data are to be delivered at least annually to each Repository pursuant to subsection C hereof, including Audited Financial Statements, or, if Audited Financial Statements are not available, unaudited financial statements of the City that have been prepared in accordance with Generally Accepted Accounting Principles.

ii. “Audited Financial Statements” means the City’s annual financial statements that have been prepared in accordance with Generally Accepted Accounting Principles and audited by a firm of certified public accountants or the legislative auditor as is required by the laws of the State.

iii. “Event Information” means the information that is delivered pursuant to subsection E hereof.

iv. “NRMSIR” means each nationally recognized municipal securities information repository that is recognized by the SEC from time to time pursuant to the Rule. Such NRMSIRs currently include (1) Kenny Information Systems, 65 Broadway, New York, New York 10006-2503; (2) Thomson Municipal Services, Inc., 100 Business Park Drive, 395 Hudson Street, New York, New York 10014-3669; (3) Bloomberg Financial Markets, P.O. Box 888, Princeton, New Jersey 08542-0888; (4) Moody’s Investors Service, 99 Church Street, New York, New York 10007-2701; and (5) Disclosure, Inc., 5161 River Road, Bethesda, Maryland 20816-1584.

v. “Official Statement” means the Official Statement, dated as of its date of delivery to the Purchaser, that is delivered in connection with the original issue and sale of the Bonds.

vi. “Repository” means (i) each NRMSIR and (ii) any SID.

vii. “SID” means any State Information Depository that is operated or designated by the State of Nevada that receives information from all issuers within said State. As of the date of this undertaking, no SID exists for the State of Nevada.

viii. "MSRB" means the Municipal Securities Rulemaking Board.

The current address of the MSRB is 1640 King Street, #300, Alexandria, Virginia 22314.

C. Commencing with the Fiscal Year that ends June 30, 1996, the City agrees to provide or cause to be provided the Annual Financial Information to each Repository. Such Annual Financial Information and Audited Financial Statements for each Fiscal Year shall be provided to each Repository on or before March 31 of each calendar year.

D. The City may provide or cause to be provided Annual Financial Information and Audited Financial Information by specific reference to documents that were previously provided to each Repository or filed with the SEC; provided, however, that if the document that is so referenced is a final official statement within the meaning of the Rule, such final official statement must be available from the MSRB.

E. The City shall provide or cause to be provided, in a timely manner, to the MSRB and any SID, notice of any of the following events with respect to the Bonds, if such event is material:

- i. Principal and interest payment delinquencies;
- ii. Nonpayment related defaults;
- iii. Unscheduled draws on debt service reserves that reflect financial difficulties;
- iv. Unscheduled draws on credit enhancements, if any, that reflect financial difficulties;

- v. Substitution of credit or liquidity providers, if any, or their failure to perform;
- vi. Adverse tax opinions or events that affect the tax-exempt status of the Bonds;
- vii. Modifications to the rights of the owners of the Bonds;
- viii. Bond calls;
- ix. Defeasances;
- x. Release, substitution or sale of any property that secures the repayment of the Bonds; and
- xi. Rating changes.

F. The City shall provide or cause to be provided, in a timely manner to the MSRB and any SID, notice of any failure of the City to timely provide the Annual Financial Information and Audited Financial Statements as is specified in subsection C of this Section.

G. The obligation of the City hereunder shall be for the benefit of the owners of the Bonds. Unless they are otherwise required by law, no owner of the Bonds shall be entitled to damages that result from the City's noncompliance with its undertaking that is set forth in this Section; provided; however, the owners of the Bonds may take action to require the performance of such obligation by any judicial proceeding that may be available. A breach of the undertakings of the City hereunder shall not constitute an event of default, and the rights and remedies that are provided in Section 18 hereof are not applicable to the breach of the obligations of the City hereunder.

H. The undertakings that are contained in this Section shall be in effect from and after the issuance and delivery of the Bonds and shall extend to the earlier of (i) the date on which all of the principal of and interest on the Bonds shall have been deemed to have been paid pursuant to the terms of this Ordinance; (ii) the date on which the City shall no longer constitute an “obligated person” within the meaning of the Rule; or (iii) the date on which those portions of the Rule that require this written undertaking are held to be invalid by a court of competent jurisdiction in a non-appealable action, have been repealed retroactively or otherwise do not apply to the Bonds.

I. This Section may be amended from time to time by an ordinance of the City without the consent of the owners of the Bonds or the registered owners of the Bonds if such amendment would not, in and of itself, cause the undertakings herein (or any action that has been taken by the Purchaser in reliance on the undertakings herein) to violate the Rule or any official interpretive guidance that is related to the Rule. The City shall provide notice of such amendment to each Repository with its Annual Financial Information.

Section 22. That the City Council does hereby find and declare that no special assessment that was levied by any of the Assessment Ordinances exceeds the reasonable market value of the lot or parcel of property upon which such special assessment was so levied.

Section 23. That the City Council does hereby find and declare that the life of the improvements of which any of the Projects consists will be not less than the ten (10) year period during which the Bonds mature.

Section 24. That, if the City Council shall, at any time, desire that an institution or some officer of the City other than the City Treasurer act as the Registrar or the Paying Agent, or both, for the Bonds, the City Council may, upon causing the mailing of a notice to each owner of each Bond, at his address that is last shown in the registration books, appoint a successor Registrar or a successor Paying Agent, or both. No change in the Registrar or the Paying Agent, or both, may take effect until a successor Registrar or a successor Paying Agent, as the case may be, is appointed. It is not required that the same institution or officer of the City serve as both the Registrar and the Paying Agent hereunder, but the City shall have the right to have the same institution or the same officer of the City serve as both the Registrar and the Paying Agent hereunder.

Section 25. When all of the principal of, interest on and prior redemption premiums that are due in connection with any of the Bonds have been duly paid, the pledge, the lien and all of the obligations hereunder shall thereby be discharged as to that Bond and the Bond shall no longer be deemed to be outstanding within the meaning of this Ordinance. There shall be deemed to be such due payment when the City has placed in escrow or in trust with a trust bank that is located within or without the State of Nevada an amount that is sufficient (including the known minimum yield that is available for such purpose from bills, certificates of indebtedness, notes, bonds or similar securities which are direct obligations of, or the principal of and interest on which are unconditionally guaranteed by, the United States ("Federal Securities" herein) in which such amount may be initially invested wholly or in part) to meet all bond requirements of the Bond, as the same become due. The Federal Securities shall become due before the

respective times on which the proceeds thereof shall be needed in accordance with a schedule that is established and agreed upon between the City and the bank at the time of the creation of the escrow or trust, or the Federal Securities shall be subject to redemption at the option of the holders thereof to assure the availability of such proceeds as may be needed to meet that schedule. For the purpose of this section "Federal Securities" shall include only Federal Securities that are not callable for redemption prior to their maturities except at the option of the owner thereof.

Section 26. That, after this Ordinance is signed by the Mayor and attested and sealed by the City Clerk, this Ordinance shall be published by its title only, together with the names of the members of the City Council who voted either for or against its passage, such publication to be made in the Las Vegas Review-Journal, a newspaper that is published and has a general circulation within the City, at least once, pursuant to Section 2.110 of said City Charter, such publication to be, substantially, in the following form:

Section 27. That all of the actions, proceedings, matters and things that have heretofore been taken, had and done by the City and the officers thereof (not inconsistent with the provisions of this Ordinance) concerning the Districts, including without limitation the construction and installation of the Project in each District, the performance of all of the prerequisites to the levying of the special assessments for the purpose of defraying, in part, the cost and expense of such Projects and to the fixing of the assessment lien upon each assessable lot or parcel of property within each of the Districts that is benefited by the Project therein and including without limitation the passage and adoption of the corresponding Assessment Ordinance, the issuance of the Bonds in the aggregate principal amount of \$2,249,000.00, the sale thereof to the Purchaser and the distribution of the Official Statement in connection therewith be, and the same hereby are, in all respects approved, ratified and confirmed.

Section 28. That this Ordinance may be amended or supplemented by an ordinance or ordinances that is or are adopted by the City Council, without the receipt by the City of any additional consideration, with the written consent of the owners of seventy-five percent (75%) of the Bonds that are outstanding at the time of the adoption of each such amendatory or supplemental ordinance; provided, however, that no such ordinance shall have the effect of permitting:

- A. An extension of the maturity of any Bond;
- B. A reduction in the principal amount of any Bond or the rate of interest thereon;

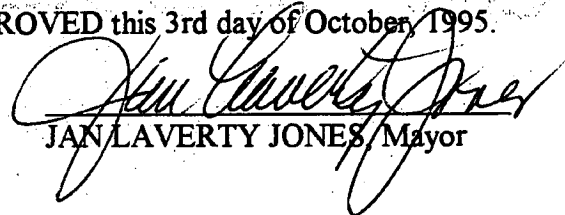

WHEREAS, the City Council of the City of Las Vegas (the "City Council" and the "City", respectively, herein) in the County of Clark and State of Nevada (the "State" herein), has taken all of the requisite legal action that is preliminary to and in the creation of those certain special improvement districts that have been designated and identified as "City of Las Vegas, Nevada, Special Improvement District No 1405 (Rampart Boulevard)", "City of Las Vegas, Nevada, Special Improvement District No. 1407 (Buffalo Drive)", "City of Las Vegas, Nevada, Special Improvement District No. 1413 (Alpine/Trent Area)" and "City of Las Vegas, Nevada, Special Improvement District No. 1414 (Lake Mead Boulevard)" (said Districts being referred to herein individually as

"Improvement District No. 1405", "Improvement District No. 1407", "Improvement District No. 1413" and "Improvement District No. 1414", respectively, or generically as a "District" and sometimes collectively as the "Districts") for the purposes of providing for the construction and installation therein of certain local improvements and of defraying the entire cost and expense thereof by special assessments against the assessable lots and parcels of property within each assessment unit of the respective Districts according to the benefits that were anticipated would be derived from such improvements by the respective lots and parcels that were proposed to be so assessed, all in accordance with the provisions of the Nevada Revised Statutes ("NRS" herein) that provide therefor; and

assessments, according to the benefits as aforesaid, against the respective assessable lots and parcels of property that would be benefited thereby; and

WHEREAS, the City Council, pursuant to Ordinance No. 3743 that was duly passed, adopted and approved on the 20th day of October, 1993, created Improvement District No. 1413, ordered the construction and installation therein of the proposed local improvements (the "District 1413 Project" herein) and determined to defray a portion of the entire cost and expense of the District 1413 Project by special assessments, according to the benefits as aforesaid, against the respective assessable lots and parcels of property that would be benefited thereby; and

WHEREAS, the City Council, pursuant to Ordinance No. 3716 that was duly passed, adopted and approved on the 16th day of June, 1993, created Improvement District No. 1414, ordered the construction and installation therein of the proposed local improvements (the "District 1414 Project" herein) and determined to defray a portion of the entire cost and expense of the District 1414 Project by special assessments, according to the benefits as aforesaid, against the respective assessable lots and parcels of property that would be benefited thereby; and

WHEREAS, the City Council, pursuant to Ordinance No. 3902 that was duly passed, adopted and approved on the 5th day of July, 1995 (the "District 1405 Assessment Ordinance" herein), levied assessments in the aggregate amount of \$926,864.00 against the assessable lots and parcels of property that have been benefited by the District 1405 Project, and, at the close of the 30-day cash payment period on the

24th day of August, 1995, there remained unpaid valid assessments against such lots and parcels in the aggregate amount of not less than \$926,864,000.00; and

WHEREAS, the City Council, pursuant to Ordinance No. 3911 that was duly passed, adopted and approved on the 19th day of July, 1995 (the "District 1407 Assessment Ordinance" herein), levied assessments in the aggregate amount of \$955,263.00 against the assessable lots and parcels of property that have been benefited by the District 1407 Project, and, at the close of the 30-day cash payment period on the 24th day of August, 1995, there remained unpaid valid assessments against such lots and parcels in the aggregate amount of not less than \$849,997.49; and

WHEREAS, the City Council, pursuant to Ordinance No. 3912 that was duly passed, adopted and approved on the 19th day of July, 1995 (the "District 1413 Assessment Ordinance" herein), levied assessments in the aggregate amount of \$324,821.00 against the assessable lots and parcels of property that have been benefited by the District 1413 Project, and, at the close of the 30-day cash payment period on the 24th day of August, 1995, there remained unpaid valid assessments against such lots and parcels in the aggregate amount of not less than \$262,001.46; and

WHEREAS, the City Council, pursuant to Ordinance No. 3903 that was duly passed, adopted and approved on the 5th day of July, 1995 (the "District 1414 Assessment Ordinance" herein), levied assessments in the aggregate amount of \$456,582.00 against the assessable lots and parcels of property that have been benefited by the District 1414 Project, and, at the close of the 30-day cash payment period on the

24th day of August, 1995, there remained unpaid valid assessments against such lots and parcels in the aggregate amount of not less than \$212,402.05; and

WHEREAS, the unpaid valid assessments in each District are payable in twenty (20) substantially equal semiannual installments of principal, with interest in all cases on the unpaid and deferred installments from the effective date of the respective Assessment Ordinances, i.e., the 25th day of July, 1995, at a rate per annum that may not exceed by more than one percent (1%) the highest rate of interest that is borne by the bonds that are hereinafter authorized to be sold (the effective interest rate on which may not exceed by more than three percent (3%) the "Index of Twenty Bonds" that was most recently published in The Bond Buyer before the date on which the bids for the purchase of such bonds were received), both principal and interest being payable semiannually at the Office of the City Treasurer of the City (the "City Treasurer" herein) on the 25th days of January and July in each year, commencing on the 25th day of January, 1996; and

WHEREAS, the City Council has determined, and by this Ordinance does so determine, that it is necessary and in the best interests of the City, each of the Districts and the inhabitants thereof that the City issue in a single issue, pursuant to NRS 271.485, as the same was amended in Section 2 of Chapter 16, Statutes of Nevada 1995, its City of Las Vegas, Nevada, Special Improvement District Nos. 1405 (Rampart Boulevard), 1407 (Lake Mead Drive), 1413 (Alpine/Trent Area) and 1414 (Lake Mead Boulevard) Special Assessment, Local Improvement Bonds, Series October 1, 1995 (the "Bonds" herein), in the aggregate principal amount of \$2,249,000.00, which is an amount that does not exceed the aggregate amount of the assessments that were levied upon the lots and parcels

of property within the combined Districts that remained payable in installments at the close of such 30-day cash payment period, nor does the portion of the principal amount of the Bonds that is attributable to any one District exceed the total uncollected assessments that were levied in that District; and

WHEREAS, the City Council has elected, and by this Ordinance does so elect, to have NRS Chapter 348 apply to the Bonds; and

WHEREAS, the City received sealed bids for the purchase of the Bonds and publicly opened the same in Las Vegas, Nevada, on Wednesday, the 6th day of September, 1995; and

WHEREAS, the City Council has determined, and by this Ordinance does so determine, that the bid that was submitted by \_\_\_\_\_, of \_\_\_\_\_, \_\_\_\_\_ (the "Purchaser" herein), for the principal amount thereof,\* a premium of \$\_\_\_\_\_,\* \*\*less a discount of \$\_\_\_\_\_,\*\* and the interest that will accrue thereon from the date of the Bonds to the date of the delivery of the Bonds at the interest rate or rates that are herein designated, is the best responsible bid for the purchase of the Bonds, which proposal is hereby formally accepted; and

WHEREAS, the City Council has heretofore, pursuant to that certain Resolution that was duly passed, adopted and approved on the 3rd day of June 1992, established the City of Las Vegas Special Improvement District Surplus and Deficiency Fund (the "Surplus and Deficiency Fund" herein) in accordance with NRS 271.428.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

Section 1. That this Ordinance shall be known, and may be cited by the short title, as the "Improvement District Nos. 1405, 1407, 1413 and 1414 Bond Ordinance".

Section 2. That it shall be the duty of the City to receive, collect and enforce the payment of each of the assessments in the several Districts that has been made and levied for the purpose of defraying, in part, the cost and expense of the District 1405 Project, the District 1407 Project, the District 1413 Project and the District 1414 Project (individually a "Project" and collectively the "Projects" herein), each of the installments of such assessments, all of the interest thereon (at a rate that is to be hereafter determined) and all of the penalties, if any, that have accrued thereon, all as is provided by law and in the manner and at the time or times that are specified in the respective Assessment Ordinances and in this Ordinance, and to pay and disburse such assessments, including the installments thereof, the interest thereon and the penalties, if any, in connection therewith to any person who is lawfully entitled to receive the same.

Section 3. That the City Treasurer be, and he hereby is, designated by the City Council to implement the provisions of Section 2 of this Ordinance, and, in so doing, he shall be, and hereby is, authorized, empowered and directed to receive, collect and enforce, and it shall be his duty to receive, collect and enforce, the payment of each of the assessments that have been made and levied for the purpose of defraying, in part, the cost and expense of the Projects, each of the installments of such assessments, all of the interest thereon (at a rate that is to be hereafter determined), and all of the penalties, if any, that have accrued thereon, all as is provided by law and in the manner and at the time

or times that are specified in the respective Assessment Ordinances and in this Ordinance, and to pay and disburse such assessments, including the installments thereof, the interest thereon and the penalties, if any, in connection therewith to any person who is lawfully entitled to receive the same, all in accordance with the ordinances and resolutions of the City that have heretofore been, or are hereafter to be, adopted. All of the monies that are received from such assessments from and after the 24th day of August, 1995, the 30th day following the effective date of each of the Assessment Ordinances, both principal and interest, shall be placed in a separate fund that is to be designated as the "City of Las Vegas, Nevada, Special Improvement District Nos. 1405, 1407, 1413 and 1414 Bond Fund" (the "Bond Fund" herein) and shall be used, as soon as the funds are available for such purpose, to pay the principal of, the interest on and any prior redemption premium that is due in connection, with the Bonds, and for no other purpose whatsoever, and, as security for such payment, the Bond Fund is hereby exclusively pledged to such payment, except as is herein otherwise specifically provided. The City Treasurer shall be, and he hereby is, also authorized, empowered and directed to receive and collect, and it shall be his further duty to receive and collect, the surplus monies, if any, that are attributable to any of the Districts pursuant to NRS 271.428, to place all of such surplus monies in the Surplus and Deficiency Fund and to hold on deposit and disburse the same in any manner that is authorized by NRS 271.428, including without limitation for the payment of the principal of, and the interest on, the Bonds, to the extent that is necessary, if any payment from the Surplus and Deficiency Fund is necessary.

Section 4. That, if the owner of any lot or parcel of property that is assessed for any of the Projects shall be delinquent in the payment of either the principal of any installment of the assessment that has been levied upon such lot or parcel or the interest on such installment, or both, it shall be the duty of the City Council forthwith to cause the Purchaser and the owner of the lot or parcel with respect to which such delinquency exists to be notified in writing of such delinquency, and, if such delinquency shall not be paid within ten (10) days after such notice has been given, the City Council shall forthwith cause the City Treasurer and the other officers of the City to foreclose the special assessment lien upon the lot or parcel with respect to which such delinquency exists by any method that is now or may hereafter be provided by law. If such foreclosure is not filed and prosecuted within a reasonable time, the owner of any of the Bonds may file and prosecute a foreclosure action in the name of the City and may also proceed against the City in the manner that is specified in each Assessment Ordinance. All of the net proceeds from collecting any delinquent assessment shall be deposited in the Bond Fund (or, to the extent that is specified in Section 8 of this Ordinance, deposited in the general fund of the City) and, in any event, in an amount that is not less than the principal amount of such assessment and the interest that had accrued thereon to the date of such collection.

Section 5. That, for the purpose of defraying the entire cost and expense of the Projects (except to the extent that funds are available for such purpose from that part of such assessments that have heretofore been paid and except to the extent that other funds are available for such purpose), there shall be issued in the name of the City, the

City's fully registered (i.e., registered as to the payment of both the principal and the interest thereon) special assessment bonds that are designated as the "City of Las Vegas, Nevada, Special Improvement District Nos. 1405 (Rampart Boulevard), 1407 (Buffalo Drive), 1413 (Alpine/Trent Area) and 1414 (Lake Mead Boulevard) Special Assessment, Local Improvement Bonds, Series October 1, 1995", in the aggregate principal amount of \$2,249,000.00, which Bonds shall be dated as of the 1st day of October, 1995, and, except as is provided in Section 12 of this Ordinance, shall be in the denomination of \$5,000 each (except for the one Bond that has the October 1, 1996, maturity date, which will be in the denomination of \$1,000.00, or any integral multiple thereof that does not exceed \$5,000.00), and such Bonds may be in any denomination that is an integral multiple of \$5,000; provided, however, that no Bond may be in a denomination that exceeds the principal that becomes due on any maturity date, and no Bond may be issued for more than one maturity. The Bonds shall bear interest, at the rates per annum that are hereinafter designated, from the most recent interest payment date to which such interest has been paid or duly provided for, or, if no interest has been paid, from the date of the Bonds, to their respective maturities, payable on the 1st day of April, 1996, and semiannually thereafter on the 1st days of October and April in each year. The Bonds shall mature serially on the 1st day of October in each of the amounts and years that are designated as follows:

The Bonds shall be payable in lawful money of the United States of America without deduction for exchange or collection charges at the Office of the City Treasurer in the Las Vegas City Hall Complex, 400 East Stewart Avenue, Las Vegas, Nevada 89101. If, upon the presentation of any Bond, at or after its maturity, the payment thereof is not made as is herein provided, interest thereon shall continue at the same rate per annum until the principal thereof is paid in full. The principal of, the interest on and any prior redemption premium that may be due in connection with, any Bond shall be payable to the registered owner thereof as the same is identified in the registration records that are kept by the City Treasurer, being both the registrar (i.e., the transfer agent) (the "Registrar" herein) and the paying agent (the "Paying Agent" herein) for the Bonds, upon the maturity thereof and upon the presentation and surrender of such Bond to the Paying Agent. Except as is otherwise provided in Section 12 of this Ordinance, the payment of the interest on any Bond shall be made to the registered owner thereof by way of a check or draft that is mailed by the Paying Agent, on or before each interest payment date (or, if such interest payment date is not a business day, on or before the next succeeding business day), to the registered owner thereof, at such owner's address as it last appears in the registration books that are kept by the Registrar (or by such other arrangement as may be mutually agreed upon between the Paying Agent and any registered owner), on the fifteenth day of

the calendar month that precedes each interest payment date (the "Regular Record Date" herein) or on a special record date (the "Special Record Date" herein) if one is established by the Paying Agent for the payment of any defaulted interest on the Special Record Date. All such payments shall be made in lawful money of the United States of America.

Section 6. That each of the Bonds shall be subject to prior redemption from any monies that are legally available for that purpose, at the option of the City, from any maturity (in any order of maturity and by lot within a maturity), on any interest payment date that is prior to its maturity, at a price that is equal to the principal amount thereof, the interest that will have accrued thereon to the redemption date and a premium that is equal to three percent (3%) of the principal amount of the Bond that is so redeemed. The prior redemption premium shall be paid from the three percent (3%) prepayment premium with respect to the special assessments that is provided for in each Assessment Ordinance; provided, however, that nothing that is contained herein shall prevent the payment of any such redemption premium from any other funds that may be available for that purpose. If less than all of the Bonds, or less than all of the Bonds that have a single maturity, are being called, such Bonds will be selected by the Paying Agent by lot, giving proportionate weight to Bonds in denominations that are larger than \$5,000, all in such a manner as the Paying Agent may determine. Whenever it is considered to be advisable by the City Treasurer, and whenever funds are available for such purpose, he, as the Paying Agent, may call a suitable amount of the Bonds for payment. In the case of a Bond that has a denomination that is larger than \$5,000, a portion of such Bond (\$5,000 or any integral multiple thereof) may be redeemed, in which case the Registrar shall,

without charge to the owner of such Bond, authenticate and issue a replacement Bond or Bonds in an amount that is equal to the unredeemed portion thereof. Unless such notice is waived by the registered owner of a Bond that is to be redeemed, a notice of redemption shall be given by the Registrar, in the name of the City, by mailing such notice not less than thirty (30) days and not more than sixty (60) days prior to the redemption date, by registered or certified mail, to the registered owner (initially Cede & Co., as the nominee of The Depository Trust Company (the "DTC" herein), the securities depository for the Bonds) of each Bond that is to be redeemed and to the Purchaser. The failure to give such notice to the registered owner of any Bond, or any defect in such notice, shall not affect the validity of the proceedings for the redemption of any other Bond. All such notices shall be dated and shall state: (1) the redemption date, (2) the redemption price, (3) if less than all of the outstanding Bonds are to be redeemed, the identification (and, in the case of a partial redemption, the respective principal amounts) of the Bonds that are to be redeemed, (4) that on the redemption date the redemption price will become due and payable upon each Bond, or portion thereof, that is called for redemption and that the interest thereon shall cease to accrue from and after such date and (5) the place at which such Bonds are to be surrendered in exchange for the payment of the redemption price, which place of payment shall be the office of the Paying Agent. After such notice has been given in the manner that is hereinabove provided, each of the Bonds that is called for redemption shall become due and payable on the designated redemption date, and, upon the presentation thereof, the City will pay the redemption price for each of the Bonds that is called for redemption. The installments of the interest that become due prior to and on

the redemption date shall be payable in the manner that is provided herein for the payment of interest. A certificate by the Registrar that a notice of redemption has been given in the manner that is set forth herein shall be conclusive, and the receipt by the owner of any Bond of a notice of redemption shall not be a condition precedent to the redemption of that Bond.

Section 7. That, except as is otherwise provided in Section 12 of this Ordinance, the person in whose name a Bond is registered in the registration books that are kept by the Registrar shall be deemed and regarded to be the absolute owner thereof for all purposes, and the payment of the principal of, the interest on and any prior redemption premium that may be due in connection with, any Bond shall be made only to, or upon the written order of, the registered owner thereof or his legal representative (except as is provided above for the payment of interest to the registered owner thereof as of the Regular Record Date or a Special Record Date). The registration of any Bond may be changed upon the transfer of such Bond in the manner and subject to the conditions and limitations that are specified herein. All of the payments that are made in the manner that is specified herein shall be valid and effectual to discharge the liability of the City upon the respective Bonds in connection with which such payments are made, to the extent of the sum or sums that are so paid. Each Bond shall be fully transferable by the registered owner thereof in person or by his duly authorized attorney in the registration records that are kept by the Registrar upon the presentation of such Bond, together with a duly executed written instrument of transfer that is satisfactory to the Registrar. The Registrar shall require the owner or transferee to pay any tax or other governmental charge that is

required to be paid with respect to such transfer and a charge that is sufficient to reimburse the Registrar for the cost of preparing and authenticating a new Bond. The Registrar shall not be required to transfer any Bond during the period of fifteen (15) days that next precedes any date on which any of the Bonds are being selected for call for prior redemption or to transfer any Bond after the mailing of the notice that calls such Bond, or any portion thereof, for redemption. No exchange charge shall be levied in the case of an exchange that results from an optional redemption of a part of a Bond.

Section 8. That the Bonds and the interest thereon shall be payable from the Bond Fund, which will contain the receipts upon the collection thereof from the special assessments that were levied against, and secured by a lien upon, the assessable lots and parcels of property within the several Districts.

Whenever there is a deficiency in the Bond Fund, the deficiency must first be paid out of the Surplus and Deficiency Fund (to the extent of the monies that are available therein) before any payment is made out of the general fund of the City. In the event that the Bond Fund is insufficient to pay the Bonds, both principal and interest, as they become due, and the monies, if any, that are then contained in the Surplus and Deficiency Fund are not sufficient for that purpose, such deficiency must be paid out of the general fund of the City (the "General Fund" herein).

In the event that deficiencies are paid out of the General Fund, all of the net proceeds from the collection of the delinquent assessments with respect to which such payments from the General Fund were made shall be returned to and deposited in the General Fund when the Bonds, both principal and interest, have been fully paid and

discharged. If the General Fund is insufficient to pay any such deficiency promptly, the City Council shall levy, and it shall be its duty to levy, a general (ad valorem) tax upon all of the property within the City that is by law taxable for state, county and municipal purposes, that is fully sufficient, after making a due allowance for probable delinquencies, to provide for the prompt payment of the Bonds, both principal and interest, as they become due, but subject to the limitation that is imposed by NRS 361.453 and by Section 2 of Article 10 of the Constitution of the State. The Bonds, and the interest thereon, are payable solely from the assessments, the monies, if any, that are then contained in the Surplus and Deficiency Fund, the General Fund and the proceeds of such general tax that are pledged to the payment thereof.

Section 9. That, pursuant to NRS 271.515, the Mayor, the City Clerk and the City Treasurer, other than any of them who may have heretofore done so, shall each file with the Secretary of State his or her manual signature, certified to be such under oath. Thereafter, each of the Bonds shall be signed and executed in the name of the City with an engraved, imprinted, stamped or otherwise reproduced facsimile of the signatures of the Mayor and the City Treasurer, shall be attested with a facsimile of the signature of the City Clerk, shall be authenticated by the manual signature of the Registrar, in the manner that is hereinafter specified, and shall bear an engraved, imprinted, stamped or otherwise reproduced facsimile of the seal of the City affixed thereto. The Bonds that bear the signatures of the officers of the City who are in office at the time of the signing thereof shall be the valid and binding obligations of the City (subject to the requirement of authentication by the Registrar in the manner that is hereinafter specified), notwithstanding

the fact that, before the delivery thereof and the payment therefor, any or all of the persons whose signatures appear thereon shall have ceased to fill their respective offices. Any officer who is authorized or permitted herein to sign any Bond at the time of its execution and at the time of the execution of the signature certificate with respect to the Bonds may adopt, as and for his or her own facsimile signature, the facsimile signature of his or her predecessor in office in the event that such facsimile signature appears upon such Bond. No Bond shall be valid or obligatory for any purpose unless the certificate of authentication, substantially in the form that is hereinafter specified, has been duly executed by the City Treasurer, as the Registrar, and such certificate of authentication of the Registrar upon any Bond shall be the only competent evidence that such Bond has been duly issued and delivered. The Registrar's certificate of authentication shall be deemed to have been duly executed by the Registrar if it is manually signed by him. If any Bond is lost, stolen, destroyed or mutilated, the Registrar shall, upon his receipt of such evidence or information that relates thereto, such indemnification and such reimbursement for expenses as he may reasonably require, register and deliver to the registered owner thereof a replacement for such Bond that bears the same number as the Bond that is being so replaced. If such lost, stolen, destroyed or mutilated Bond shall have matured, the Registrar may direct the Paying Agent to pay such Bond in lieu of such replacement.

Section 10. That, except as is otherwise provided in Section 12 of this Ordinance, the books and records for the registration and transfer of the Bonds shall be kept by the City Treasurer, who is hereby appointed by the City Council as the Registrar (i.e., the transfer agent) for the Bonds. Each Bond shall be fully transferable by the

registered owner thereof in person or by his duly authorized attorney in the registration records that are kept by the Registrar upon the presentation of such Bond, together with a duly executed written instrument of transfer that is satisfactory to the Registrar. Except as is otherwise provided in said Section 12, upon the surrender for transfer of any Bond to the Registrar, duly endorsed for transfer by the registered owner thereof or by his attorney who has been duly authorized in writing by such registered owner to endorse the same or accompanied by an assignment (in a form that is satisfactory to the Registrar) that has been duly executed by such registered owner or by his attorney who has been duly authorized in writing by such registered owner to execute the same, the Registrar shall authenticate and deliver, in the name of the transferee or transferees, a new Bond or Bonds of a like aggregate principal amount and of the same maturity, bearing a number or numbers that are not contemporaneously outstanding. Bonds may be exchanged by the Registrar for Bonds of other authorized denominations that have, in the aggregate, an equal principal amount and have the same maturity. The Registrar may require the owner or transferee of such new Bond or Bonds to pay any tax or other governmental charge that is required to be paid with respect to such transfer and may charge a sum that is sufficient to pay the cost of preparing and authenticating such new Bond or Bonds. No such charge may be levied in the case of an exchange that results from an optional redemption. The Registrar shall not be required to transfer or exchange (i) any Bond that is subject to redemption during a period that begins at the opening of business fifteen (15) days before the date of the mailing by the Registrar of a notice of the prior redemption of Bonds and ends at the close of business on the date of such mailing or (ii) any Bond after

the mailing of the notice that calls such Bond, or any portion thereof, for redemption, in the manner that is specified herein. Whenever any Bond shall be surrendered to the Paying Agent upon the payment thereof, or to the Registrar for its replacement, in the manner that is specified herein, such Bond shall be promptly canceled and destroyed by the Paying Agent or the Registrar, as the case may be, and a certificate of such destruction shall be prepared by the Paying Agent or the Registrar, as is appropriate.

Section 11. That, subject to the registration provisions hereof, the Bonds shall be fully negotiable and shall have all of the qualities of negotiable paper, and the owner or owners thereof shall possess all of the rights that are enjoyed by the holders of negotiable instruments under the provisions of the Uniform Commercial Code-Investment Securities.

Section 12. A. That, notwithstanding the foregoing provisions of Sections 5 to 11, inclusive, of this Ordinance, the Bonds shall initially be evidenced by one Bond for each maturity in which the Bonds mature in denominations that are equal to the aggregate principal amount of the Bonds that mature for that maturity. The Bonds, as they are initially delivered, shall be registered in the name of Cede & Co., as the nominee of the DTC. The Bonds may not thereafter be transferred or exchanged except:

(1) To a successor of the DTC or its nominee, which successor must be both a "clearing corporation", as that term is defined in NRS 104.8102(3), and a qualified and registered "clearing agency" under Section 17A of the Securities Exchange Act of 1934, as amended;

(2) Upon the resignation of the DTC or a successor or a new depository pursuant to paragraph (1) or this paragraph (2), respectively, of this Subsection A, or a determination by the City Council to the effect that the DTC or such successor or new depository is no longer able to carry out its functions, and the designation by the City Council of another depository institution, to such other depository institution in accordance with Subsection (B) of this Section 12; provided, however, that such new depository institution must be both a "clearing corporation", as that item is defined in NRS 104.8102(3), and a qualified and registered "clearing agency" under Section 17A of the Securities Exchange Act of 1934, as amended, to carry out the functions of the DTC or such successor or new depository and must be acceptable to both the City Council and the depository that is then holding the Bonds; or

(3) Upon the resignation of the DTC or a successor or a new depository under paragraph (1) or paragraph (2), respectively, of this Subsection A, or a determination by the City Council to the effect that the DTC or such successor or new depository is no longer able to carry out its functions, and the failure by the City Council, after a reasonable investigation, to locate another qualified depository institution for the Bonds under said paragraph (2) to carry out such depository functions, to such persons, in accordance with Subsection (B) of this Section 12, as are identified in written transfer instructions that are satisfactory to the Registrar.

B. That, in the case of a transfer to a successor to the DTC or its nominee pursuant to paragraph (1) of Subsection A of this Section 12 or a designation of a new depository pursuant to paragraph (2) of said Subsection A, and upon the receipt

by the Registrar of the outstanding Bonds, together with written instructions for such transfer that are satisfactory to the Registrar, a new Bond for each maturity of the Bonds that are then outstanding shall be issued to such successor or new depository, as the case may be, or its nominee, as is specified in such written transfer instructions. In the case of a resignation or a determination pursuant to paragraph (3) of said Subsection A and the failure by the City Council, after a reasonable investigation, to locate another qualified depository institution for the Bonds, as is provided in said paragraph (3), and upon the receipt by the Registrar of the outstanding Bonds, together with written instructions for such transfer that are satisfactory to the Registrar, new Bonds shall be issued in the denomination of \$5,000, or any integral multiple thereof, in the manner that is specified in, and subject to the limitations that are imposed by, Section 5 of this Ordinance, registered in the names of such persons, and in such denominations, as are set forth in such written transfer instructions; provided, however, that the Registrar shall not be required to deliver such new Bonds within a period of less than sixty (60) days after the date of his receipt of such written transfer instructions.

C. That the City Council, the Registrar and the Paying Agent, and each of them, shall be entitled to treat the registered owner of any Bond as the absolute owner thereof for all of the purposes hereof and any applicable law, notwithstanding any notice to the contrary that has been received by any or all of them, and neither the City Council nor the Registrar nor the Paying Agent shall have any responsibility for transmitting the payments on the Bonds to the beneficial owners of the

Bonds that are held by the DTC or by any successor or new depository that is named pursuant to said Subsection A.

D. That the City Council, the Registrar and the Paying Agent shall endeavor to cooperate with the DTC, or with any successor or new depository that is named pursuant to paragraph (1) or paragraph (2), respectively, of said Subsection A, in effectuating the requirements of the Bonds by arranging for the payment of the Bonds in such a manner that the funds that represent such payments are available to the depository on the dates on which the same are due.

E. That, upon any partial redemption of any maturity of the Bonds, Cede & Co. (or its successor), in its discretion, may request the City to issue and authenticate a new Bond or shall make an appropriate notation on the Bond that indicates the date and the amount of such prepayment; provided, however, that, in the case of a final maturity, the Bond must be presented to the Paying Agent prior to any payment.

Section 13. That, pursuant to NRS 271.505, the Bonds shall contain a recital that they are issued pursuant to NRS Chapter 271, which recital shall conclusively impart full compliance with all of the provisions of said Chapter, and all of the Bonds that contain such recital shall be incontestable for any cause whatsoever after their delivery for value.

Section 14. The City of Las Vegas (the "City" herein), in the County of Clark and State of Nevada (the "State" herein), for value received hereby promises, out of funds that are available for the purpose that is hereinafter set forth, to pay to the registered owner hereof who is identified above, or to his registered assigns, the principal amount that is specified above on the maturity date that is specified above, with interest hereon from the date of this bond, or from the most recent interest payment date to which such interest has been paid, until maturity at the percentage rate per annum that is specified above, such interest

Alternative means of payment of such interest may be used if such alternative means are mutually agreed upon between the owner of this bond and the Paying Agent, as is provided in the ordinance that authorized the issuance of this bond. If, upon the presentation and surrender to the Paying Agent of this bond at its maturity, the payment of this bond is not made in the manner that is specified herein, the interest hereon shall continue at the same rate per annum until the principal hereof is paid in full.

This bond is one of a series that is subject to prior redemption, from any monies that are legally available for that purpose, in any order of maturity that is selected by the City, at the option of the City, on any interest payment date at a price that is equal to the principal amount hereof, the interest that will accrue thereon to the redemption date and a premium of three percent (3%) of the principal amount hereof. If less than all of the bonds, or portions thereof, of a single maturity are being called for redemption, such bonds are to be selected by the Paying Agent by lot in the manner that is specified in the Improvement District Nos. 1405, 1407, 1413 and 1414 Bond Ordinance (i.e., the ordinance that authorized the issuance of this bond) that was duly adopted on the 3rd day of October, 1995. Such redemption shall be made upon not less than thirty (30) days' prior notice by mailing the same to the registered owner or owners of each bond that is to be redeemed at the address that is shown in the registration records in the manner and upon the conditions that are specified in the ordinance that authorized the issuance of this bond.

This bond is one of a series of special assessment bonds, issued by the City, all of which are of like date and designation (but not denomination) and aggregate the total amount of \$2,249,000.00.

Pursuant to the ordinance that authorized the issuance of this bond, reference to which is made for further details, the payment of the principal of and the interest on the bonds of the series of which this bond is one shall be made from, and as security for such payment there is pledged, a special fund that is designated as "City of Las Vegas, Nevada, Special Improvement District Nos. 1405, 1407, 1413 and 1414 Bond

Fund" (sometimes referred to herein simply as the "Bond Fund") that contains the receipts, upon the collection thereof, from the special assessments that have been levied against, and secured by a lien upon, the assessable lots and parcels of the property that have been specially benefited by certain public improvements that have been constructed and installed in "City of Las Vegas, Nevada, Special Improvement District No. 1405 (Rampart Boulevard)", "City of Las Vegas, Nevada, Special Improvement District No. 1407 (Buffalo Drive)", "City of Las Vegas, Nevada, Special Improvement District No. 1413 (Alpine/Trent Area)" and "City of Las Vegas, Nevada, Special Improvement District No. 1414 (Lake Mead Boulevard)" (sometimes herein referred to collectively as the "Districts") and remain unpaid from and after the 24th day of August, 1995, which Bond Fund is, and shall continue to constitute, a sinking fund for, and the same shall be deemed to be specially appropriated to, the full and prompt payment of such bonds, and the interest thereon, and shall be used for no other purpose whatsoever; provided, however, that in the event that the Bond Fund is insufficient to pay such bonds, and the interest thereon, as the same become due, and the monies, if any, that are then contained in the City's special surplus and deficiency fund are not sufficient for that purpose, the deficiency shall be paid out of the City's general fund. If such general fund is insufficient to pay any such deficiency promptly, the City Council shall levy, and it shall be its duty to levy, a general (ad valorem) tax upon all of the property within the City that is by law taxable for state, county and municipal purposes that is fully sufficient, after making a due allowance for probable delinquencies, to provide for the prompt payment of such bonds, both principal and interest, as they become due, but subject to the limitation that is imposed by

NRS 361.453 and by Section 2 of Article 10 of the Constitution of the State. Such bonds and the interest thereon are payable solely from the assessments, the monies, if any, that are then contained in the City's special surplus and deficiency fund, the City's general fund and the proceeds of such general tax that are pledged to the payment thereof.

Such special assessments, which have been made and levied to defray the cost and expense, with the interest that has accrued thereon, of constructing and installing such improvements, constitute a lien upon and against the respective lots and parcels property upon which such assessments were made and levied from and after the 25th day of July, 1995, the effective date of the ordinances that levied the assessments for each of the Districts.

It is hereby certified, recited and declared that all of the acts, conditions and things that are essential to the validity of this bond exist, have happened and have been done in due time, form and manner as is required by law; that the total issue of such special assessment bonds of the City to defray the cost of such improvements, and the expenses that were incidental thereto, including this bond, does not exceed the amount that is authorized by law or the aggregate amount of the uncollected special assessments that were levied to defray the cost and expense of constructing and installing such improvements, nor does the portion of the principal amount of the Bonds that is attributable to any one District exceed the total uncollected assessments that were levied in that District; that this bond is issued under the authority of the Consolidated Local Improvements Law, Chapter 271 of the Nevada Revised Statutes; and that this bond is incontestable for any cause whatsoever.

It is hereby further certified, recited and declared that the proceedings with reference to constructing and installing such improvements, levying the assessments to pay therefor and issuing such bonds have been regularly had and taken, in full compliance with the law, and that all of the prerequisites to the fixing of the assessment lien upon the lots and parcels of property that are benefited by such improvements and to the liability of the owner or owners of such lots and parcels for such assessments have been fully satisfied.

Section 15. That, when the Bonds have been duly executed and authenticated, they will be delivered to the Purchaser upon the City's receipt of the purchase price that has been agreed upon. The Registrar shall initially register the Bonds in the name of the Purchaser or in the names of such transferees, or of any combination thereof, as the Purchaser may designate by a writing or writings that is or are satisfactory to the Registrar, as is directed by the Purchaser. The funds that are realized from the sale of the Bonds, including without limitation any investment income therefrom, shall be applied solely to defray the cost and expense of the respective Projects (including without limitation the repayment of any interim financing that may have been incurred in connection therewith). An amount that is equal to the amount of the Bonds that are issued for each of the respective Districts shall be applied to the costs and expenses of the Project for which that District was created; provided, however, that after such cost and expense is paid (excepting any portion thereof that is to be paid with other than the proceeds of such special assessments), any funds that remain from the sale of the Bonds shall be deposited in the Bond Fund and used for the purposes that are specified in Section 3 of this Ordinance. Additionally, all of the monies that are received as accrued interest and premium at the time of the delivery of any of the Bonds shall be deposited in the Bond Fund to apply to the payment of the interest that is next due on the Bonds. The Purchaser, however, shall, in no manner, be responsible for the application by the City, or any of its officers, employees or agents, of any of the funds that are derived from the sale of the Bonds or of any other funds that are designated herein.

Section 16. That, as long as any of the Bonds remain outstanding, the City will keep or cause to be kept true and accurate books of records and accounts that show full and true entries with respect to the collection and disposition of such special assessments, as well as any delinquency in the collection thereof, the deposits in, and the disbursements from, the Bond Fund, the deposits, if any, in, and the disbursements, if any, from, the Surplus and Deficiency Fund, the redemption of the Bonds, both principal and interest, and the disbursements to defray the cost and expense of the Project, including the expenses that were incidental thereto, and the City will permit an inspection and examination of all of such records and accounts at all reasonable times by any representative of the Purchaser.

Section 17. That the officers and employees of the City be, and each of them hereby is, authorized, empowered and directed to take all action that may be necessary or appropriate in order to effectuate the provisions of this Ordinance, including without limitation:

A. The printing of the Bonds, including without limitation the printing of such additional blank bonds as may be required by the Registrar, and the printing on each Bond (or the appending thereto) of a certified true copy of the Bond Counsel's approving opinion and, if appropriate, a statement of insurance;

B. The printing, distribution and execution of a final official statement for the Bonds, as supplemented (the "Official Statement" herein), that is substantially in the form that is now before the City Council, with such amendments, additions and deletions as are in accordance with the facts, are not inconsistent herewith

and are approved by the execution of the Official Statement by the officials that are designated therein; and

C. The execution of such certificates as may be reasonably required by the Purchaser, relating, inter alia, to the signing and registration of the Bonds, the tenure and identity of the officials of the City Council and of the City, the delivery of the Bonds, the designation of the City Treasurer as the Paying Agent and the Registrar for the Bonds, the receipt of the purchase price for the Bonds, the exemption of the interest on the Bonds from federal and state income taxation, and, if it is in accordance with the facts, the absence of litigation, pending or threatened, that may affect the validity of the Bonds. It shall be the duty of the proper officers of the City hereafter to take all action that may be necessary in order for the City to comply with the provisions of NRS Chapter 271, as the same may hereafter be amended and supplemented from time to time.

Section 18. That any owner of any one or more of the Bonds may, either at law or in equity, by suit, action, mandamus or other appropriate proceeding in any court of competent jurisdiction, protect the liens that are created by this Ordinance on the proceeds from the collection of such special assessments and may, by suit, action, mandamus or other appropriate proceeding, enforce and compel the performance of any duty that is imposed upon the City by the provisions of this Ordinance or of any ordinance that has heretofore been adopted that relates to the District, including without limitation the segregation of the special assessments, the proper application thereof and the appointment of a receiver. The failure of the owner of any Bond to proceed as aforesaid shall not

relieve the City or any of its officers, employees or agents of any liability for its or his failure to perform any such duty.

Section 19. That the City hereby covenants, for the benefit of the registered owners of the Bonds, that it will not take any action or omit to take any action with respect to the Bonds, the proceeds thereof, any other funds of the City or any facility of the City, the acquisition of which is financed with the proceeds of the Bonds, if such action or omission (i) would cause the interest on the Bonds to lose its exclusion, for federal income tax purposes under Section 103 of the Internal Revenue Code of 1986, as amended (the "Tax Code" herein), from the gross income of the receipts thereof or (ii) would cause the interest on the Bonds to lose its exclusion from the alternative minimum taxable income, as that term is defined in Section 55(b)(2) of the Tax Code, of such recipients, except to the extent that such interest is required to be included in the adjusted current earnings adjustment that is applicable to corporations under Section 56 of the Tax Code in calculating the alternative minimum taxable income of such corporations. The foregoing covenant shall remain in full force and effect, notwithstanding the payment in full or the defeasance of the Bonds, until the date on which all of the obligations of the City in fulfilling such covenant under the Tax Code have been met.

Section 20. That, pursuant to NRS 271.520, the Bonds, their transfer and the income therefrom shall forever be and remain free and exempt from taxation by the State or any subdivision thereof, except for the tax on estates that is imposed by NRS Chapter 375A and the tax on generation-skipping transfers that is imposed by NRS Chapter 375B.

Section 21. A. This Section constitutes the written undertaking of the City, for the benefit of the owners of the Bonds (which, for the purposes of this Section only, include the beneficial owners of Bonds), which is required in order to allow the Purchaser of the Bonds to comply with Rule 15c2-12 that was promulgated by the Securities and Exchange Commission (the "SEC" herein) under the Securities Exchange Act of 1934, as amended, (17CFR Part 240 § 240.15c2-12) (the "Rule" herein).

B. For purposes of this Section the following definitions shall apply:

i. "Annual Financial Information" means the financial information and operating data with respect to the City of the type that are set forth under those captions in the Official Statement and are specified in the discussion under the caption "Continuing Disclosure Undertaking" in the Official Statement, which financial information and operating data are to be delivered at least annually to each Repository pursuant to subsection C hereof, including Audited Financial Statements, or, if Audited Financial Statements are not available, unaudited financial statements of the City that have been prepared in accordance with Generally Accepted Accounting Principles.

ii. "Audited Financial Statements" means the City's annual financial statements that have been prepared in accordance with Generally Accepted Accounting Principles and audited by a firm of certified public accountants or the legislative auditor as is required by the laws of the State.

iii. "Event Information" means the information that is delivered pursuant to subsection E hereof.

iv. "NRMSIR" means each nationally recognized municipal securities information repository that is recognized by the SEC from time to time pursuant to the Rule. Such NRMSIRs currently include (1) Kenny Information Systems, 65 Broadway, New York, New York 10006-2503; (2) Thomson Municipal Services, Inc., 100 Business Park Drive, 395 Hudson Street, New York, New York 10014-3669; (3) Bloomberg Financial Markets, P.O. Box 888, Princeton, New Jersey 08542-0888; (4) Moody's Investors Service, 99 Church Street, New York, New York 10007-2701; and (5) Disclosure, Inc., 5161 River Road, Bethesda, Maryland 20816-1584.

v. "Official Statement" means the Official Statement, dated as of its date of delivery to the Purchaser, that is delivered in connection with the original issue and sale of the Bonds.

vi. "Repository" means (i) each NRMSIR and (ii) any SID.

vii. "SID" means any State Information Depository that is operated or designated by the State of Nevada that receives information from all issuers within said State. As of the date of this undertaking, no SID exists for the State of Nevada.

viii. "MSRB" means the Municipal Securities Rulemaking Board.

The current address of the MSRB is 1640 King Street, #300, Alexandria, Virginia 22314.

C. Commencing with the Fiscal Year that ends June 30, 1996, the City agrees to provide or cause to be provided the Annual Financial Information to each Repository. Such Annual Financial Information and Audited Financial Statements for each Fiscal Year shall be provided to each Repository on or before March 31 of each calendar year.

D. The City may provide or cause to be provided Annual Financial Information and Audited Financial Information by specific reference to documents that were previously provided to each Repository or filed with the SEC; provided, however, that if the document that is so referenced is a final official statement within the meaning of the Rule, such final official statement must be available from the MSRB.

E. The City shall provide or cause to be provided, in a timely manner, to the MSRB and any SID, notice of any of the following events with respect to the Bonds, if such event is material:

- i. Principal and interest payment delinquencies;
- ii. Nonpayment related defaults;
- iii. Unscheduled draws on debt service reserves that reflect financial difficulties;
- iv. Unscheduled draws on credit enhancements, if any, that reflect financial difficulties;

- v. Substitution of credit or liquidity providers, if any, or their failure to perform;
- vi. Adverse tax opinions or events that affect the tax-exempt status of the Bonds;
- vii. Modifications to the rights of the owners of the Bonds;
- viii. Bond calls;
- ix. Defeasances;
- x. Release, substitution or sale of any property that secures the repayment of the Bonds; and
- xi. Rating changes.

F. The City shall provide or cause to be provided, in a timely manner to the MSRB and any SID, notice of any failure of the City to timely provide the Annual Financial Information and Audited Financial Statements as is specified in subsection C of this Section.

G. The obligation of the City hereunder shall be for the benefit of the owners of the Bonds. Unless they are otherwise required by law, no owner of the Bonds shall be entitled to damages that result from the City's noncompliance with its undertaking that is set forth in this Section; provided; however, the owners of the Bonds may take action to require the performance of such obligation by any judicial proceeding that may be available. A breach of the undertakings of the City hereunder shall not constitute an event of default, and the rights and remedies that are provided in Section 18 hereof are not applicable to the breach of the obligations of the City hereunder.

H. The undertakings that are contained in this Section shall be in effect from and after the issuance and delivery of the Bonds and shall extend to the earlier of (i) the date on which all of the principal of and interest on the Bonds shall have been deemed to have been paid pursuant to the terms of this Ordinance; (ii) the date on which the City shall no longer constitute an "obligated person" within the meaning of the Rule; or (iii) the date on which those portions of the Rule that require this written undertaking are held to be invalid by a court of competent jurisdiction in a non-appealable action, have been repealed retroactively or otherwise do not apply to the Bonds.

I. This Section may be amended from time to time by an ordinance of the City without the consent of the owners of the Bonds or the registered owners of the Bonds if such amendment would not, in and of itself, cause the undertakings herein (or any action that has been taken by the Purchaser in reliance on the undertakings herein) to violate the Rule. The City shall provide notice of such amendment to each Repository with its Annual Financial Information.

Section 22. That the City Council does hereby find and declare that no special assessment that was levied by any of the Assessment Ordinances exceeds the reasonable market value of the lot or parcel of property upon which such special assessment was so levied.

Section 23. That the City Council does hereby find and declare that the life of the improvements of which any of the Projects consists will be not less than the ten (10) year period during which the Bonds mature.

Section 24. That, if the City Council shall, at any time, desire that an institution or some officer of the City other than the City Treasurer act as the Registrar or the Paying Agent, or both, for the Bonds, the City Council may, upon causing the mailing of a notice to each owner of each Bond, at his address that is last shown in the registration books, appoint a successor Registrar or a successor Paying Agent, or both. No change in the Registrar or the Paying Agent, or both, may take effect until a successor Registrar or a successor Paying Agent, as the case may be, is appointed. It is not required that the same institution or officer of the City serve as both the Registrar and the Paying Agent hereunder, but the City shall have the right to have the same institution or the same officer of the City serve as both the Registrar and the Paying Agent hereunder.

Section 25. When all of the principal of, interest on and prior redemption premiums that are due in connection with any of the Bonds have been duly paid, the pledge, the lien and all of the obligations hereunder shall thereby be discharged as to that Bond and the Bond shall no longer be deemed to be outstanding within the meaning of this Ordinance. There shall be deemed to be such due payment when the City has placed in escrow or in trust with a trust bank that is located within or without the State of Nevada an amount that is sufficient (including the known minimum yield that is available for such purpose from bills, certificates of indebtedness, notes, bonds or similar securities which are direct obligations of, or the principal of and interest on which are unconditionally guaranteed by, the United States ("Federal Securities" herein) in which such amount may be initially invested wholly or in part) to meet all bond requirements of the Bond, as the same become due. The Federal Securities shall become due before the

respective times on which the proceeds thereof shall be needed in accordance with a schedule that is established and agreed upon between the City and the bank at the time of the creation of the escrow or trust, or the Federal Securities shall be subject to redemption at the option of the holders thereof to assure the availability of such proceeds as may be needed to meet that schedule. For the purpose of this section "Federal Securities" shall include only Federal Securities that are not callable for redemption prior to their maturities except at the option of the owner thereof.

Section 26. That, after this Ordinance is signed by the Mayor and attested and sealed by the City Clerk, this Ordinance shall be published by its title only, together with the names of the members of the City Council who voted either for or against its passage, such publication to be made in the Las Vegas Review-Journal, a newspaper that is published and has a general circulation within the City, at least once, pursuant to Section 2.110 of said City Charter, such publication to be, substantially, in the following form:

Section 27. That all of the actions, proceedings, matters and things that have heretofore been taken, had and done by the City and the officers thereof (not inconsistent with the provisions of this Ordinance) concerning the Districts, including without limitation the construction and installation of the Project in each District, the performance of all of the prerequisites to the levying of the special assessments for the purpose of defraying, in part, the cost and expense of such Projects and to the fixing of the assessment lien upon each assessable lot or parcel of property within each of the Districts that is benefited by the Project therein and including without limitation the passage and adoption of the corresponding Assessment Ordinance, the issuance of the Bonds in the aggregate principal amount of \$2,249,000.00, the sale thereof to the Purchaser and the distribution of the Official Statement in connection therewith be, and the same hereby are, in all respects approved, ratified and confirmed.

Section 28. That this Ordinance may be amended or supplemented by an ordinance or ordinances that is or are adopted by the City Council, without the receipt by the City of any additional consideration, with the written consent of the owners of seventy-five percent (75%) of the Bonds that are outstanding at the time of the adoption of each such amendatory or supplemental ordinance; provided, however, that no such ordinance shall have the effect of permitting:

- A. An extension of the maturity of any Bond;
- B. A reduction in the principal amount of any Bond or the rate of interest thereon;
