EMERGENCY ORDINANCE NO. 1109

Adopted

An Ordinance entitled: "AN EMERGENCY ORDINANCE DECLARING THE DETERMINATION OF THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS, NEVADA, TO MAKE CERTAIN PUBLIC IMPROVEMENTS IN VARIOUS AREAS OF THE SAID CITY GENERALLY DESCRIBED AS FOLLOWS: UNIT 1 -- INSTALLING STREET PAVING AND CURBS AND GUTTERS IN ALL OF SCOTCH EIGHTY ADDITION, BOUNDED ON THE NORTH BY WALDMAN AVENUE (INCLUDING BOTH SIDES OF WALDMAN AVENUE), ON THE SOUTH BY OAKLEY BOULEVARD (NOT INCLUDING OAKLEY BOULEVARD IMPROVEMENT) AND ON THE EAST AND WEST BY THE BOUNDARIES OF THE SUBDIVISION; UNIT 2-- INSTALLING ALLEY PAVING BETWEEN FREMONT STREET AND OGDEN AVENUE FROM FIFTEENTH STREET TO BRUCE STREET; UNIT 3--INSTALLING ALLEY PAVING BETWEEN THIRTEENTH STREET AND FOURTEENTH STREET FROM CARSON AVENUE TO BRIDGER AVENUE; UNIT 4--INSTALLING ALLEY PAVING BETWEEN MAIN STREET AND SECOND STREET FROM IMPERIAL AVENUE TO UTAH AVENUE; TO CREATE 4-UNIT IMPROVEMENT ASSESSMENT DISTRICT NO. 453 FOR THE PURPOSE OF MAKING SAID IMPROVEMENTS IN SAID AREAS; AND TO DEFRAY THE COSTS AND EXPENSES THEREOF BY SPECIAL ASSESSMENTS MADE ACCORDING TO BENEFITS; FIXING A TIME IN WHICH PROTESTS AGAINST THE PROPOSED IMPROVEMENTS IN EACH INDIVIDUAL UNIT FOR THE CREATION OF SUCH DISTRICT MAY BE HEARD AND CONSIDERED BY SAID BOARD; DIRECTING NOTICE THEREOF TO BE GIVEN; PROVIDING OTHER MATTERS PROPERLY RELATING THERETO; AND DECLARING AN EMERGENCY." was read by title by the City Attorney, Mr. Sidney R. Whitmore.
