

ORDINANCE NO. 1115

AN ORDINANCE AMENDING TITLE X, CHAPTER 2, SECTION 19 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960, PROVIDING FOR INCREASED MILEAGE RATES FOR TAXICABS; PROVIDING FOR POSTING THEREOF WITHIN EACH VEHICLE; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; PROVIDING PENALTIES FOR THE VIOLATION HEREOF; AND REPEALING ALL ORDINANCES, PARTS OF ORDINANCES, SECTIONS, SUBSECTIONS, PHRASES OR SENTENCES IN CONFLICT HEREWITH.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. Title X, Chapter 2, Section 19 of the Municipal Code of the City of Las Vegas, Nevada, 1960, is hereby amended to read as follows:

10-2-19: RATES: No owner or driver of a taxicab shall charge a greater sum for the use of a taxicab for 1, 2 or 3 passengers, than in accordance with the following rates:

(A) Mileage Rates: Fifty cents (50¢) for the first one-quarter (1/4) mile; ten cents (10¢) for each additional one-fourth (1/4) mile thereof, plus twenty-five cents (25¢) for each additional passenger over three (3).

(B) Waiting Time: Four Dollars (\$4.00) for each hour of waiting time.

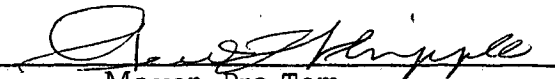
Every taxicab operated in the city shall display a rate card which shall be readable from a distance of six feet (6') by the passengers therein.

SECTION 2. The rates hereof shall become effective 12:01 A.M. on the 1st day of February, 1964.

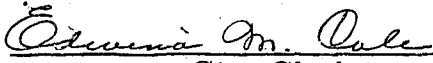
SECTION 3. Any person, firm or corporation violating any of the provisions of this ordinance shall, upon conviction thereof, be punished by a fine of not more than \$500.00 and/or imprisonment in the City Jail for not more than six months, or any combination of such fine and imprisonment. Every day of such violation shall constitute a separate offense.

SECTION 4. All ordinances, or parts of ordinances, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1960, in conflict herewith are hereby repealed.

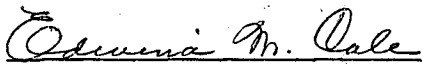

10-2-19. RATES: No owner or driver of a taxicab shall charge a greater sum for the use of a taxicab for 1, 2 or 3 passengers, than in accordance with the following rates:

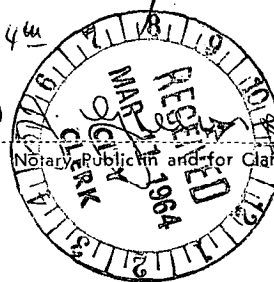
