

ORDINANCE NO. 1193

AN ORDINANCE TO AMEND TITLE I, CHAPTER 7, SECTION 1 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960, BY CREATING A NEW SALARY SCHEDULE TO BE INSTITUTED JULY 1, 1965; PROVIDING A FIVE PER CENT (5%) SALARY INCREASE EFFECTIVE ON SAID DATE; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. Title I, Chapter 7, Section 1 of the Municipal Code of the City of Las Vegas, Nevada, is hereby amended to read as follows:

1-7-1: From and after the first day of July, 1965, the following schedule of by-weekly salary rates shall be in effect for Civil Service employees of the City of Las Vegas, Nevada:
