ORDINANCE NO. 1195

AN ORDINANCE TO AMEND TITLE V, CHAPTER 17, SECTION 6 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960, AND ORDINANCE NO. 1189, EXTENDING THE DISTRICT BOUNDARY FOR GAMBLING OPERATIONS MAINTAINED IN THE CITY OF LAS VEGAS; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; PROVIDING PENALTIES FOR THE VIOLATION HEREOF; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN
AS FOLLOWS:

SECTION 1. Title V, Chapter 17, Section 6 of the Municipal Code of the City of Las Vegas, Nevada, 1960, is hereby amended to read as follows:

5-17-6: DISTRICTS WHEREIN GAMBLING IS PERMITTED: No game, slot machine or gambling device as enumerated in Section 1 hereof and defined in Section 4 of this Chapter, for which a license has been issued, shall be conducted, maintained or operated in the City except within the district thereof bounded by the east side of Main Street, the south side of Stewart Avenue, the west side of Second Street, the east side of Second Street a distance of 150 feet southerly from the southeast corner of Fremont Street, and the east side of Second Street between Fremont Street and Ogden Avenue, and the north side of Carson Avenue, and also on both sides of West Jackson Avenue between North "D" Street and North "G" Street, on both sides of Owens Avenue between "H" Street and "J" Street, and no license shall be issued to conduct, maintain or operate such game, slot machine or gambling device except within such district; provided, that a license may be issued for the conduct, maintenance and operation of slot machines, game and gambling device outside of such district in any hotel having at least one hundred (100) guest rooms, and the same shall be operated and conducted only in conformity with all the requirements of the provisions of this Chapter; and, provided further, that a license may be issued for the operation of a slot machine outside of such district to the owner of any other regularly established and duly licensed business

and such slot machine shall be operated and maintained in
and at such place of business and in accordance with the re-
quirements of this Chapter.

SECTION 2. Any person, firm or corporation violating any of the provisions
of this ordinance shall, upon conviction thereof, be punished by a fine of not more than
\$500.00 and/or imprisonment in the City Jail for not more than six (6) months, or any
combination of such fine and imprisonment. Every day of such violation shall constitute
a separate offense.

SECTION 3. All ordinances or parts of ordinances, sections, subsections,
phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of
Las Vegas, Nevada, 1960, in conflict herewith are hereby repealed.

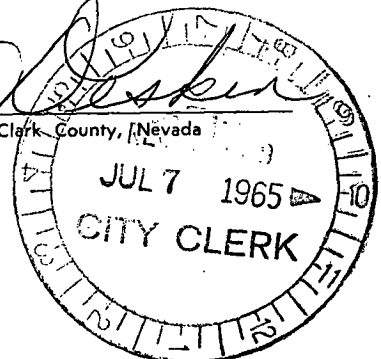

ORDINANCE NO. 1192

AN ORDINANCE TO AMEND TITLE V, CHAPTER 17, SECTION 4 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960, AND ORDINANCE NO. 1189, EXTENDING THE DISTRICT BOUNDARY FOR GAMBLING OPERATIONS MAINTAINED IN THE CITY OF LAS VEGAS; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERE TO; PROVIDING PENALTIES FOR THE VIOLATION HEREOF; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. Title V, Chapter 17, Section 4 of the Municipal Code of the City of Las Vegas, Nevada, 1960, is hereby amended to read as follows:

§ 17-3. DISTRICTS WHEREIN GAMBLING IS PERMITTED. No game, slot machine or gambling device as enumerated in Section 1 hereof, and defined in Section 4 of this Chapter, for which a license has been issued, shall be conducted, maintained or operated in the City except within the district hereat bounded by the east side of Main Street, the south side of Stewart Avenue, the west side of Second Street, the east side of Second Street, a distance of 150 feet southerly from the southeast corner of Fremont Street, and the east side of Second Street between Fremont Street and Oaden Avenue, and the north side of Corson Avenue, and also on both sides of West Jackson Avenue between North "D" Street and North "G" Street, on both sides of Owens Avenue between "H" Street and "J" Street, and no license shall be issued to conduct, maintain or operate such game, slot machine or gambling device except within such district, provided, that a license may be issued for the conduct, maintenance and operation of slot machines, game and gambling device outside of such district in any hotel having at least one hundred (100) guest rooms, and the same shall be operated and conducted only in conformity with all the requirements of the provisions of this Chapter; and provided further, that a license may be issued for the operation of a slot machine outside of such district to the owner of any other regularly established and duly licensed business and such slot machine shall be operated and maintained in and at such place of business and in accordance with the requirements of this Chapter.

SECTION 2. Any person, firm or corporation violating any of the provisions of this ordinance shall, upon conviction thereof, be punished by a fine of not more than \$500.00 and/or imprisonment in the City Jail for not more than six (6) months, or any combination of such fine and imprisonment. Every day of such violation shall constitute a separate offense.

SECTION 3. All ordinances or parts of ordinances, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, 1960, in conflict herewith are hereby repealed.
