

EMERGENCY ORDINANCE NO. 1207

AN EMERGENCY ORDINANCE TO AMEND EMERGENCY ORDINANCE NO. 1204 CREATING SPECIAL ASSESSMENT DISTRICT NO. 467 BY PROVIDING A NEW TIME TO REVIEW THE ASSESSMENTS TO BE LEVIED IN SAID DISTRICT; DIRECTING THE CITY CLERK TO MAIL AND PUBLISH NOTICE OF THE TIME AND PLACE OF SAID REVIEW; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO AND DECLARING AN EMERGENCY.

WHEREAS, the Board of Commissioners of the City of Las Vegas, Nevada, has created Assessment District No. 467 by Emergency Ordinance No. 1204, passed, adopted and approved on the 4th day of August, 1965; and

WHEREAS, said Emergency Ordinance No. 1204 designated a time and place for the review of the assessments to be levied in said district and directed notification thereof to be given; and

WHEREAS, the time designated in said Emergency Ordinance No. 1204 for the review of said assessments is 7:30 P.M. on the 1st day of September, 1965; and

WHEREAS, the County Assessor of Clark County, Nevada, and acting Ex-Officio City Assessor of the City of Las Vegas, has been unable to prepare the assessment roll in respect of said assessment district in time to mail and publish the requisite statutory notices of said review prior to the time set therefor; and

WHEREAS, it is therefore necessary and appropriate to adopt a new ordinance designating a new time to review the assessments to be levied and directing that notification thereof be given in the manner provided by law;

NOW, THEREFORE, THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS, NEVADA, DOES ORDAIN AS FOLLOWS:

Section 1. That Section 1 to Section 7, both inclusive, of said Emergency Ordinance No. 1204 be, and the same hereby are, incorporated herein and by reference made a part hereof, and hereby are, in all respects, confirmed.

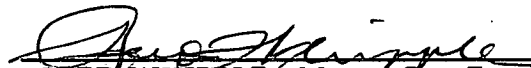
Section 2. That Section 8 of said Emergency Ordinance No. 1204 is hereby amended to read as follows:

Section 8. That before said special assessment roll is adopted and confirmed by said Board, any person objecting to the assessment may file his objection thereto with the City Clerk on or before Wednesday, the 15th day of September, 1965, at 7:30 P.M., at the City Hall in said City, and said time and place are hereby fixed as the time and place when and where said Board and said County Assessor and Ex-Officio City Assessor will meet to hear and consider objections to said special assessment roll and to review said assessment.

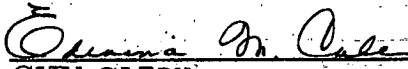
Section 3. That after the filing of the special assessment roll in respect of said district with the City Clerk, she shall give notice in the manner specified in Section 9 of the said emergency ordinance, which said section 9 is incorporated herein and by reference made a part hereof and hereby is, in all respects, confirmed.

Section 4. That Section 10 to Section 21, both inclusive, of said emergency ordinance be and the same hereby are incorporated herein and by reference made a part hereof, and hereby are, in all respects, confirmed.

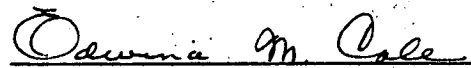
