

ORDINANCE NO. 1211

AN ORDINANCE TO AMEND TITLE V, CHAPTER 17, SECTION 19 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY PROVIDING FOR A SEPARATE POPULATION DISTRICT FOR BINGO LICENSING; PROVIDING FOR OTHER MATTERS PROPERLY RELATED THERETO; PROVIDING PENALTIES FOR THE VIOLATION HEREOF; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS, NEVADA, DOES ORDAIN AS FOLLOWS:

SECTION 1. Title V, Chapter 17, Section 19 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

5-17-19: BINGO AND RACEHORSE BOOK LICENSES LIMITED: Hereafter the issuance of bingo licenses and racehorse book licenses shall be based on population, limiting the number of each type of said licenses issued to one (1) for each fifty thousand (50,000) population, or fraction thereof, within the city, except a separate population district for bingo licensing is hereby created as follows: Bounded on the South by the North side of Bonanza Road, on the East by the Union Pacific Railway track, on the North by Miller, and on the West by the west side of Highland. A license issued in said district shall not be transferable outside said district. The determination of population for the purpose of this Chapter shall be as determined by the Board of Commissioners under appropriate liquor licensing regulations now or hereafter in effect.

SECTION 2. Any person, firm or corporation violating any of the provisions of this ordinance shall, upon conviction thereof, be punished by a fine of not more than \$500.00 and/or imprisonment in the City Jail for not more than six (6) months, or any combination of such fine and imprisonment. Every day of such violation shall constitute a separate offense.

SECTION 3. All ordinances or parts of ordinances, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby repealed.

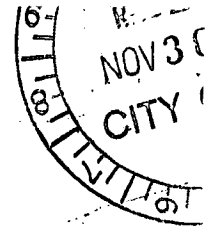
