ORDINANCE No. 3448

AN ORDINANCE RELATING TO THE STORAGE OF VEHICLES IN RESIDENTIAL ZONING DISTRICTS; AMENDING TITLE 19, CHAPTER 78, SECTION 10, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, TO CLARIFY THAT THE PAVED SURFACE UPON WHICH A VEHICLE IS PERMITTED TO BE STORED IN A FRONT OR SIDE YARD IN A RESIDENTIAL ZONING DISTRICT MUST EXTEND THE FULL LENGTH OF THE VEHICLE; PROVIDING PENALTIES FOR THE VIOLATION HEREOF; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

Summary: Requires the paved surface upon which a vehicle may be stored in a front or side yard in a residential zone to extend the full length of the vehicle.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title 19, Chapter 78, Section 10, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

19.78.010: Motor vehicles, including passenger cars, trucks and motorcycles, and trailers, boats and other like vehicles, except motor vehicles primarily designed or used for racing or for purposes other than transportation, may be stored or repaired on any property in a zoning district with an "R" prefix, provided the same do not constitute a nuisance to either the public or area residents, create a health or fire hazard or have a detrimental effect on the neighborhood, and, if they are stored:

(A) In the front yard, are stored either on a designated or established driveway that leads to a garage or carport or on a concrete or asphaltic paved surface[;] which extends the full length of the vehicle; or

(B) In the side yard, are either obscured by an opaque fence six feet high or are stored either on a designated or established driveway that leads to a garage or carport or on a concrete or asphaltic paved surface[,] which extends the full length of the vehicle,

1 and provided, further, that the use complies with the provisions
2 set out in this Chapter.

3 SECTION 2: Whenever in this ordinance any act is
4 prohibited or is made or declared to be unlawful or an offense or
5 a misdemeanor, or whenever in this ordinance the doing of any act
6 is required or the failure to do any act is made or declared to
7 be unlawful or an offense or a misdemeanor, the doing of any such
8 prohibited act or the failure to do any such required act shall
9 constitute a misdemeanor and upon conviction thereof, shall be
10 punished by a fine of not more than \$1,000.00 or by imprisonment
11 for a term of not more than six (6) months, or by any combination
12 of such fine and imprisonment. Any day of any violation of this
13 ordinance shall constitute a separate offense.

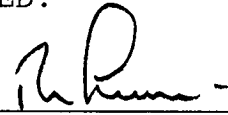
14 SECTION 3: If any section, subsection, subdivision,
15 paragraph, sentence, clause or phrase in this ordinance or any
16 part thereof, is for any reason held to be unconstitutional or
17 invalid or ineffective by any court of competent jurisdiction,
18 such decision shall not affect the validity or effectiveness of
19 the remaining portions of this ordinance or any part thereof.
20 The City Council of the City of Las Vegas, Nevada, hereby
21 declares that it would have passed each section, subsection, sub-
22 division, paragraph, sentence, clause or phrase thereof irrespec-
23 tive of the fact that any one or more sections, subsections, sub-
24 divisions, paragraphs, sentences, clauses or phrases be declared
25 unconstitutional, invalid or ineffective.
