AN ORDINANCE TO AMEND THE MASTER PLAN OF STREETS AND HIGHWAYS PROVIDED FOR IN TITLE 13, CHAPTER 12, SECTION 30 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, BY DELETING BUFFALO DRIVE BETWEEN ANN ROAD AND TROPICAL PARKWAY, AND TROPICAL PARKWAY BETWEEN BUFFALO DRIVE AND CIMARRON ROAD; TO PROVIDE FOR OTHER MATTERS PROPERLY RELATING THERETO AND TO REPEAL ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HERewith.

Summary: Amends Master Plan of Streets and Highways by deleting Buffalo Drive between Ann Road and Tropical Parkway, and Tropical Parkway between Buffalo Drive and Cimarron Road.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: The Master Plan of Streets and Highways provided for in Title 13, Chapter 12, Section 30, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended by deleting therefrom:

(A) Buffalo Drive between Ann Road and Tropical Parkway, and

(B) Tropical Parkway between Buffalo Drive and Cimarron Road.

SECTION 2: If any section, subsection, subdivision, paragraph, sentence, clause or phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the City of Las Vegas, Nevada, hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional, invalid or ineffective.

1 SECTION 3: All ordinances or parts of ordinances,
2 sections, subsections, phrases, sentences, clauses or paragraphs
3 contained in the Municipal Code of the City of Las Vegas, Nevada,
4 1983 Edition, in conflict herewith are hereby repealed.
