AN ORDINANCE TO AMEND TITLE V, CHAPTER 1(A), SECTION 4, SUBSECTION (F) OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, ENTITLED "BUSINESS LICENSE FEE SCHEDULES" TO PROVIDE FOR THE LICENSE FEE SCHEDULES OF FORTUNE TELLERS AND PSYCHICS; AND TO PROVIDE FOR OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS, NEVADA, DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title V, Chapter 1(A), Section 4, Subsection (F) of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

- 5-1(A)-4 (F) (1) Finance Company: \$250.00 semi-annually for each finance company or branch thereof other than a bank, mortgage company, savings and loan, credit union, trust company, or pawnbroker who is in the business of loaning money to others for profit and who holds himself out to the general public as such. A State license under NRS 675 is also required.
- (2) Fortune Teller: \$50.00 semi-annually for every person who carries on, practices, or professes to practice the business of palmistry, phrenology, life reading, fortune telling, cartomancy, clarivoyance, clairaudience, crystal gazing, mediumship, prophecy, augury, devination, magic, [or] necromancy, or a psychic, and demands or

1 receives a fee for the exercise or exhibi-
2 tion of his respective art, directly or
3 indirectly, or incidental to the conduct of
4 any other business, either as a gift, dona-
5 tion, or otherwise, or who gives an exhibi-
6 tion thereof at any place where an admission
7 fee is charged.

8 Each applicant for a fortune teller's license
9 shall pay to the Director of Business
10 Activity the sum of \$50.00 in addition to
11 whatever other costs are needed, which sum
12 shall be a nonrefundable fee for the investi-
13 gation, the application shall be submitted
14 to the Board of City Commissioners which
15 shall approve the applicant if he is found
16 to have a good moral character and meets
17 the other qualifications of this subsection.
18 Every license issued for the practice of
19 fortune telling, or for any similar
20 occupation herein enumerated, shall be
21 limited to areas permitting professional
22 offices or any commercial or industrial use,
23 providing a use permit is issued to the
24 applicant from the Department of Community
25 Planning and Development.
26 No employee or other person shall assist
27 the licensee in any audience or reading,
28 nor shall any mechanical device of any de-
29 scription whatsoever be used by the licensee
30 in the conduct of any interview, audience,
31 or reading.

1 This subsection shall not be construed to
2 apply to astrologers licensed under Section
3 5-1(A)-4(A)12 of this Code.

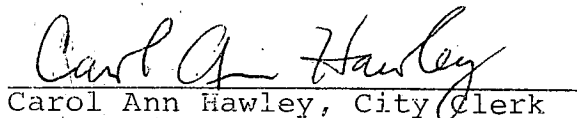
4 SECTION 2: If any section, subsection, subdivision,
5 paragraph, sentence, clause or phrase in this Chapter or any
6 part thereof, is for any reason held to be unconstitutional or
7 invalid or ineffective by any court of competent jurisdiction,
8 such decision shall not affect the validity or effectiveness
9 of the remaining portions of this Chapter or any part thereof.
10 The Board of City Commissioners of the City of Las Vegas,
11 Nevada, hereby declares that it would have passed each section,
12 subsection, subdivision, paragraphs, sentence, clause or phrase
13 thereof, irrespective of the fact that any one or more sections
14 subsections, subdivisions, paragraphs, sentences, clauses or
15 phrases be declared unconstitutional, invalid or ineffective.

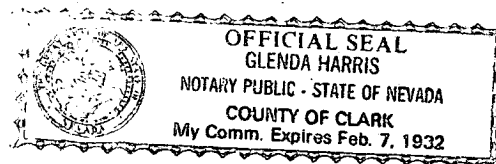

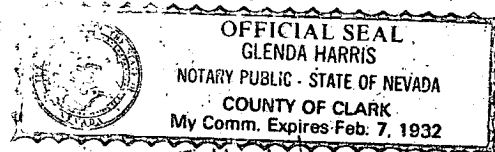

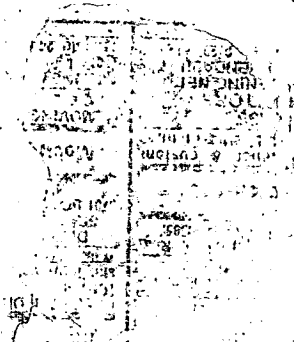
