Ordinance No. 2161

AN ORDINANCE RELATING TO ANIMAL CONTROL; AMENDING TITLE VI, CHAPTER 2, SECTION 2, SUBSECTION F, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, TO PROVIDE THAT THE ANIMAL ADVISORY COMMITTEE ESTABLISHED THEREIN SHALL BE COMPOSED OF A REPRESENTATIVE OF THE CLARK COUNTY VETERINARY MEDICAL ASSOCIATION, THREE MEMBERS APPOINTED FROM THE MEMBERSHIP OF THE VARIOUS ORGANIZATIONS WHICH HAVE DEMONSTRATED AN INTEREST IN THE WELFARE OF ANIMALS AND THE SENIOR ANIMAL CONTROL OFFICER OF THE CITY OF LAS VEGAS; PROVIDING OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT THEREWITH.

Summary: Changes the method of selecting members of the Animal Advisory Committee.

THE BOARD OF CITY COMMISSIONERS OF THE CITY OF LAS VEGAS, NEVADA, DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title VI, Chapter 2, Section 2, Subsection (F), of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

6-2-2(F): That after the filing of a criminal complaint with the Municipal Court, the question of whether the animal is vicious, dangerous or ferocious may be referred by said Court to an Animal Advisory Committee composed of [a member or alternate, respectively,] one representative of the Clark County Veterinary Medical Association, [the Clark County Humane Society, the Nevada Society for the Prevention of Cruelty to Animals, the Nevada Dog Fanciers, Inc., the Nevada Cat Fanciers, Inc., and the National Retail Pet Supply and Groomers Association, such members being selected for service by their respective organizations.] three members selected by the Board of City Commissioners from the membership of the various organizations in the City of Las Vegas which have demonstrated an interest in the welfare of animals and the Senior Animal Control Officer of the City of Las Vegas. The members of the Animal Advisory Committee shall be appointed [by their respective organizations] to serve for a period of

1 two (2) years; said Animal Advisory Committee shall hold an
2 informal hearing after the Defendant is found guilty by the
3 Municipal Court and report its findings and recommendations
4 to the Municipal Court at the time of sentencing of the
5 Defendant. In the event that the Animal Advisory Committee
6 shall find that said animal is vicious, dangerous or fero-
7 cious, then and in that event only, may the animal be
8 destroyed; however, a Municipal Court Judge is not otherwise
9 bound by any decision of the Animal Advisory Committee, but
10 may, by way of fine or imprisonment provide punishment to the
11 owner, possessor or person or persons having control,
12 custody, or care of the animal.

13 SECTION 2: If any section, subsection, subdivision,
14 paragraph, sentence, clause or phrase in this Chapter or any part
15 thereof, is for any reason held to be unconstitutional or invalid
16 or ineffective by any court of competent jurisdiction, such deci-
17 sion shall not affect the validity or effectiveness of the
18 remaining portions of this Chapter or any part thereof. The
19 Board of Commissioners of the City of Las Vegas hereby declares
20 that it would have passed each section, subsection, subdivision,
21 paragraph, sentence, clause or phrase thereof irrespective of the
22 fact that any one or more sections, subsections, subdivisions,
23 paragraphs, sentences, clauses or phrases be declared unconstitu-
24 tional, invalid or ineffective.

25 SECTION 3: All ordinances or parts of ordinances,
26 sections, subsections, phrases, sentences, clauses or paragraphs

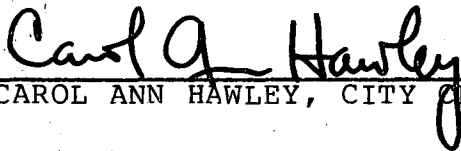

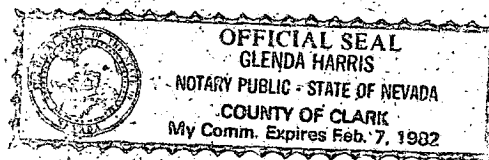

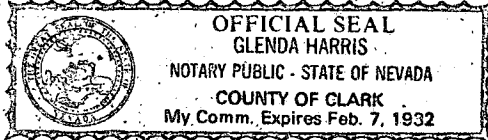
