ORDINANCE NO. 2166

AN ORDINANCE RELATING TO ANIMAL CONTROL; AMENDING TITLE VI, CHAPTER 2, SECTION 2, SUBSECTION F, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, TO PROVIDE THAT THE REPRESENTATION ON THE ANIMAL ADVISORY COMMITTEE ESTABLISHED THEREIN FROM THE VARIOUS ORGANIZATIONS WHICH HAVE DEMONSTRATED AN INTEREST IN THE WELFARE OF ANIMALS SHALL CONSIST OF FOUR MEMBERS; PROVIDING OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT THEREWITH.

THE BOARD OF CITY COMMISSIONERS OF THE CITY OF LAS VEGAS, NEVADA, DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title VI, Chapter 2, Section 2, Subsection (F), of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, as last amended by Section 1 of Ordinance No. 2161 of said City, is hereby amended to read as follows:

6-2-2(F) That after the filing of a criminal complaint with the Municipal Court, the question of whether the animal is vicious, dangerous or ferocious may be referred by said Court to an Animal Advisory Committee composed of one representative of the Clark County Veterinary Medical Association, [three] four members selected by the Board of City Commissioners from the membership of the various organizations in the City of Las Vegas which have demonstrated an interest in the welfare of animals and the Senior Animal Control Officer of the City of Las Vegas. The members of the Animal Advisory Committee shall be appointed to serve for a period of two (2) years; said Animal Advisory Committee shall hold an informal hearing after the Defendant is found guilty by the Municipal

1 Court and report its findings and recommendations to
2 the Municipal Court at the time of sentencing of the
3 Defendant. In the event that the Animal Advisory
4 Committee shall find that said animal is vicious,
5 dangerous or ferocious, then and in that event only,
6 may the animal be destroyed; however, a Municipal
7 Court Judge is not otherwise bound by any decision
8 of the Animal Advisory Committee, but may, by way of
9 fine or imprisonment provide punishment to the owner,
10 possessor or person or persons having control, custody,
11 or care of the animal.

12 SECTION 2: If any section, subsection, subdivision,
13 paragraph, sentence, clause or phrase in this Chapter or any
14 part thereof, is for any reason held to be unconstitutional or
15 invalid or ineffective by any court of competent jurisdiction,
16 such decision shall not affect the validity or effectiveness of
17 the remaining portions of this Chapter or any part thereof. The
18 Board of Commissioners of the City of Las Vegas hereby declares
19 that it would have passed each section, subsection, subdivision,
20 paragraph, sentence, clause or phrase thereof irrespective of
21 the fact that any one or more sections, subsections, sub-
22 divisions, paragraphs, sentences, clauses or phrases be declared
23 unconstitutional, invalid or ineffective.

24 SECTION 3: All ordinances or parts of ordinances,
25 sections, subsections, phrases, sentences, clauses or paragraphs
