Ordinance No. 2169

AN ORDINANCE RELATING TO BUSINESS LICENSING; AMENDING TITLE V, CHAPTER 1(A), SECTION 4, SUBSECTION (M), OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, TO ESTABLISH A LICENSING CATEGORY FOR MERCHANDISE BROKERS AND TO PROVIDE FOR A LICENSE FEE THEREFOR; PROVIDING OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

Summary: Establishes a licensing category for merchandise brokers, including, by way of illustration and not in limitation, so-called "manufacturers' representatives" and "food brokers"; and provides a license fee therefor.

THE BOARD OF CITY COMMISSIONERS OF THE CITY OF LAS VEGAS, NEVADA, DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title V, Chapter 1(A), Section 4, Subsection (M), of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

- 5-1(A)-4(M):
1. Management or Marketing Service: Any person or firm which is conducting budgeting, marketing, financial, property management and/or management counseling or consultant services for an individual or business firm shall pay \$50.00 semi-annually as a management or marketing service.
 2. Marriage and Family Counselors: \$50.00 for each marriage and family counselor certified and registered under NRS 641-A.
 3. Massage Parlor: See the Chapter of Title V entitled "Massage Parlors" for fees and licensing requirements.
 4. Masseur or Masseur: See the Chapter of Title V entitled "Massage Parlors" for fees and licensing requirements.

- 1 5. Mechanical Games or Devices: see Coin-Operated
2 Amusement Machines.
- 3 6. Merchandise Broker: Every person who, for a
4 commission or for other compensation and with-
5 out having such goods, wares, merchandise or
6 services in his possession or control, is en-
7 gaged in selling or negotiating the sale of
8 any of the goods, wares, merchandise or services
9 described in Section 5-1(A)-1. belonging to
10 others shall pay \$50.00 semi-annually.
- 11 [6] 7. Mobile Home Park: Every person operating a mobile
12 home park shall pay a semi-annual fee according
13 to the following schedule:

- 19 [7] 8. Mortgage Company: \$250.00 semi-annually for each
20 mortgage company, including each mortgage loan
21 broker, holding a State license under NRS 645-B.
- 22 [8] 9. Music, Furnished from Central Location and De-
23 livered to Outlets: \$50.00 semi-annually for the
24 business of furnishing continuous and uninterrupted
25 music transmitted from a central location and
26 delivered to an outlet, other than coin-operated,
27 on the premises of the purchaser, and \$10.00
28 semi-annually for each outlet in excess of five
29 (5).
- 30 [9] 10. Mutual Fund Broker - Dealer: \$50.00 semi-
31 annually.
- 32 [10] 11. Mutual Fund Salesman: \$10.00 semi-annually.

SECTION 2: If any section, subsection, subdivision, paragraph, sentence, clause or phrase in this chapter or any part thereof, is for any reason held to be unconstitutional, or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this chapter or any part thereof. The Board of Commissioners of the City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional, invalid or ineffective.

SECTION 3: All ordinances, parts of ordinances, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby repealed.

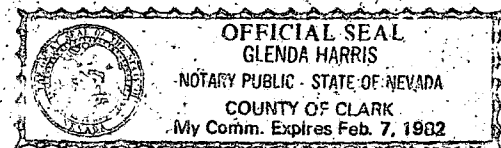
