9 THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS,
10 NEVADA DOES HEREBY ORDAIN AS FOLLOWS:

11 WHEREAS, the Legislature of the State of Nevada, by vir-
12 tue of the Las Vegas City Charter, has granted to the Board of
13 Commissioners of said City the power to declare by ordinance that
14 any offense made a misdemeanor by the laws of the State of Nevada
15 shall also be deemed to be a misdemeanor in the City of Las Vegas
16 whenever such offense is committed within the boundaries of said
17 City; and

18 WHEREAS, the Board of Commissioners of said City has
19 exercised such power, the ordinance to be found in Title VI,
20 Chapter 1, Section 34 of the Municipal Code of said City; and

21 WHEREAS, many new criminal laws were enacted by the 1981
22 Session of the Nevada Legislature, some of which laws became
23 effective on passage and some on July 1, 1981; and

24 WHEREAS, the Board of Commissioners of said City desires
25 by this ordinance to re-adopt said Title VI, Chapter 1, Section
26 34 to include within its purview all of the State misdemeanor
27 laws which are now in effect.

28 NOW, THEREFORE, THE BOARD OF COMMISSIONERS OF THE CITY
29 OF LAS VEGAS, NEVADA, DOES ORDAIN AS FOLLOWS:

30 SECTION 1: Title VI, Chapter 1, Section 34, of the
31 Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is
