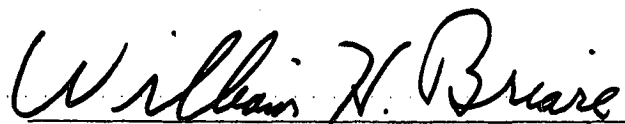

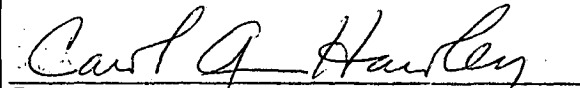
SECTION 2: This Ordinance shall become effective on September 1, 1981.

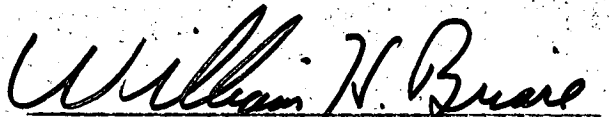

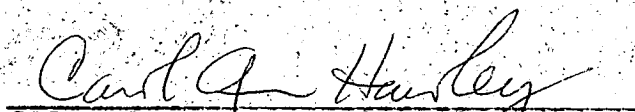
