ORDINANCE NO. 2180

AN ORDINANCE RELATING TO PUBLIC BUS TRANSPORTATION; AMENDING TITLE V, CHAPTER 1(A), SECTION 3, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY REPEALING THE PROHIBITION AGAINST THE GRANTING OF MORE THAN ONE LICENSE FOR PUBLIC BUS TRANSPORTATION SERVICE; PROVIDING OTHER MATTER PROPERLY RELATING THERETO.

Commissioner Ron Lurie	Repeals the prohibition against granting more than one license for bus transportation service.

THE BOARD OF CITY COMMISSIONERS OF THE CITY OF LAS VEGAS, NEVADA, DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title V, Chapter 1(A), Section 3 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

5-1(A)-3: Public Bus Service: Any person operating a public bus transportation service for the carrying of passengers from place to place in the City of Las Vegas shall pay a semi-annual license fee of twenty five dollars (\$25.00) for each bus used in such transportation service. The applicant must file an application designating the routes with the City Clerk and meet Public Service Commission requirements before such license may be approved by the Board of City Commissioners. [As a matter of public policy and public convenience and necessity, only one license for a public bus transportation service shall be granted.]

SECTION 2: If any section, subsection, subdivision, paragraph, sentence, clause or phrase in this Chapter or any part thereof, is for any reason held to be unconstitutional or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the

1 remaining portions of this Chapter or any part thereof. The
2 Board of City Commissioners of the City of Las Vegas, Nevada,
3 hereby declares that it would have passed each section, subsection
4 subdivision, paragraph, sentence, clause or phrase thereof,
5 irrespective of the fact that any one or more sections, subsec-
6 tions, subdivisions, paragraphs, sentences, clauses or phrases be
7 declared unconstitutional, invalid or ineffective.
