Ordinance No. 2183

AN ORDINANCE RELATING TO ARMORED CAR SERVICE, PROVIDING QUALIFICATIONS FOR GUARDS AND DRIVERS, REQUIRING INSURANCE FOR THE PROTECTION FROM LOSSES AND PROVIDING OTHER MATTERS PROPERLY RELATING THERETO.

Summary: Regulates armored car services.

THE BOARD OF CITY COMMISSIONERS OF THE CITY OF LAS VEGAS, NEVADA, DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title V, of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to add a new chapter to read as follows:

SECTION 2: The Board hereby finds that the business of providing armored car services seriously effects the well being of the City and its residents. That such activities are involved in the transportation of property worth millions of dollars, necessitating armed guards to protect the property from theft and robbery and that such business must therefor comply with LVC Chapter 4.

SECTION 3: Unless the context otherwise requires "Armored Car Service" means the providing for hire of the transportation of coin money, currancy, bank notes, money orders, bonds, notes, bills of lading, gambling chips, and other valuable property, instruments or documents.

SECTION 4: It is unlawful for any person to engage in the business of providing an armored car service without a valid license issued pursuant to this chapter.

SECTION 5: Each principal (officer, director, local manager, and owners of 10% or more) must be approved for suitability in order to be associated with an armored car service.

1 However, the Director in his discretion may waive a principal
2 from this requirement if, in his opinion, the principal is so far
3 removed from the operation of the local business that he will not
4 likely exercise significant influence over the business. Any
5 principal who has been so waived may later be required at the
6 discretion of the Director to apply and be found suitable in
7 order to continue his association with the business.

8 SECTION 6: Each driver and guard employed by the
9 licensee must have the following qualifications:

- 10 (A) Be 18 years of age or over;
- 11 (B) Be certified by a licensed doctor to be of sound
12 physique, possessing eyesight with or without
13 correction to at least 20/40 in one eye and 20/100
14 in the other eye, free of physical defects and
15 diseases which might impair ability to drive an
16 armored car or protect the valuables being trans-
17 ported and not addicted to dangerous drugs or
18 alcohol.
- 19 (C) Have satisfactorily completed an approved course
20 and training on how to properly use and carry a
21 weapon. The course and training must be evaluated
22 and approved by the Las Vegas Metropolitan Police
23 Department.
- 24 (D) Be the holder of a work card pursuant to LVC Title
25 V, Chapter 46.

26 SECTION 7: (A) A licensee shall not employ or allow
27 anyone to act as a driver or guard for an armored
28 car unless they meet the qualifications of Section
29 6.

- 30 (B) Each licensee must maintain for a period of 3
31 years and provide to the Department upon request,
32 the certifications required by Section 6 and the

1 names, addresses, birth dates and such other
2 related information on drivers and guards and
3 other employees as the Department may require in
4 order to determine compliance with this Chapter.

5 SECTION 8: Each licensee shall maintain all risk cargo
6 insurance for the property transported or stored and must file
7 with the department a certificate, from the insurance company
8 providing the coverage, showing that such coverage has been pro-
9 vided and containing a provision for thirty (30) day notice to
10 the City if coverage should be stopped for any reason.

11 SECTION 9: Each applicant and licensee shall pay in
12 advance to the Department a semi-annual license fee of \$150.00

13 SECTION 10: If any section, subsection, subdivision,
14 paragraph, sentence, clause or phrase in this Chapter or any part
15 thereof, is for any reason held to be unconstitutional or invalid
16 or ineffective by any court of competent jurisdiction, such
17 decision shall not affect the validity or effectiveness of the
18 remaining portions of this Chapter or any part thereof. The
19 Board of City Commissioners of the City of Las Vegas, Nevada,
20 hereby declares that it would have passed each section, sub-
21 section, subdivision, paragraph, sentence, clause or phrase
22 thereof, irrespective of the fact that any one or more sections,
23 subsections, subdivisions, paragraphs, sentences, clauses or
24 phrases be declared unconstitutional, invalid or ineffective.

25 SECTION 11: Whenever in this ordinance any act is pro-
26 hibited or is made or declared to be unlawful or an offense or a
27 misdemeanor, or whenever in this ordinance the doing of any act
28 is required or the failure to do any act is made or declared to
29 be unlawful or an offense or a misdemeanor, the doing of any such
30 prohibited act or the failure to do any such required act shall
31 constitute a misdemeanor and upon conviction thereof, shall be
32 punished by a fine of not more than \$1,000.00 or by imprisonment

1 for a term of not more than six months, or by any combination of
2 such fine and imprisonment. Any day of any violation of this
3 ordinance shall constitute a separate offense.

4 SECTION 12: Sections 1, 3, 4, 5, 6(A), (B), and (C),
5 7, 8, 9, 10, 11, 12, 13 and 14 become effective upon passage
6 and publication.

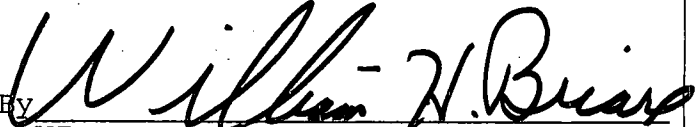
7 SECTION 13: Subsection 6(D) of this ordinance shall
8 become effective November 1, 1981.

10 Section 2 of this ordinance shall immediately become effective
11 and Section 5 of this ordinance shall immediately be repealed.

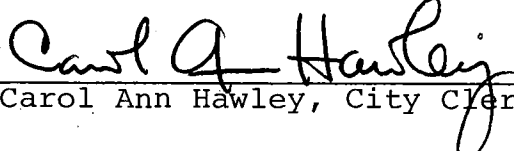
