

ORDINANCE NO. 971

AN ORDINANCE AMENDING TITLE VIII, CHAPTER 3 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960, BY AMENDING SECTION 17 BY DELETING THEREFROM THE LAST SENTENCE THEREOF; BY REPEALING SECTION 18 THEREOF; BY RETAINING ALL OTHER SECTIONS OF TITLE VIII, CHAPTER 3, NOT EXPRESSLY HEREWITH AMENDED AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DO
ORDAIN AS FOLLOWS:

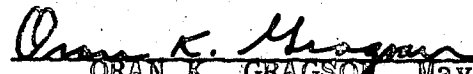
SECTION 1. Section 17 of Chapter 3, Title VIII, Municipal Code of the City of Las Vegas, Nevada, 1960, is hereby amended to read as follows:

FAILURE TO PAY CHARGES WHEN DUE; PENALTY: In case any person shall fail to pay the charge for collecting, hauling and disposing of garbage, rubbish, dirt and dead animals within fifteen (15) days from and after the same becomes due as herein provided, a penalty of ten per cent (10%) of such charge shall be added thereto.

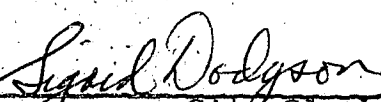
SECTION 2. Section 18 of Chapter 3, Title VIII, Municipal Code of the City of Las Vegas, Nevada, 1960, is hereby repealed.

SECTION 3. All other Sections of Title VIII, Chapter 3, of the Municipal Code of the City of Las Vegas, Nevada, 1960, not expressly herewith amended, are hereby retained.

SECTION 4. All ordinances or parts of ordinances in conflict herewith are hereby repealed.
