

AN ORDINANCE TO AMEND TITLE I, CHAPTER 18 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960, BY AMENDING SECTIONS 340.8 AND 340.9 OF THE CIVIL SERVICE RULES AND REGULATIONS OF THE CITY OF LAS VEGAS, COUNTY OF CLARK, STATE OF NEVADA; PROVIDING FOR INCREASED ELIGIBILITY OF APPLICANTS FOR CIVIL SERVICE POSITIONS; PROVIDING OTHER MATTERS PROPERLY RELATED THERETO AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

The Board of Commissioners of the City of Las Vegas do ordain as follows:

SECTION 1. Title I, Chapter 18, Section 340.8 of the Civil Service Rules and Regulations of the City of Las Vegas, County of Clark, State of Nevada, is hereby amended to read as follows:

340.8 Examinations given in accordance with the requirements of Civil Service Rule 340.2 will be graded on a basis of 100%. No rating higher than 100% shall be given. A minimum grade of 70% must be attained before an applicant is eligible to take any further examination which may be required. Every applicant who receives a final grade of not less than 70% shall be considered to have passed the examination, provided that the Oral Interview grade was not less than 70%.

SECTION 2. Title I, Chapter 18, Section 340.9 of the Civil Service Rules and Regulations of the City of Las Vegas, County of Clark, State of Nevada, is hereby amended to read as follows:

340.9 Disabled veteran and veteran preference points shall be given only on entrance examinations and then only when the applicant has received a final grade of 70%, or more. Ten (10) points shall be added to the final grade for a disabled veteran, or five (5) points for a veteran as defined below:

- (a) "Veteran" means a person who served in the Armed Forces of the United States during any war or in any campaign for which a campaign badge has been authorized, and who is able to establish that he has been honorably separated from such service.
- (b) "Disabled Veteran" is a person who served in the Armed Forces of the United States during any war or in any campaign for which a campaign badge has been authorized and who is able to establish that he has been honorably separated from such service, and to establish by official records the present existence of a service-connected disability, or the current receipt of compensation, disability retirement benefits or pension by reason of such service-connected disability.

SECTION 3. All ordinances, parts of ordinances, chapters, sections, subsections, paragraphs, sentences, clauses or phrases contained in the Municipal Code of the City

of Las Vegas, Nevada, 1960, in conflict herewith are hereby repealed.
