

AN ORDINANCE TO AMEND TITLE XI, CHAPTER 1, SECTION 3, MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960, BY AMENDING THE LAND USE PLAN MAP ADOPTED BY THE CITY OF LAS VEGAS, AND CHANGING THE ZONING DESIGNATION OF CERTAIN AREAS OF THE SAID MAP.

The Board of Commissioners of the City of Las Vegas do ordain as follows:

SECTION 1. The Land Use Plan Map adopted by Title XI, Chapter 1, Section 3, Municipal Code of the City of Las Vegas, Nevada, 1960, is hereby amended to read as follows:

From R-E to M-1: (Z-62-60)

PARCEL 1: A portion of the Northwest Quarter (NW $\frac{1}{4}$) of Section 9, Township 21 South, Range 61 East legally described as:

COMMENCING at the intersection of the East right-of-way line of the proposed Interstate Freeway and the West line of Westwood Drive; thence Southwesterly along the East right-of-way line of the proposed freeway to a point, said point being the intersection of the East line of the proposed freeway and the West line of Section 9, Township 21 South, Range 61 East; thence Southerly along the West line of Section 9, Township 21 South, Range 61 East to a point, said point being the intersection of the West line of Section 9, Township 21 South, Range 61 East with the West line of Highland Drive; thence Northeasterly along the West line of Highland Drive; thence Northwesterly along the South line of Presidio Street; thence Northeasterly along the West line of Westwood Drive to the point of beginning, save and except that portion zoned M-1.

PARCEL 2: Lots 13, 14, 15, 16, Block 1, Golden Gate Tract.

SECTION 2. All ordinances, parts of ordinances, chapters, sections, subsections, paragraphs, sentences, clauses or phrases contained in the Municipal Code of the City of Las Vegas, Nevada, 1960, in conflict herewith are hereby repealed.
