

AN ORDINANCE TO AMEND TITLE I, CHAPTER 18, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, 1960, BY AMENDING SECTION 310.3 (a) OF THE CIVIL SERVICE RULES AND REGULATIONS OF THE CITY OF LAS VEGAS, COUNTY OF CLARK STATE OF NEVADA, PROVIDING FOR AN AGE LIMIT FOR POLICE PATROLMEN: BY PROVIDING FOR ALL MATTERS RELATING THERETO: AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

The Board of Commissioners of the City of Las Vegas do ordain as follows:

SECTION 1. Title I, Chapter 18, Section 310.3 (a) of the Civil Service Rules and Regulations of the City of Las Vegas, County of Clark, State of Nevada is hereby amended to read as follows:

- (a) Age Limit for patrolmen - 23 to 39 years - provided, however, that those who have passed their 36th birthday will be hired only with previous police experience from an accredited law enforcement agency, upon the recommendation of the Chief of Police with the approval of the Personnel Director and City Manager. Persons who have completed a training program for police cadets of at least two years duration and have reached the age of 21 will be eligible for appointment to or to compete in the examination given for this position.

SECTION 2. All ordinances, parts of ordinances, chapters, sections, subsections, paragraphs, sentences, clauses or phrases contained in the Municipal Code of the City of Las Vegas, Nevada, 1960, in conflict herewith are hereby repealed.

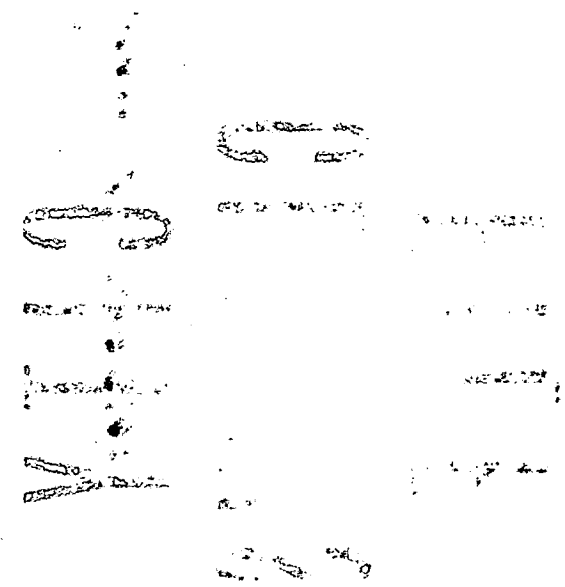
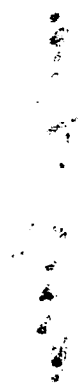
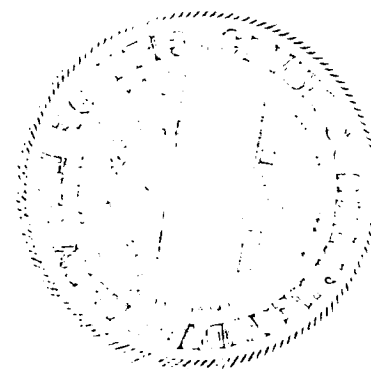

AN ORDINANCE TO AMEND TITLE I,
CHAPTER 18, OF THE MUNICIPAL

vada is hereby amended to read as
follows:

(a) Age Limit for patrolmen — 23 to
39 years — provided, however, that

day will be hired only with previous
police experience from an accredited
law enforcement agency, upon the
recommendation of the Chief of Police
with the approval of the Personnel
Director and City Manager. Persons
who have completed a training pro-
gram for police cadets of at least
two years duration and have reached
the age of 21 will be eligible for ap-
pointment to or to compete in the ex-
amination given for this position.

SECTION 2. All ordinances, parts of
ordinances, chapters, sections, subsec-
tions, paragraphs, sentences, clauses or
phrases contained in the Municipal Code
of the City of Las Vegas, Nevada, 1960,
in conflict herewith are hereby repealed.
