

ORDINANCE NO. 1334

AN ORDINANCE TO AMEND ORDINANCE NO. 1323 AND TITLE X, CHAPTER 3, SECTION 12 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY PROVIDING A MAXIMUM NUMBER OF PARKING METER EXEMPTION PERMITS TO BE ISSUED TO PRESS MEDIA AND PUBLIC OFFICIALS; PROVIDING OTHER MATTERS PROPERLY RELATED THERETO; PROVIDING PENALTIES FOR THE VIOLATION HEREOF; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH. 1334

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. Ordinance No. 1323 and Title X, Chapter 3, Section 12 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

10-3-12: The Director of License and Revenue shall hereafter be authorized to issue sixty (60) parking meter exemption permits as follows:

Certain of said exemption permits shall be issued for the benefit of press media and the utilization of said exemption permits shall be designated to personnel representing press media by the firm or company. All other exemption permits as hereinabove designated shall be issued to public officials and in every instance said exemption permits shall be utilized for official business only as required by the respective position.

SECTION 2. Any person, firm or corporation violating any of the provisions of

this ordinance shall, upon conviction thereof, be punished by a fine of not more than \$500.00 and/or imprisonment in the City Jail for not more than six (6) months, or any combination of such fine and imprisonment. Every day of such violation shall constitute a separate offense.

SECTION 3. All ordinances or parts of ordinances, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, in conflict herewith are hereby repealed.

SECTION 2. Any person, firm or corporation violating any of the provisions of this ordinance shall, upon conviction thereof, be punished by a fine of not more than \$500.00 and/or imprisonment in the City Jail for not more than six (6) months, or any combination of such fine and imprisonment. Every day of such violation shall constitute a separate offense.

SECTION 3. All ordinances or parts of ordinances, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, in conflict herewith are repealed.
