

ORDINANCE NO. 1339

AN ORDINANCE TO AMEND TITLE X OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY AMENDING CHAPTER 14, SECTION 3, SUBSECTION (B) OF SAID TITLE TO REVISE SCHEDULE V THEREOF PROVIDING FOR STOP STREETS; BY AMENDING CHAPTER 17, SECTION 24 OF SAID TITLE PROHIBITING PARKING AT ALL TIMES ON CERTAIN STREETS BY REVISING SCHEDULE VII THEREOF; BY AMENDING CHAPTER 17, SECTION 26 OF SAID TITLE PROHIBITING STOPPING, STANDING OR PARKING DURING CERTAIN HOURS ON CERTAIN STREETS BY REVISING SCHEDULE IX THEREOF; BY AMENDING CHAPTER 17, SECTION 27 OF SAID TITLE PROVIDING LIMITED PARKING TIME ON CERTAIN STREETS BY REVISING SCHEDULE X THEREOF; BY AMENDING CHAPTER 25, SECTION 2, SUBSECTION (C) OF SAID TITLE BY REVISING SCHEDULE I THEREOF PROVIDING 35 AND 25 MILES PER HOUR SPEED LIMITS ON CERTAIN STREETS; BY AMENDING CHAPTER 26, SECTION 2 OF SAID TITLE BY REVISING SCHEDULE II THEREOF PROVIDING THAT CERTAIN STREETS OR PORTIONS THEREOF SHALL BE ONE-WAY STREETS; BY AMENDING CHAPTER 29, SECTION 16 OF SAID TITLE BY REVISING SCHEDULE XIV THEREOF DESIGNATING CERTAIN STREETS OR PARTS OF STREETS AS TRUCK ROUTES; PROVIDING FOR OTHER MATTERS PROPERLY RELATED THERETO; PROVIDING PENALTIES FOR THE VIOLATION HEREOF; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN
AS FOLLOWS:

SECTION 1. Title X, Chapter 14, Section 3, Subsection (B) of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended by adding to Schedule V thereof the following:

10-14-3(B): SCHEDULE V

Bruce Street at Franklin Avenue

Sweeney Avenue at Bruce Street

Arville Street at Oakey Boulevard

SECTION 2. Title X, Chapter 17, Section 24 of said Municipal Code is hereby amended by adding to Schedule VII thereof the following:

10-17-24: SCHEDULE VII

Bonanza Road -- along both sides from Casino Center Boulevard
easterly to a point 300 feet east of Las Vegas Blvd. North

Owens Avenue -- along the south side between Main Street and
Las Vegas Blvd. North

Eastern Avenue -- along the west side between Oakey Boulevard
and Ballard Drive

SECTION 3. Title X, Chapter 17, Section 26 of said Municipal Code is hereby amended by adding to Schedule IX thereof the following:

10-17-26: SCHEDULE IX

Area of D Street, Paul Avenue, Cadillac Lane and George Place
(No Parking, Tuesdays, 5:00 A.M. to 6:00 A.M.)

Santa Paula along both sides from Oakey Boulevard and Sahara Avenue
(No Parking, Wednesdays, 8:00 A.M. to 10:00 A.M.)

SECTION 4. Title X, Chapter 17, Section 27 of said Municipal Code is hereby amended by adding to Schedule X thereof the following:

10-17-27: SCHEDULE X

SECTION 5. Title X, Chapter 25, Section 2, Subsection (C) of said Municipal Code is hereby amended by adding to Schedule I thereof the following:

10-25-2(C): SCHEDULE I

Eastern Avenue -- between Charleston Boulevard and Sahara Avenue

Bruce Street -- between Charleston Boulevard and Stewart Avenue

SECTION 6. Title X, Chapter 26, Section 2 of said Municipal Code is hereby amended by adding to Schedule II thereof the following:

10-26-2: SCHEDULE II

North Fourth Street -- that portion of North Fourth Street from Ogden Avenue to Stewart Avenue, traffic shall move only in a northerly direction.

Casino Center Boulevard -- that portion of Casino Center Boulevard from Ogden Avenue to Stewart Avenue, traffic shall move only in a southerly direction.

SECTION 7. Title X, Chapter 29, Section 16 of said Municipal Code is hereby amended by adding to Schedule XIV thereof the following:

Highland Avenue	Bonanza Road	Carey Avenue
Sahara Avenue	Rancho Road	Decatur Boulevard
Valley View Drive	Sahara Avenue	Southerly City Limits

SECTION 8. Any person, firm or corporation violating any of the provisions of this ordinance shall, upon conviction thereof, be punished by a fine of not more than \$500.00 and/or imprisonment in the City Jail for not more than six (6) months, or any combination of such fine and imprisonment. Every day of such violation shall constitute a separate offense.

SECTION 9. All ordinances or parts of ordinances, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby repealed.

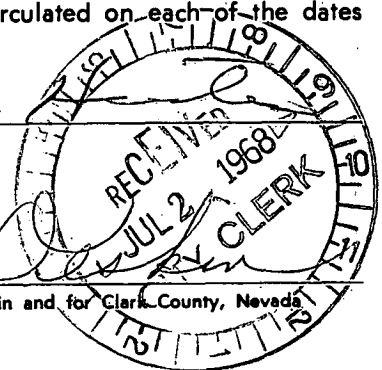

AN ORDINANCE TO AMEND TITLE X OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY AMENDING CHAPTER 14, SECTION 3, SUBSECTION (B) OF SAID TITLE TO REVISE SCHEDULE V THEREOF PROVIDING FOR STOP STREETS; BY AMENDING CHAPTER 17, SECTION 24 OF SAID TITLE PROHIBITING PARKING AT ALL TIMES ON CERTAIN STREETS BY REVISING SCHEDULE VII THEREOF; BY AMENDING CHAPTER 17, SECTION 26 OF SAID TITLE PROHIBITING STOPPING, STANDING OR PARKING DURING CERTAIN HOURS ON CERTAIN STREETS BY REVISING SCHEDULE IX THEREOF; BY AMENDING CHAPTER 17, SECTION 27 OF SAID TITLE PROVIDING LIMITED PARKING TIME ON CERTAIN STREETS BY REVISING SCHEDULE X THEREOF; BY AMENDING CHAPTER 25, SECTION 2, SUBSECTION (C) OF SAID TITLE BY REVISING SCHEDULE I THEREOF PROVIDING 35 AND 25 MILES PER HOUR SPEED LIMITS ON CERTAIN STREETS; BY AMENDING CHAPTER 26, SECTION 2 OF SAID TITLE BY REVISING SCHEDULE II THEREOF PROVIDING THAT CERTAIN STREETS OR PORTIONS THEREOF SHALL BE ONE-WAY STREETS; BY AMENDING CHAPTER 29, SECTION 16 OF SAID TITLE BY REVISING SCHEDULE XIV THEREOF DESIGNATING CERTAIN STREETS OR PARTS OF STREETS AS TRUCK ROUTES; PROVIDING FOR OTHER MATTERS PROPERLY RELATED THERETO; PROVIDING PENALTIES FOR THE VIOLATION HEREOF; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. Title X, Chapter 14, Section 3, Subsection (B) of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended by adding to Schedule V thereof the following:

10-14-3(B): SCHEDULE V
Bruce Street at Franklin Avenue
Sweeney Avenue at Bruce Street
Arville Street at Oakey Boulevard
SECTION 2. Title X, Chapter 17, Section 24 of said Municipal Code is hereby amended by adding to Schedule VII thereof the following:

10-17-24: SCHEDULE VII
Bonanza Road—along both sides from Casino Center Boulevard easterly to a point 300 feet east of Las Vegas Blvd. North
Owens Avenue—along the south side between Main Street and Las Vegas Blvd. North
Eastern Avenue—along the west side between Oakey Boulevard and Ballard Drive

SECTION 3. Title X, Chapter 17, Section 26 of said Municipal Code is hereby amended by adding to Schedule IX thereof the following:

10-17-26: SCHEDULE IX
Area of D Street, Paul Avenue, Cadillac Lane and George Place
(No Parking, Tuesdays, 5:00 a.m. to 6:00 a.m.)

Santa Paula along both sides from Oakey Boulevard and Sahara Avenue
(No Parking, Wednesdays, 8:00 a.m. to 10:00 a.m.)

SECTION 4. Title X, Chapter 17, Section 27 of said Municipal Code is hereby amended by adding to Schedule X thereof the following:

10-17-27: SCHEDULE X
Stewart Avenue from 7th Street to 8th Street North Side
Industrial Road from Chicago Avenue to Sahara Avenue Both sides
Casino Center Blvd. from California Avenue to 100' North of California Ave. West side

SECTION 5. Title X, Chapter 25, Section 2, Subsection (C) of said Municipal Code is hereby amended by adding to Schedule I thereof the following:

10-25-2(C): SCHEDULE I
Eastern Avenue — between Charleston Boulevard and Sahara Avenue

Bruce Street — between Charleston Boulevard and Stewart Avenue

SECTION 6. Title X, Chapter 26, Section 2 of said Municipal Code is hereby amended by adding to Schedule II thereof the following:

10-26-2: SCHEDULE II
North Fourth Street — that portion of North Fourth Street from Ogden Avenue to Stewart Avenue, traffic shall move only in a northerly direction.

Casino Center Boulevard — that portion of Casino Center Boulevard from Ogden Avenue to Stewart Avenue, traffic shall move only in a southerly direction.

SECTION 7. Title X, Chapter 29, Section 16 of said Municipal Code is hereby amended by adding to Schedule XIV thereof the following:

Highland Avenue from Bonanza Road to Carey Avenue
Sahara Avenue from Rancho Road to Decatur Boulevard

Valley View Drive from Sahara Avenue to Southerly City Limits

SECTION 8. Any person, firm or corporation violating any of the provisions of this ordinance shall, upon conviction thereof, be punished by a fine of not more than \$500.00 and/or imprisonment in the City Jail for not more than six (6) months, or any combination of such fine and imprisonment. Every day of such violation shall constitute a separate offense.

SECTION 9. All ordinances or parts of ordinances, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby repealed.
