

ORDINANCE NO. 1354

AN ORDINANCE TO AMEND TITLE VI, CHAPTER 1 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY REPEALING SECTION 7 THEREOF ENTITLED "DANCE HALLS"; TO AMEND TITLE V OF SAID MUNICIPAL CODE BY ADDING THERETO A NEW CHAPTER, TO BE DESIGNATED CHAPTER 34, PROVIDING FOR RULES AND REGULATIONS GOVERNING DANCE HALLS; PROVIDING OTHER MATTERS PROPERLY RELATING THERETO; PROVIDING PENALTIES FOR THE VIOLATION HEREOF; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH. 1354

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. Section 7, Chapter 1, Title VI of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby repealed.

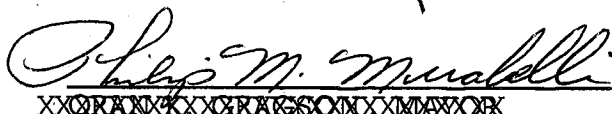
SECTION 2. Title V of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended by adding thereto a new chapter, to be designated Chapter 34, to read as follows:

- 5-34-1: DANCE HALLS: Any person or firm desiring to establish a dance hall within the City of Las Vegas shall file an application with the Director of License and Revenue.
- 5-34-2: Such application may be referred to the Chief of Police for the purpose of establishing that the applicant shall not have been convicted of a felony or two or more misdemeanors involving moral turpitude, and a bond in the amount of Two Thousand (\$2,000.00) Dollars shall be discretionary.
- 5-34-3: The applicant shall provide adequate security during the time when any dance is in progress and shall not permit minor guests to leave and return.
- 5-34-4: Curfew laws shall be observed by the applicant and minimum lighting shall be provided so that the intensity of such interior lighting shall be not less than one foot candle power light when measured at a point thirty inches from the floor wherever persons and patrons are sitting or standing within the premises.
- 5-34-5: A permit of Ten (\$10.00) Dollars shall be charged. Promotional activities other than those governed under Title II, Chapter 7 of this Code may be charged a fee of Twenty Five (\$25.00) Dollars.

SECTION 3. Any person, firm or corporation violating any of the provisions of this ordinance shall, upon conviction thereof, be punished by a fine of not more than \$500.00 and/or imprisonment in the city jail for not more than six (6) months, or any combination of such fine and imprisonment. Every day of such violation shall constitute a separate offense.

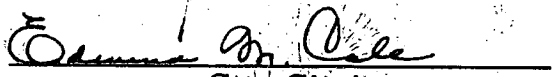

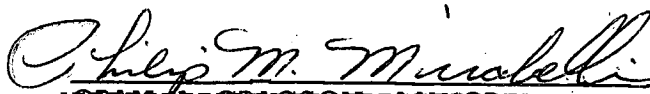

ORDINANCE NO. 1354
AN ORDINANCE TO AMEND TITLE VI, CHAPTER 1 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY REPEALING SECTION 7 THEREOF ENTITLED "DANCE HALLS"; TO AMEND TITLE V OF SAID MUNICIPAL CODE BY ADDING THERETO A NEW CHAPTER, TO BE DESIGNATED CHAPTER 34, PROVIDING FOR RULES AND REGULATIONS GOVERNING DANCE HALLS; PROVIDING OTHER MATTERS PROPERLY RELATING THERETO; PROVIDING PENALTIES FOR THE VIOLATION HEREOF; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. Section 7, Chapter 1, Title VI of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby repealed.

SECTION 2. Title V of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended by adding thereto a new chapter, to be designated Chapter 34, to read as follows:

5-34-1:
DANCE HALLS: Any person or firm desiring to establish a dance hall within the City of Las Vegas shall file an application with the Director of License and Revenue.

5-34-2:
Such application may be referred to the Chief of Police for the purpose of establishing that the applicant shall not have been convicted of a felony or two or more misdemeanors involving moral turpitude, and a bond in the amount of Two Thousand (\$2,000.00) Dollars shall be discretionary.

5-34-3:
The applicant shall provide adequate security during the time when a dance is in progress and shall not permit minor guests to leave and return.

5-34-4:
Curfew laws shall be observed by the applicant and minimum lighting shall be provided so that the intensity of such interior lighting shall

be not less than one foot candle power light when measured at a point thirty inches from the floor wherever persons and patrons are sitting or standing within the premises.

5-34-5:
A permit of Ten (\$10.00) Dollars shall be charged. Promotional activities other than those governed under Title II, Chapter 7 of this Code may be charged a fee of Twenty Five (\$25.00) Dollars.

SECTION 3. Any person, firm or corporation violating any of the provisions of this ordinance shall, upon conviction thereof, be punished by a fine of not more than \$500.00 and/or imprisonment in the city jail for not more than six (6) months, or any combination of such fine and imprisonment. Every day of such violation shall constitute a separate offense.

SECTION 4. All ordinances or parts of ordinances, sections, subsections, phrases clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby repealed.
