

ORDINANCE NO. 1361

AN ORDINANCE TO AMEND TITLE V OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY REPEALING CHAPTER 23 THEREOF, ENTITLED "ESCORT BUREAUS" AND PROVIDING THAT HEREAFTER THERE SHALL BE NO SUCH LICENSED BUSINESS WITHIN THE CITY OF LAS VEGAS; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. Chapter 23 of Title V of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby repealed, and hereafter there shall be no such business license issued within the City of Las Vegas.

SECTION 2. All ordinances or parts of ordinances, sections, subsections, phrases, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby repealed.

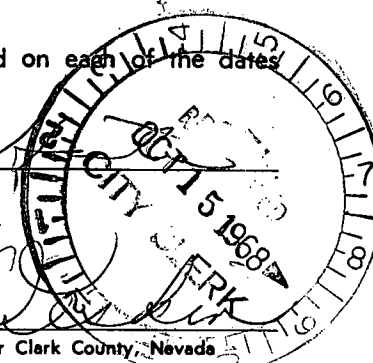
