

ORDINANCE NO. 1242

AN ORDINANCE ANNEXING TO AND MAKING A PART OF THE CITY OF LAS VEGAS CERTAIN SPECIFICALLY DESCRIBED TERRITORY ADJOINING AND CONTIGUOUS TO THE CORPORATE LIMITS OF THE CITY OF LAS VEGAS; DECLARING SAID TERRITORY AND INHABITANTS TO BE ANNEXED THERETO AND SUBJECT TO ALL LAWS AND ORDINANCES; ORDERING A PLAT SHOWING SAID TERRITORY TO BE RECORDED IN THE OFFICE OF THE COUNTY RECORDER OF THE COUNTY OF CLARK, STATE OF NEVADA, AND PROVIDING OTHER MATTERS PROPERLY RELATED THERETO.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. Pursuant to Section 22, Chapter 484, Statutes of Nevada 1965, and a hearing having been held by the Clark County Annexation Commission on the 4th day of January, 1966, and said Commission having approved said annexation, and pursuant to a hearing having been scheduled before the Board of City Commissioners on the 16th day of February, 1966, and no person or persons having appeared to object to said annexation, and the hereinafter described real property being contiguous and adjacent to the exterior boundaries of the City of Las Vegas, the same are hereby annexed to and included within the boundaries of the City of Las Vegas, Nevada. Said parcel is described as follows, to-wit:

That portion of the South Half (S 1/2) of Section 8 lying west of the west right-of-way line of Interstate Freeway No. 15, Township 21 South, Range 61 East, M.D.B.&M.

Together with the tenements, property and inhabitants within said parcel of real property, are hereby declared to be a part of the City of Las Vegas.

SECTION 2. Said parcel of real property, together with the tenements and inhabitants thereof, shall be subject to the laws applicable to the City of Las Vegas.

SECTION 3. The City Engineer of the City of Las Vegas is hereby instructed to prepare plats of said territory described in Section 1 of this ordinance and to file the same for record in the office of the County Recorder of Clark County, Nevada.

Said parcel is described as follows, to-wit:

That portion of the South Half (S½) of Section 8, lying west of the west right-of-way line of Interstate Freeway No. 15, Township 21 South, Range 61 East, M.D.B.&M.

Together with the tenements, property and inhabitants within said parcel of real property, are hereby declared to be a part of the City of Las Vegas.

SECTION 2. Said parcel of real property, together with the tenements and inhabitants thereof, shall be subject to the laws applicable to the City of Las Vegas.

SECTION 3. The City Engineer of the City of Las Vegas is hereby instructed to prepare plats of said territory described in Section 1 of this ordinance and to file the same for record in the office of the County Recorder of Clark County, Nevada.
