

ORDINANCE NO. 1255

AN ORDINANCE ANNEXING TO AND MAKING A PART OF THE CITY OF LAS VEGAS CERTAIN SPECIFICALLY DESCRIBED TERRITORY ADJOINING AND CONTIGUOUS TO THE CORPORATE LIMITS OF THE CITY OF LAS VEGAS; DECLARING SAID TERRITORY AND INHABITANTS TO BE ANNEXED THERETO AND SUBJECT TO ALL LAWS AND ORDINANCES; ORDERING A PLAT SHOWING SAID TERRITORY TO BE RECORDED IN THE OFFICE OF THE COUNTY RECORDER OF THE COUNTY OF CLARK, STATE OF NEVADA, AND PROVIDING OTHER MATTERS PROPERLY RELATED THERETO. 1255-

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. Pursuant to Section 22, Chapter 484, Statutes of Nevada 1965, and a hearing having been set by the Clark County Annexation Commission on the 18th day of April, 1966, and continued to the 17th day of May, 1966, and said Commission having approved said annexation, and pursuant to a hearing having been scheduled before the Board of City Commissioners on the 6th day of July, 1966, and no person or persons having appeared to object to said annexation and the hereinafter described real property being contiguous and adjacent to the exterior boundaries of the City of Las Vegas, the same are hereby annexed to and included within the boundaries of the City of Las Vegas, Nevada. Said parcels are described as follows, to-wit:

Parcel #1: The Southwest Quarter (SW 1/4) of the Southeast Quarter (SE 1/4) and the Southeast Quarter (SE 1/4) of the Southwest Quarter (SW 1/4), excepting therefrom the West Half (W 1/2) of the West Half (W 1/2) of said Southeast Quarter (SE 1/4) of the Southwest Quarter (SW 1/4) Section 20, Township 20 South, Range 61 East, M.D.B.&M.

Parcel #2: The Northeast Quarter (NE 1/4) of the Northeast Quarter (NE 1/4), Section 20, Township 20 South, Range 61 East, M.D.B.&M.

Parcel #3: The East 150 feet of Lot 6, Sebec Acres, a recorded subdivision in the Southwest Quarter (SW 1/4), Section 20, Township 20 South, Range 61 East, M.D.B.&M.

Together with the tenements, property and inhabitants within said parcel of real property, are hereby declared to be a part of the City of Las Vegas.

SECTION 2. Said parcel of real property, together with the tenements and inhabitants thereof, shall be subject to the laws applicable to the City of Las Vegas.

SECTION 3. The City Engineer of the City of Las Vegas is hereby instructed to prepare plats of said territory described in Section 1 of this ordinance and to file the same for record in the Office of the County Recorder of Clark County, Nevada.

OF THE COUNTY OF CLARK, STATE
OF NEVADA, AND PROVIDING OTHER
MATTERS PROPERLY RELATED
THERE TO.

THE BOARD OF COMMISSIONERS
OF THE CITY OF LAS VEGAS DOES
ORDAIN AS FOLLOWS:

SECTION 1. Pursuant to Section 22,
Chapter 484, Statutes of Nevada, 1965,
and a hearing having been set by the
Clark County Annexation Commission on
the 18th day of April, 1966, and contin-
ued to the 17th day of May, 1966, and
said Commission having approved said
annexation, and pursuant to a hearing
having been scheduled before the Board
of City Commissioners on the 6th day
of July, 1966, and no person or persons
having appeared to object to said an-
nexation, and the hereinafter described
real property being contiguous and adja-
cent to the exterior boundaries of the
City of Las Vegas, the same are hereby
annexed to and included within the bound-
aries of the City of Las Vegas, Ne-
vada. Said parcels are described as fol-
lows, to-wit:

Parcel No. 1: The Southwest Quarter
(SW¼) of the Southeast Quarter (SE¼)
and the Southeast Quarter (SE¼) of
the Southwest Quarter (SW¼) except-
ing therefrom the West Half (W½) of
the West Half (W½) of said Southeast
Quarter (SE¼) of the Southwest Quar-
ter (SW¼), Section 20, Township 20
South, Range 61 East, M.D.B.&M.
Parcel No. 2: The Northeast Quarter
(NE¼) of the Northeast Quarter
(NE¼), Section 20, Township 20 South,
Range 61 East, M.D.B.&M.
Parcel No. 3: The East 150 feet
of Lot 6, Sebec Acres, a recorded sub-
division in the Southwest Quarter
(SW¼), Section 20, Township 20 South,
Range 61 East, M.D.B.&M.

Together with the tenements, prop-
erty, and inhabitants within said par-
cel of real property, are hereby de-
clared to be a part of the City of Las
Vegas.

SECTION 2. Said parcel of real prop-
erty, together with the tenements and
inhabitants thereof, shall be subject to
the laws applicable to the City of Las
Vegas.

SECTION 3. The City Engineer of the
City of Las Vegas is hereby instructed
to prepare plats of said territory de-
scribed in Section 1 of this ordinance
and to file the same for record in the
Office of the County Recorder of Clark
County, Nevada.
