

ORDINANCE NO. 1256

AN ORDINANCE TO AMEND TITLE VIII, CHAPTER 3, SECTION 8 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, PROVIDING FOR THE REGULATION OF THE HAULING OF RUBBISH; TO AMEND SECTION 11 OF SAID TITLE AND CHAPTER BY PROVIDING FOR TIME LIMITS FOR THE PLACING AND REMOVAL OF GARBAGE RECEPTACLES AND REGULATING THE LOCATION THEREOF; TO AMEND TITLE VIII, CHAPTER 8 OF SAID MUNICIPAL CODE BY ADDING THERETO A NEW SECTION, DESIGNATED SECTION 24, PROVIDING PENALTIES FOR THE VIOLATION HEREOF; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1. Title VIII, Chapter 3, Section 8 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

8-3-8: COLLECTING OR TRANSPORTING OF GARBAGE: It shall be unlawful for any person, other than the City, or its authorized contractor, or his duly appointed agents, to collect, haul, convey or transport any garbage, rubbish, dirt or dead animals; provided, however, that construction rubbish and excavation debris may be removed by duly licensed building contractors; and provided further, that private persons for noncommercial purposes and not for pecuniary profit may remove, convey and transport rubbish, as defined in this Chapter, to a city owned and operated dumping ground.

SECTION 2. Title VIII, Chapter 3, Section 11 of said Municipal Code is hereby amended to read as follows:

8-3-11: OWNERS AND RESIDENTS TO PROVIDE RECEPTACLES: Every person owning or managing any place of business, public building, multiple dwelling or residence, except as provided in Section 19 of this Chapter, shall provide a receptacle sufficient for the depositing of all garbage, rubbish and dirt from his premises. It shall be unlawful in any district classified as an "R" district under the zoning regulations of the City of Las Vegas to place, keep, store, or locate within the right-of-way of a street, sidewalk or alley, or within any front yard as defined in the zoning regulations of the City of Las Vegas, any such receptacle; provided, however,

such receptacle may be placed within such area for the purpose of the collection of garbage from midnight to midnight on the day or days designated for the pick up thereof and for a period of not to exceed ten (10) hours prior to midnight of the day of pick up.

SECTION 3. Title VIII, Chapter 3 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended by adding thereto a new section, designated Section 24, to read as follows:

8-3-24: Any person, firm or corporation violating any of the provisions of Sections 5, 6 and 8 of this Chapter shall, upon conviction thereof, be punished by a fine of not less than Fifty (\$50.00) Dollars, nor more than Five Hundred (\$500.00) Dollars and/or imprisonment in the City Jail for not less than thirty days or more than six months. Every day of such violation shall constitute a separate offense.

SECTION 4. All ordinances or parts of ordinances, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby repealed.

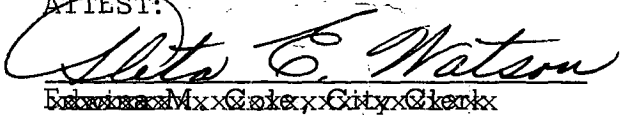

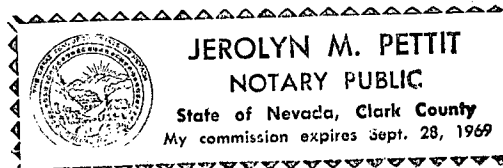

**ORDINANCE NO. 1256
AMENDED**

AN ORDINANCE TO AMEND TITLE VIII, CHAPTER 3, SECTION 8 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, PROVIDING FOR THE REGULATION OF THE HAULING OF RUBBISH; AMEND SECTION 11 OF SAID TITLE AND CHAPTER BY PROVIDING FOR TIME LIMITS FOR THE PLACING AND REMOVAL OF GARBAGE RECEPTACLES AND REGULATING THE LOCATION THEREOF; TO AMEND TITLE VIII, CHAPTER 8 OF SAID MUNICIPAL CODE BY ADDING THERETO A NEW SECTION, DESIGNATED SECTION 24, PROVIDING PENALTIES FOR THE VIOLATION HEREOF; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1. Title VIII, Chapter 3, Section 8 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

8-3-8:
COLLECTING OR TRANSPORTING OF GARBAGE: It shall be unlawful for any person, other than the City, or its authorized contractor, or his duly appointed agents, to collect, haul, convey or transport any garbage, rubbish, dirt or dead animals; provided, however, that construction rubbish and excavation debris may be removed by duly licensed building contractors; and provided further, that private persons for noncommercial purposes and not for pecuniary profit may remove, convey and transport rubbish, as defined in this Chapter, to a city owned and operated dumping ground.

SECTION 2. Title VIII, Chapter 3, Section 11 of said Municipal Code is hereby amended to read as follows:

8-3-11:
OWNERS AND RESIDENTS TO PROVIDE RECEPTACLES: Every person owning or managing any place of business, public building, multiple dwelling or residence, except as provided in Section 19 of this Chapter, shall provide a receptacle sufficient for the depositing of all garbage, rubbish and dirt from his premises. It shall be unlawful in any district classified as an "R" district under the zoning regulations of the City of Las Vegas to place, keep, store, or locate within the right-of-way of a street, sidewalk or alley, or within any front yard as defined in the zoning regulations of the City of Las Vegas, any such receptacle provided, however, such receptacle may be placed within such area for the purpose of the collection of garbage from midnight to midnight on the day or days designated for the pick up thereof and for a period of not to exceed ten (10) hours prior to midnight of the day of pick up.

SECTION 3. Title VIII, Chapter 3 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended by adding thereto a new section, designated Section 24, to read as follows:

8-3-24:
Any person, firm or corporation violating any of the provisions of Sections 5, 6 and 8 of this Chapter shall, upon conviction thereof, be punished by a fine of not less than Fifty (\$50.00) Dollars, nor more than Five Hundred (\$500.00) Dollars, and/or imprisonment in the City Jail for not less than thirty days or more than six months. Every day of such violation shall constitute a separate offense.

SECTION 4. All ordinances or parts of ordinances, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby repealed.
