

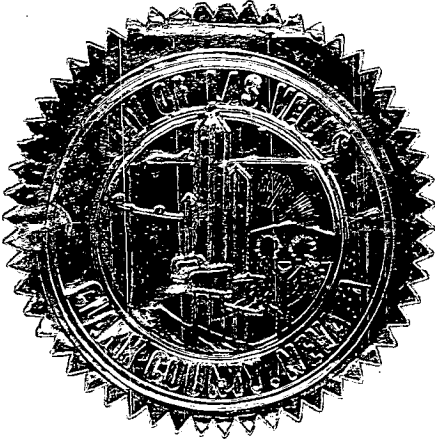
ORDINANCE NO. 1263

AN ORDINANCE TO AMEND TITLE I, CHAPTER 16 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY ADOPTING A NEW OFFICIAL SEAL OF SAID CITY; PROVIDING OTHER MATTERS PROPERLY RELATED THERETO, AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. Title I, Chapter 16 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

1-16-1: DESIGN: The Official Seal of the City shall be as herein illustrated:



1-16-2: ADOPTION: The Seal illustrated above is hereby adopted as the Official Seal of the City.

1-16-3: CUSTODIAN: The City Clerk shall be the custodian of the Official Seal of the City.

SECTION 2. All ordinances or parts of ordinances, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby repealed.

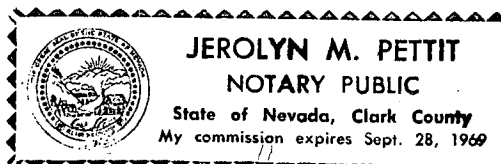

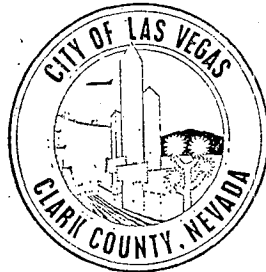
