

ORDINANCE NO. 1323

AN ORDINANCE TO AMEND ORDINANCE NO. 1306, BY REPEALING SECTION 2 THEREOF, AND TO AMEND TITLE X, CHAPTER 3 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY ADDING THERETO TWO NEW SECTIONS, TO BE DESIGNATED SECTIONS 12 AND 13; PROVIDING A MAXIMUM NUMBER OF PARKING METER EXEMPTION PERMITS TO BE ISSUED TO PRESS MEDIA AND PUBLIC OFFICIALS; PROVIDING FOR THE DISPOSITION OF NOTICES OF VIOLATIONS ISSUED IN ERROR; PROVIDING OTHER MATTERS PROPERLY RELATED THERETO; PROVIDING PENALTIES FOR THE VIOLATION HEREOF; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. Section 2 of Ordinance No. 1306 is hereby repealed.

SECTION 2. Title X, Chapter 3 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended by adding thereto two new sections, designated Sections 12 and 13, to read as follows:

10-3-12: The Director of License and Revenue shall hereafter be authorized to issue fifty eight (58) parking meter exemption permits as follows:

Certain of said exemption permits shall be issued for the benefit of press media and the utilization of said exemption permits shall be designated to personnel representing press media by the firm or company. All other exemption permits as hereinabove designated shall be issued to public officials and in every instance said exemption permits shall be utilized for official business only as

required by the respective position.

10-3-13: Non-moving violation tickets which are issued due to a non-functioning parking meter, and violations issued in error, may be referred by the Director of License and Revenue to the City Attorney for dismissal in court.

SECTION 3. Any person, firm or corporation violating any of the provisions of this ordinance shall, upon conviction thereof, be punished by a fine of not more than \$500.00 and/or imprisonment in the City Jail for not more than six (6) months, or any combination of such fine and imprisonment. Every day of such violation shall constitute a separate offense.

SECTION 4. All ordinances or parts of ordinances, section, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, in conflict herewith are hereby repealed.

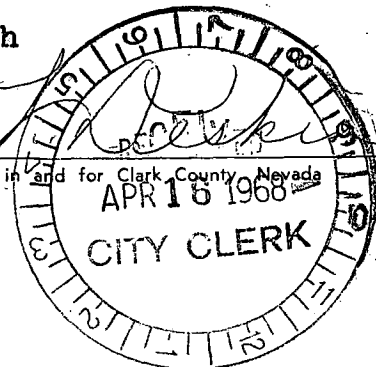
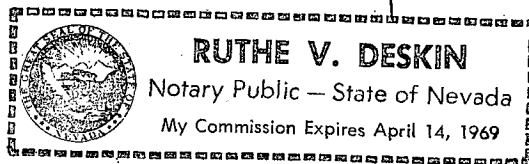
