11 THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY
12 ORDAIN AS FOLLOWS:

13 SECTION 1: Title 6, Chapter 4, Section 15, of the Municipal Code of the
14 City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

15 **6.04.015:** The license fee for an accountant is seventy-five dollars semiannually.
16 "Accountant" means each certified public accountant and public accountant registered and issued
17 a permit under NRS 628 and conducting a private practice, whether as a sole practitioner or as
18 a partner [or] , shareholder, member, associate or employee in a firm which offers or advertises
19 its services to the general public, and whether the practice is full-time or supplementary to
20 employment with a Federal, State or local government agency.

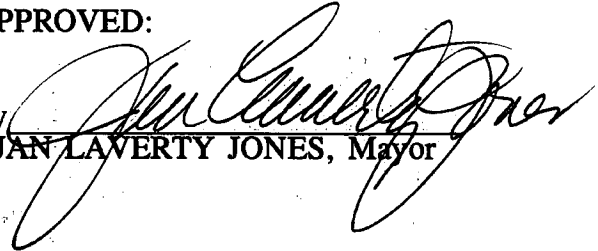
21 SECTION 2: If any section, subsection, subdivision, paragraph, sentence,
22 clause or phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional
23 or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the
24 validity or effectiveness of the remaining portions of this ordinance or any part thereof. The City
25 Council of the City of Las Vegas, Nevada, hereby declares that it would have passed each section,
26 subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that
any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases be

1 declared unconstitutional, invalid or ineffective.

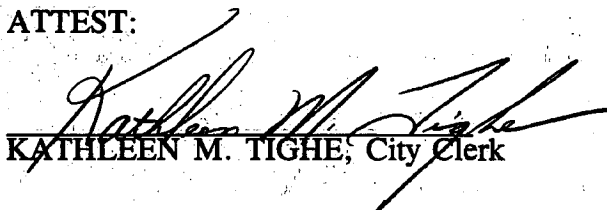
2 SECTION 3: All ordinances or parts of ordinances, sections, subsections,

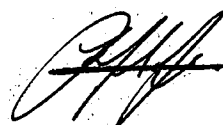

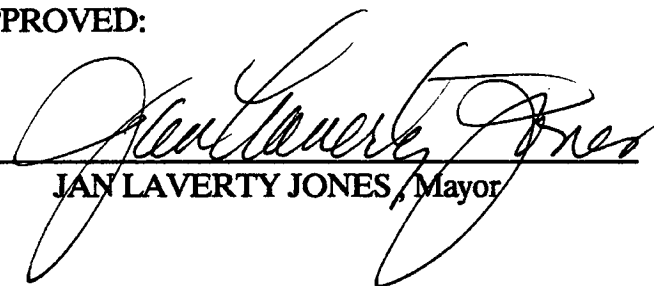

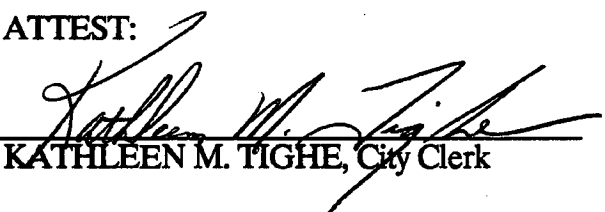
