Summary: Removes armored car service
businesses from the privileged license
category, requires said businesses to pay a
semiannual license fee in accordance with the
provisions of LVMC 6.04 and eliminates risk

11 THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY
12 ORDAIN AS FOLLOWS:

13 SECTION 1: Title 6, Chapter 10 of the Municipal Code of the City of Las
14 Vegas, Nevada, 1983 Edition, is hereby repealed.

15 SECTION 2: Title 6, Chapter 4, Section 50, of the Municipal Code of the
16 City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

17 **6.04.050:** [See LVMC 6.10 for fees and regulations on armored cars.] The license fee for
18 each armored car service business is seventy-five dollars semiannually for each
19 armored vehicle used in the business. "Armored car service business" means a
20 business that provides for hire the transportation of money, currency, bank notes,
21 money orders, bonds, notes, gaming chips, and other valuable property, instruments
22 or documents.

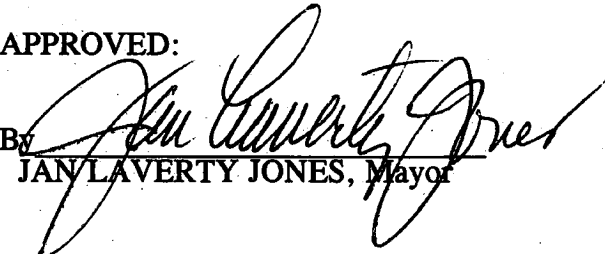
23 SECTION 3: If any section, subsection, subdivision, paragraph, sentence,
24 clause or phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional
25 or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the
26 validity or effectiveness of the remaining portions of this ordinance or any part thereof. The City

1 Council of the City of Las Vegas, Nevada, hereby declares that it would have passed each section,
2 subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that
3 any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases be
4 declared unconstitutional, invalid or ineffective.

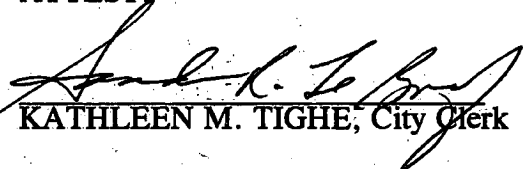
5 SECTION 4: All ordinances or parts of ordinances, sections, subsections,

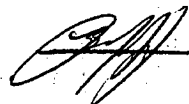

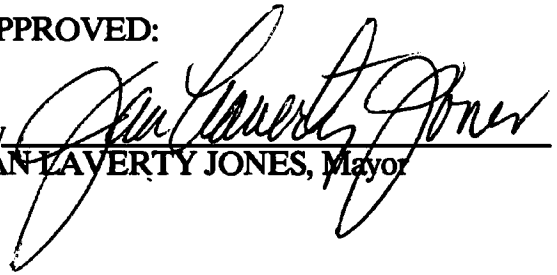

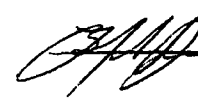
