ORDINANCE NO. 3830

AN ORDINANCE RELATING TO BUSINESS LICENSES; AMENDING TITLE 6, CHAPTER 2, SECTION 160, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, BY DELETING THE PROVISIONS PROVIDING FOR THE PRORATION OF LICENSE TAXES; AMENDING SECTION 170 OF SAID TITLE AND CHAPTER BY ESTABLISHING THE COMMENCEMENT DATE OF THE SEMIANNUAL LICENSE TAX PERIOD AND PROHIBITING PRORATING OF LICENSE TAXES BASED ON THE ACTUAL DATE THE BUSINESS STARTS; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

Summary: Establishes the commencement date of the initial semiannual license tax period for businesses and prohibits prorating these license taxes based on the actual date of commencement of business operations during the initial semiannual period.

SECTION 1: Title 6, Chapter 2, Section 160, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

6.02.160: Unless specifically provided otherwise, all license taxes imposed by this Title shall be for a semiannual period and shall be [prorated for the first period if the business does not start at the beginning of the period.] billed by the Department accordingly.

SECTION 2: Title 6, Chapter 2, Section 170, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

6.02.170: License taxes are due in advance and shall [be established in such a manner that licenses for various businesses shall fall due at different times of the calendar year, provided that like businesses, insofar as possible, shall pay their license taxes in the same month] fall due on a semiannual basis, with the initial semiannual period commencing on the date the application for business license is filed. License taxes shall not be prorated based upon the fact that a business does not start at the beginning of the initial semiannual period.

SECTION 3: If any section, subsection, subdivision, paragraph, sentence, clause or phrase in this ordinance or any part thereof, is for any reason held to be

1 unconstitutional, or invalid or ineffective by any court of competent jurisdiction, such decision
2 shall not affect the validity or effectiveness of the remaining portions of this ordinance or any part
3 thereof. The City Council of the City of Las Vegas hereby declares that it would have passed
4 each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective
5 of the fact that any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses
6 or phrases be declared unconstitutional, invalid or ineffective.

7 SECTION 4: All ordinances or parts of ordinances, sections, subsections,
8 phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las
9 Vegas, Nevada, 1983 Edition, in conflict herewith are hereby repealed.

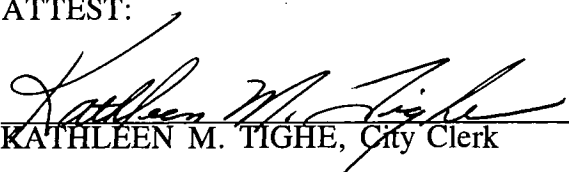

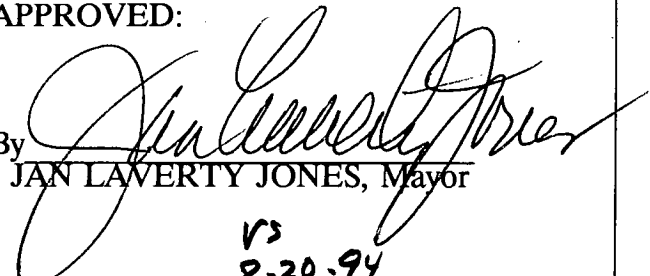

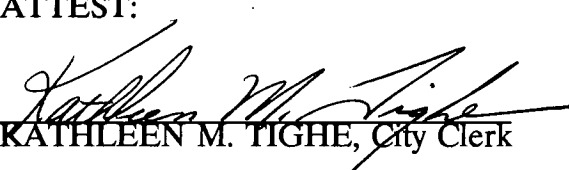
