

FIRST AMENDMENT

ORDINANCE NO. 1604

AN ORDINANCE TO AMEND TITLE X, CHAPTER 17, SECTION 24, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, TO PROVIDE FOR A LISTING OF NO PARKING ZONES DESIGNATED BY RED CURBING; PROVIDING OTHER MATTERS PROPERLY RELATING THERETO; PROVIDING PENALTIES FOR THE VIOLATION HEREOF; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS, NEVADA, DOES ORDAIN AS FOLLOWS:

SECTION 1. Title X, Chapter 17, Section 24, of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

10-17-24 PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS:


When signs are erected or red curbing is provided giving notice thereof, no person shall park a vehicle at any time upon any of the streets or parts of streets described in Schedule 17-III, a copy of which is to be maintained for public inspection in the office of the City Clerk and the City Traffic Engineer, and such other additions, deletions, corrections or amendments that may be made to said Schedule by resolution of the Board of Commissioners.

SECTION 2. Any person, firm, or corporation violating any of the provisions of this ordinance shall, upon conviction thereof, be punished by a fine of not more than \$500.00 and/or imprisonment in the City jail for not more than six (6) months, or any combination of such fine and imprisonment. Every day of such violation shall constitute a separate offense.


SECTION 3. All ordinances or parts of ordinances, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith, are hereby repealed.



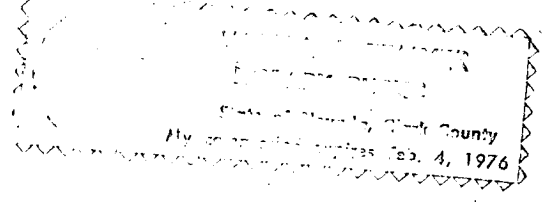
