

EMERGENCY ORDINANCE NO. 1593

AN EMERGENCY ORDINANCE TO AMEND TITLE VI, CHAPTER 1, SECTION 34 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, TO ELIMINATE THE DATE THEREFROM SO AS TO PROVIDE THAT NOT ONLY MISDEMEANORS EXISTING PRIOR TO SAID DATE, BUT ALSO THOSE MISDEMEANORS THAT MAY BE DEFINED BY THE STATE OF NEVADA AFTER SAID DATE SHALL ALSO BE MADE MISDEMEANORS WITHIN THE LAW OF THE CITY OF LAS VEGAS; PROVIDING OTHER MATTERS PROPERLY RELATING THERETO; PROVIDING PENALTIES FOR THE VIOLATION HEREOF; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH; AND DECLARING AN EMERGENCY.

WHEREAS, the Municipal Court of the City of Las Vegas is dismissing cases that are pending before the Court on the basis of said Court's interpretation of Title VI, Chapter 1, Section 34; and

WHEREAS, there are many other cases presently pending before the Court which may be dismissed as a result of a similar interpretation; and

WHEREAS, the proposed amendment herein clarifies the Code so there will be no question that the pending charges are all legal and valid; and

WHEREAS, it is in the best interests of the City of Las Vegas and the people therein that this amendment be passed as quickly as possible in order to prevent further dismissals of these cases;

NOW, THEREFORE, THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. Title VI, Chapter 1, Section 34 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

6-1-34

STATE MISDEMEANORS

The commission of any act within the corporate limits of the City or the failure to perform any act within such corporate limits, which is made a misdemeanor by the laws of the State of Nevada is hereby declared to be and shall constitute a misdemeanor.

SECTION 2. Any person, firm, or corporation violating any of the provisions of this ordinance shall, upon conviction thereof, be punished by a fine of not more than \$500.00 and/or imprisonment in the city jail for not more than six months, or any combination of such fine and imprisonment. Every day of such violation shall constitute a separate offense.

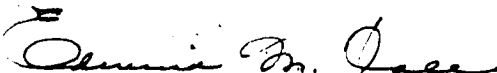
SECTION 3. All ordinances or parts of ordinances, sections, subsections,

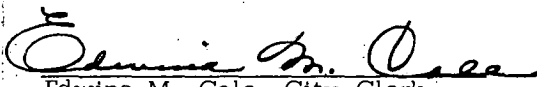

visions of this ordinance shall, upon
conviction thereof, be punished by a
fine of not more than \$500.00 and/or
imprisonment in the City Jail for not
more than six months, or any com-
bination of both; and Imprison-
ment. Every day of such violation
shall constitute a separate offense.
SECTION 3. All ordinances or
parts of ordinances, sections, subsec-
tions, phrases, clauses or para-
graphs contained in the Municipal
Code of the City of Las Vegas, Ne-
vada, 1960 Edition, in conflict here-
with are hereby repealed.
