AN ORDINANCE RELATING TO ANIMAL CONTROL; AMENDING TITLE 7, CHAPTER 20, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, BY ADDING THERETO A NEW SECTION TO PERMIT THE STERILIZATION AND VACCINATION OF FERAL CATS UNDER CERTAIN CIRCUMSTANCES; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

**Summary: Permits the sterilization and
vaccination of feral cats.**

**THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY
ORDAIN AS FOLLOWS:**

**SECTION 1: Title 7, Chapter 20, of the Municipal Code of the City
of Las Vegas, Nevada, 1983 Edition, is hereby amended by adding thereto a new section, reading
as follows:**

**Notwithstanding any other provision of this Title, a duly recognized animal
welfare society, humane organization or animal clinic, in order to encourage the
stabilization of the feral cat population in the City, may, at its own expense, do the
following with respect to a feral cat:**

- (A) Trap the animal in a humane manner;**
- (B) Have the cat properly sterilized and vaccinated for rabies; and**
- (C) Release the cat either:**
 - (1) To an Animal Control Officer for adoption or other
disposition in accordance with law; or**
 - (2) To a person who does not intend to adopt, keep or harbor
the cat, but is willing to maintain a record of the cat's
sterilization and vaccination. The licensing requirements of**

1 this Title shall not apply to any cat that has been released
2 pursuant to this Paragraph (2) if and to the extent that:

- 3 (a) The releasing organization has notched the ear of the
4 cat or otherwise identified it as a feral cat that has
5 been properly sterilized and vaccinated;
6 (b) The releasing organization has created and maintains
7 a record of the release; and
8 (c) The person to whom the cat is released maintains and
9 makes available for inspection, upon request, a
10 record of the cat's sterilization and vaccination.

11 SECTION 2: If any section, subsection, subdivision, paragraph,
12 sentence, clause or phrase in this ordinance or any part thereof is for any reason held to be
13 unconstitutional or invalid or ineffective by any court of competent jurisdiction, such decision
14 shall not affect the validity or effectiveness of the remaining portions of this ordinance or any part
15 thereof. The City Council of the City of Las Vegas, Nevada, hereby declares that it would have
16 passed each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof
17 irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs,
18 sentences, clauses, or phrases be declared unconstitutional, invalid or ineffective.

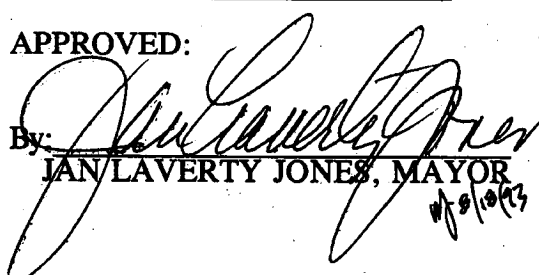

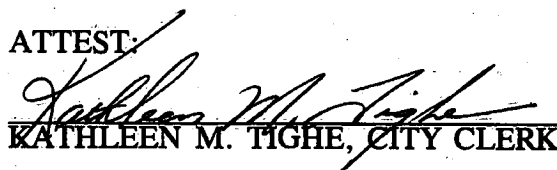

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY
ORDAIN AS FOLLOWS:

SECTION 1: Title 7, Chapter 20, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended by adding thereto a new section, reading as follows:

Notwithstanding any other provision of this Title, a duly recognized animal welfare society, humane organization or animal clinic, in order to encourage the stabilization of the feral cat population in the City, may, at its own expense, do the following with respect to a feral cat:

- (A) Trap the animal in a humane manner;
- (B) Have the cat properly sterilized and vaccinated for rabies; and
- (C) Release the cat either:
 - (1) To a person who pays all applicable licensing and other fees established under this Title; or
 - (2) To an Animal Control Officer for disposition in accordance with law.

SECTION 2: If any section, subsection, subdivision, paragraph, sentence, clause or phrase in this ordinance or any part thereof is for any reason held to be

1 unconstitutional or invalid or ineffective by any court of competent jurisdiction, such decision
2 shall not affect the validity or effectiveness of the remaining portions of this ordinance or any part
3 thereof. The City Council of the City of Las Vegas, Nevada, hereby declares that it would have
4 passed each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof
5 irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs,
6 sentences, clauses, or phrases be declared unconstitutional, invalid or ineffective.

7 SECTION 3: All ordinances or parts of ordinances, sections,
8 subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City
9 of Las Vegas, Nevada, 1983 Edition, in conflict herewith are hereby repealed.

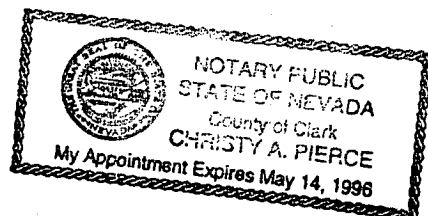

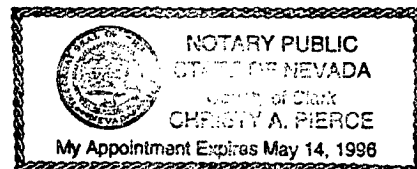

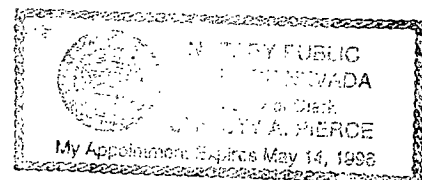
