

1 AN EMERGENCY ORDINANCE DECLARING THE DETERMINATION OF THE BOARD OF COMMIS-  
2 SIONERS OF THE CITY OF LAS VEGAS, NEVADA, TO MAKE CERTAIN PUBLIC IMPROVE-  
3 MENTS IN SAID CITY BY INSTALLING A COMPLETE STREET LIGHTING SYSTEM; TO  
4 CREATE STREET IMPROVEMENT ASSESSMENT DISTRICT NO. 100-27 FOR THE PURPOSE OF  
5 MAKING SAID IMPROVEMENTS; AND TO DEFRAY THE ENTIRE COST AND EXPENSE THEREOF  
6 BY SPECIAL ASSESSMENTS MADE ACCORDING TO FRONTAGE; FIXING A TIME IN WHICH  
7 PROTESTS AGAINST THE PROPOSED IMPROVEMENTS OR THE CREATION OF SUCH DISTRICT  
8 MAY BE HEARD AND CONSIDERED BY SAID BOARD; DIRECTING NOTICE THEREOF TO BE  
9 GIVEN; AND PROVIDING OTHER MATTERS RELATING THERETO.

10 WHEREAS, certain streets in the City of Las Vegas, Nevada, are  
11 without adequate street lighting; and

12 WHEREAS, the said Board of Commissioners deems it expedient and  
13 for the best interests of said City to improve those certain streets herein-  
14 after particularly described by installing thereon a complete street light-  
15 ing system; and

16 WHEREAS, said Board deems it expedient and desirable to create  
17 Street Improvement Assessment District No. 100-27 for the purpose of making  
18 said improvements, and to defray the entire cost and expense thereof by  
19 special assessments made according to the frontage against the owners and  
20 the assessable lots, premises, and property specially benefited by such  
21 improvements and included within said district; and

22 WHEREAS, there is included within said district some public  
23 or other property against which a valid special assessment cannot be levied  
24 by said City, but which the proportionate amounts of assessments will be  
25 paid in cash by said property owners or from the City's general funds;

26 WHEREAS, the remaining portion of the lands included within said  
27 district may be levied against by said City by a valid special assessment;  
28 and

29 WHEREAS, in no case does the estimated amount of any special  
30 assessment upon any lot or premise for said improvements exceed 50% of the  
31 value as such lot or premise as shown upon the latest tax list or assess-  
32 ment roll for State and County Tax; and

WHEREAS, in the judgment of the Board of Commissioners of said  
City of Las Vegas, it is fair and equitable that no portion of said cost  
and expense be borne by the City from its general funds except as herein  
provided; and

1 WHEREAS, at a regular meeting of the Board of Commissioners of the  
2 City of Las Vegas, held on the 17th day of February, 1954, a resolution was  
3 adopted and approved, directing the City Engineer to make estimates of the  
4 expense thereof and plats, diagrams and plans of work of the locality to be  
5 be improved, and to file such estimates, plats, diagrams and plans with the  
6 City Clerk for public examination; and

7 WHEREAS, on the 31st day of March, 1954, said estimates, plats,  
8 diagrams and plans were so filed.

9 NOW, THEREFORE, THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS  
10 DO ORDAIN AS FOLLOWS:

11 Section 1. That the Board of Commissioners of the City of Las Vegas,  
12 County of Clark, and State of Nevada, does hereby declare its determination  
13 to make certain public improvements by installing along certain streets  
14 hereinafter described a complete street lighting system, to create a special  
15 assessment district therefor, and to defray the entire cost and expense  
16 thereof by special assessments made according to frontage against the owners  
17 and the assessable lots, premises and property specially benefited by such  
18 improvements and included within said district.

19 Section 2. That the Board proposes to improve said street by  
20 constructing thereon street lighting facilities which include concrete bases,  
21 aluminum standards, mercury vapor luminaires and <sup>underground and</sup> single overhead wire and  
22 series lighting system, together with such appurtenances as may be required,  
23 as more particularly shown by the plats, diagrams and plans of the work and  
24 locality to be improved now on file in the office of the City Clerk of the  
25 City of Las Vegas.

26 Section 3. That the certain streets which the Board proposes so  
27 to have improved are the following:

28 FIRST STREET from Garces Avenue to the Police Station; SECOND,  
29 THIRD and FOURTH STREETS from Garces Avenue to the South boundary  
30 of Stewart Avenue; SIXTH and SEVENTH STREETS from Clark Avenue to  
31 the South boundary of Stewart Avenue; EIGHTH STREET from the North  
32 boundary of Bridger Avenue to the South Boundary of Stewart Avenue;  
OGDEN AVENUE from Main Street to Fifth Street and from Fifth Street  
to Eighth Street; FREMONT STREET from Main Street to Fifth Street  
and from Fifth Street to Eighth Street; CARSON AVENUE from Main  
Street to Fifth Street and from Fifth Street to Eighth Street;

1 BRIDGER AVENUE from Main Street to Fifth Street and from Fifth  
2 Street to Eighth Street; LEWIS AVENUE from Main Street to Fourth  
3 Street and from Fifth Street to Seventh Street; CLARK AVENUE  
4 FROM Main Street to Fourth Street and from Fifth Street to  
5 Seventh Street; BONNEVILLE AVENUE from Main Street to Fourth  
6 Street and GARCES AVENUE from Main Street to Fourth Street.

7 Section 4. That the special assessment district which it is pro-  
8 posed to create shall be designated Street Improvement Assessment District  
9 No. 100-27 and it shall include all the lots, premises and property, to the  
10 full depth of such, fronting, adjoining and abutting upon said street.

11 Section 5. That the City Clerk shall keep the plats, diagrams and  
12 plans of the work and locality to be improved, together with the estimates of  
13 the expense thereof, on file in her office for public inspection and examina-  
14 tion.

15 Section 6. That the Board of Commissioners of said City will meet  
16 at the City Hall in said City on Monday, the 12th day of April, 1954, at  
17 the hour of 8:00 o'clock P.M., to hear and consider any suggestions and  
18 objections that may be made by parties in interest to the proposed improve-  
19 ments or any matters relating thereto. Objections to said proposed improve-  
20 ments, or any matters relating thereto, may be filed in writing in the office  
21 of the City Clerk at any time prior to said meeting.

22 Section 7. That the City Clerk shall give notice of the filing of  
23 said estimates, plats, diagrams, and plans with the City Clerk for examination  
24 of the proposed improvement or work, of the location of the improvement, and  
25 of the district to be assessed, and of the time when the Board will meet and  
26 consider any suggestions and objections that may be made by parties in inter-  
27 est to the proposed improvements. Said notice shall be given by publication  
28 for at least once a week for two successive weeks in the Las Vegas \_\_\_\_\_  
29 Morning Sun, a daily newspaper published in said City of  
30 Las Vegas, and by posting notices in three public places near the site of  
31 said proposed work.

32 Section 8. That all by-laws, orders, resolutions and ordinances or  
parts of by-laws, orders, resolutions and ordinances in conflict with this  
ordinance, are hereby repealed.

Section 9. That if any one or more sections, sentences, clauses or parts of this ordinance shall, for any reason, be questioned, or be held invalid, such judgment shall not affect, impair or invalidate the remaining provisions of this ordinance, but shall be confined in its operation to the specific sections, sentences, clauses or parts of this ordinance so held unconstitutional and invalid, and the inapplicability and invalidity of any section, sentence, clause or part of this ordinance, in any one or more instances, shall not affect or prejudice in any way the applicability and validity of this ordinance in any other instances.

Section 10. That by reason of the fact that the streets of the City of Las Vegas are inadequate to meet the present and future needs of the City and its inhabitants and that it is necessary immediately to raise funds to improve said streets, therefore, it is hereby declared that an emergency exists, and that this ordinance is necessary for the immediate preservation of the public peace, health and safety.

Section 11. That the City Clerk and Clerk of the Board of Commissioners of the City of Las Vegas, shall cause this ordinance to be published once a week for two successive weeks immediately following its final reading and adoption, in the Las Vegas Morning Sun, a daily newspaper published in said City, and this ordinance shall become effective immediately following the second publication hereof.

Said notice shall be given by publication for at least once a week for two successive weeks in the Las Vegas Morning Sun, a daily newspaper published in said City of Las Vegas, and by posting notices in three public places near the site of said proposed work.

Section 8. That all by-laws, orders, resolutions and ordinances or parts of by-laws, orders, resolutions and ordinances in conflict with this ordinance, are hereby repealed.

Section 9. That if any one or more sections, sentences, clauses or parts of this ordinance shall, for any reason, be questioned, or be held invalid, such judgment shall not affect, impair or invalidate the remaining provisions of this ordinance, but shall be confined in its operation to the specific sections, sentences, clauses or parts of this ordinance so held unconstitutional and invalid, and the inapplicability and invalidity of any section, sentence, clause or part of this ordinance, in any one or more instances, shall not affect or prejudice in any way the applicability and validity of this ordinance in any other instances.

Section 10. That by reason of the fact that the streets of the City of Las Vegas are inadequate to meet the present and future needs of the City and its inhabitants and that it is necessary immediately to raise funds to improve said

street, therefore, it is hereby declared that an emergency exists, and that this ordinance is necessary for the immediate preservation of the public peace, health and safety.

Section 11. That the City Clerk and Clerk of the Board of Commissioners of the City of Las Vegas, shall cause this ordinance to be published once a week for two successive weeks immediately following its final reading and adoption, in the Las Vegas Morning Sun, a daily newspaper published in said City, and this ordinance shall become effective immediately following the second publication hereof.
