AN ORDINANCE TO AMEND THE MASTER PLAN OF STREETS AND HIGHWAYS THAT IS INCORPORATED BY REFERENCE INTO THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, BY TITLE 13, CHAPTER 12, SECTION 30 OF SAID MUNICIPAL CODE BY DELETING THEREFROM BRADLEY ROAD BETWEEN LONE MOUNTAIN ROAD AND CRAIG ROAD; TO PROVIDE FOR OTHER MATTERS PROPERLY RELATING THERETO AND TO REPEAL ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

Summary: Amends Master Plan of Streets and Highways by deleting Bradley Road between Lone Mountain Road and Craig Road.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: The Master Plan of Streets and Highways that is incorporated by reference into the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, by Title 13, Chapter 12, Section 30, of said Code, is hereby amended by deleting therefrom:

Bradley Road between Lone Mountain Road and Craig Road.

SECTION 2: If any section, subsection, subdivision, paragraph, sentence, clause or phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the City of Las Vegas, Nevada, hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional, invalid or ineffective.

SECTION 3: All ordinances or parts of ordinances, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada,



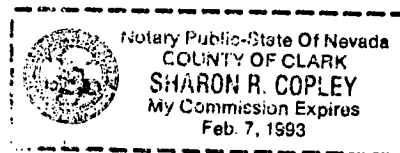
