AN ORDINANCE RELATING TO WAGERING; AMENDING TITLE 10, CHAPTER 10, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, BY ADDING THERETO A NEW SECTION, DESIGNATED AS CHAPTER 10.83; PROVIDING FOR CERTAIN DEFINITIONS; PROVIDING FOR THE PROHIBITION OF WAGERING ON INTERCOLLEGIATE ATHLETIC ASSOCIATION ATHLETIC EVENTS BY NCAA ATHLETES; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; PROVIDING PENALTIES FOR THE VIOLATION HEREOF.

Summary: An ordinance amending LVMC, Title 10, Chapter 10, by adding thereto a new section which prohibits certain types of wagering by NCAA athletes in sports books in the City.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY
ORDAIN AS FOLLOWS:

SECTION 1: Title 10, Chapter 10, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended by adding thereto the provisions that are set forth as Sections 2 and 4, inclusive, of this Ordinance.

SECTION 2: As used in this Chapter, unless the context otherwise requires, the following terms shall have the meaning that are ascribed to them as follows:

"Book" means a sports pool licensed and approved pursuant to NRS 463 and regulation 22 of the Regulations of the Nevada Gaming Commission and State Gaming Control Board, as adopted July 1, 1959, and as amended from time to time.

"Establishment" means any premises where business is conducted and includes all buildings, improvements, equipment and facilities used or maintained in connection with such business.

"Institution" means a public or private entity that offers educational training beyond the secondary level. The term also includes:

(1) A postsecondary education institution as defined in NRS 394.099; and

1 (2) A university as defined in NRS 396.838.

2 "Intercollegiate athletic event" means competition, a
3 contest, a game, a match, a meeting or an occurrence between
4 individuals or teams of individuals who attend as students insti-
5 tutions that are members of the National Collegiate Athletic
6 Association and who are developed, talented or trained in physi-
7 cal exercises, games, skills or sports requiring human strength,
8 agility or stamina, and the winner of which competition, contest,
9 game, match, meeting or occurrence is determined by a score of
10 points either earned during the event or awarded by judges of the
11 event or by favorably completing the competition according to a
12 formula of time or a formula of points and time for certain acts
13 performed during the event.

14 "National Collegiate Athletic Association" means a group
15 of institutions of forty or more states which is governed by the
16 rules of the association relating to athletic competition.

17 "Parlay card wager" means a wager on the outcome of a
18 series of three athletic events, at least one of which is an
19 intercollegiate athletic event, or a series of three or more con-
20 tingencies at least one of which is incident to an inter-
21 collegiate athletic event.

22 "Sports Pool" means a business that accepts wagers on
23 intercollegiate athletic events, or other events, other than
24 horse or other races. The term includes, but is not limited to,
25 a business that accepts parlay card wagers.

26 "Student athlete" means a person who is eligible to and
27 does compete individually or as a member of a team in inter-
28 collegiate athletic events at an institution that is a member of
29 and subject to the rules of the National Collegiate Athletic
30 Association.

31 SECTION 3: It is unlawful for any establishment that
32 owns, operates or maintains any book or sports pool to knowingly

1 accept from any student athlete an individual wager or parlay
2 card wager on an intercollegiate athletic event.

3 SECTION 4: It is unlawful for any student athlete to
4 knowingly wager on an intercollegiate athletic event at any
5 establishment that owns, operates or maintains a book or sports
6 pool.

7 SECTION 5: If any section, subsection, subdivision,
8 paragraph, sentence, clause or phrase in this ordinance or any
9 part thereof is for any reason held to be unconstitutional or
10 invalid or ineffective by any court of competent jurisdiction,
11 such decision shall not affect the validity or effectiveness of
12 the remaining portions of this ordinance or any part thereof.
13 The City Council of the City of Las Vegas, Nevada, hereby
14 declares that it would have passed each section, subsection, sub-
15 division, paragraph, sentence, clause or phrase thereof
16 irrespective of the fact that any one or more sections, subsec-
17 tions, subdivisions, paragraphs, sentences, clauses, or phrases
18 be declared unconstitutional, invalid or ineffective.

19 SECTION 6: Whenever in this ordinance any act is prohi-
20 bited or is made or declared to be unlawful or an offense or a
21 misdemeanor, or whenever in this ordinance the doing of any act
22 is required or the failure to do any act is made or declared to
23 be unlawful or an offense or a misdemeanor, the doing of such
24 prohibited act or the failure to do any such required act shall
25 constitute a misdemeanor and upon conviction thereof, shall be
26 punished by a fine of not more than \$1,000.00 or by imprisonment
27 for a term of not more than six months, or by any combination of

1 such fine and imprisonment. Any day of any violation of this
2 ordinance shall constitute a separate offense.

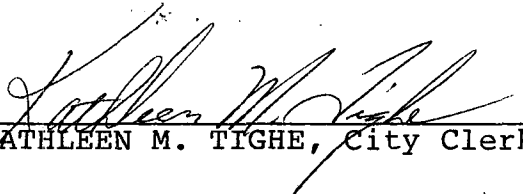
3 SECTION 7: All ordinances or parts of ordinances, sec-
