AN ORDINANCE RELATING TO APPLICATIONS FOR SPECIAL USE PERMITS FOR SLOT MACHINE GAMING; AMENDING TITLE 19, CHAPTER 90, SECTION 20, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, BY ADDING THERETO A SUBSECTION TO ALLOW A LESSEE OF PREMISES TO SIGN THE APPLICATION REQUIRED FOR A SPECIAL USE PERMIT; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HERewith.

Summary: Allows a lessee of premises, rather than the owner, to file the required application for a special use permit to use the premises for slot machine gaming.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY
ORDAIN AS FOLLOWS:

SECTION 1: Title 19, Chapter 90, Section 20, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

19.90.020: (A) An application for a special use permit shall be filed with the Secretary of the Board of Zoning Adjustment at the office of the Department of Community Planning and Development, upon a form provided by the Department of Community Planning and Development. Except as provided in subsection (B), [The] the application shall be signed and acknowledged in the same manner as is provided for with respect to variance applications under Chapter 19.88 and shall be accompanied by the same plans, attachments and exhibits, including elevations and renderings where necessary, as are required for variance applications. No application for a special use permit on property for the same use, a similar use, or a less restrictive use, for which all or any part has been previously denied, or for which a previous application has been withdrawn subsequent to a public hearing, shall be accepted until at least four months have elapsed between the date of such denial or withdrawal and the date of the meeting for which the proposed application would be

1 scheduled in the ordinary course. In addition, a period of eight
2 months from the date of a second denial or any subsequent denial
3 must elapse before an application may be filed for the same use,
4 a similar use, or a more intensive use. No application for a
5 special use permit for which there has been previously filed an
6 application for a variance or a reclassification for the same
7 use, a similar use, or a more intensive use shall be accepted
8 until the above time limits have elapsed.

9 (B) Applications for a special use permit pursuant to
10 the requirements of LVMC 6.40.140(C) and LVMC 6.40.150(E) may be
11 signed and acknowledged by a lessee of the premises; provided,
12 however, that a lessee/applicant must provide copies of its lease
13 agreements to show that there are no prohibitions therein to
14 conducting gaming operations on the leased premises. The appli-
15 cation need only be accompanied by the applicable lease docu-
16 ments, a diagram showing in general the floor plan location of
17 the slot machines and the requisite fee.

18 SECTION 2: If any section, subsection, subdivision,
19 paragraph, sentence, clause or phrase in this ordinance or any
20 part thereof, is for any reason held to be unconstitutional or
21 invalid or ineffective by any court of competent jurisdiction,
22 such decision shall not affect the validity or effectiveness of
23 the remaining portions of this ordinance or any part thereof.
24 The City Council of the City of Las Vegas, Nevada, hereby
25 declares that it would have passed each section, subsection, sub-
26 division, paragraph, sentence, clause or phrase thereof irrespec-
27 tive of the fact that any one or more sections, subsections, sub-
28 divisions, paragraphs, sentences, clauses or phrases be declared
29 unconstitutional, invalid or ineffective.

30 SECTION 3: All ordinances or parts of ordinances,
31 sections, subsections, phrases, sentences, clauses or paragraphs
32 contained in the Municipal Code of the City of Las Vegas, Nevada,

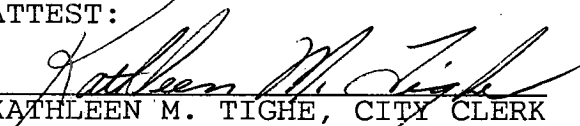
