

ORDINANCE NO. 1761

AN ORDINANCE TO AMEND TITLE I, CHAPTER 5 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY DELETING SECTION 6 THEREOF (REPEALING ORDINANCE NO. 1733) AND BY ADDING A NEW SECTION THEREOF DESIGNATED AS SECTION 8, DIVIDING THE CITY INTO FOUR WARDS AND PROVIDING FOR THE ELECTION OF CITY COMMISSIONERS THEREFROM, AND DIVIDING THE WARDS TO INCLUDE VOTING DISTRICTS; PROVIDING OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HERewith.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN
AS FOLLOWS:

SECTION 1. Title I, Chapter 5 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended below, repealing Ordinance No. 1733.

SECTION 2. Title I, Chapter 5 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended by adding thereto a new Section 8 to read as follows:

1-5-8: Division of City into Wards and the Election of City Commissioners therefrom:

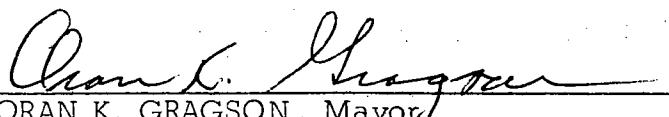
- A. The City of Las Vegas, Nevada, will be divided into Wards number 1, 2, 3, and 4 to include Voting Districts.
- B. Ward No. 1 shall include District Nos. 7, 9, 10, 11, 13, 22, 34, 35, 36, 37, 38, 39, 40, 41, 44, 45, 46, 49, 51, 60, 80, 81.
- C. Ward No. 2 shall include District Nos. 12, 16, 17, 18, 19, 20, 21, 25, 26, 27, 61, 62, 63, 65, 66, 67, 74, 77, 78, 79, 84.
- D. Ward No. 3 shall include District Nos. 1, 5, 8, 14, 15, 28, 29, 42, 43, 47, 48, 50, 55, 56, 57, 58, 59, 68, 69, 70, 71, 72.
- E. Ward No. 4 shall include District Nos. 2, 3, 4, 6, 23, 24, 30, 31, 32, 33, 52, 54, 64, 73, 75, 76, 82, 83, 85, 86, 87.
- F. Primary Municipal Elections
 - (1) At the general municipal election in 1975 and every four years thereafter, there shall be elected one Commissioner from Ward 1 and one Commissioner from Ward 3 for a term of four years.
 - (2) At the general municipal election in 1977 and every four years thereafter, there shall be elected one Commissioner from Ward 2 and one Commissioner from Ward 4 for a term of four years.

SECTION 3. All ordinances or parts of ordinances, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, 1960 Edition, in conflict herewith are hereby repealed.

SECTION 4. If any section, paragraph, sentence, phrase, term, word, or connotation of this ordinance, or portion thereof, is for any reason held invalid, inapplicable, or unconstitutional by any Court of competent jurisdiction, such holding shall not invalidate the remaining portions of this ordinance.

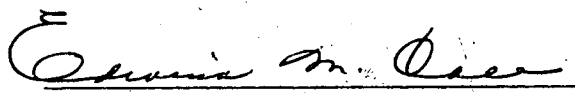

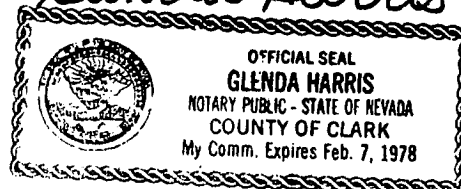

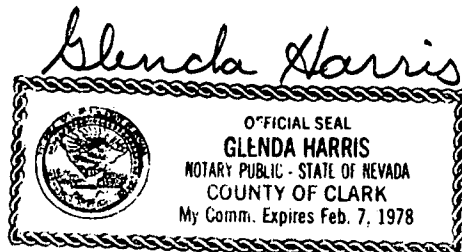
