

ORDINANCE NO. 1749

AN ORDINANCE TO AMEND TITLE VI, CHAPTER 5 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY CHANGING ALL REFERENCE THEREIN OF "POLICE DEPARTMENT" TO "LAS VEGAS METROPOLITAN POLICE DEPARTMENT" AND ALL REFERENCE THEREIN OF "CHIEF OF POLICE" TO "SHERIFF", AND BY ADDING A NEW PARAGRAPH TO SECTION 3 REQUIRING ALL APPLICANTS FOR WORK REGISTRATION CARDS TO FIRST PRODUCE A BIRTH CERTIFICATE, NATURALIZATION CERTIFICATE, OR AN ALIEN REGISTRATION CARD SHOWING LEGAL RESIDENCE IN THE UNITED STATES; PROVIDING OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN
AS FOLLOWS:

WHEREAS, the Board of Commissioners of the City of Las Vegas is informed and does believe that there are approximately four million illegal aliens living in the United States, and

WHEREAS, these illegal aliens are causing law enforcement and economic problems in the areas in which they reside, and

WHEREAS, it is the desire of the Board of Commissioners of the City of Las Vegas to not further perpetuate the problem of illegal aliens within this country.

SECTION 1. Title VI, Chapter 5 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended as follows:

6-5-1 DEFINITIONS: Whenever used in this Chapter unless the context otherwise requires:

"Employees of gambling houses" shall mean all dealers, shills, greeters, or any other person receiving a salary or percentage of profit from a gambling game or a gambling house (except slot machines, pin ball machines, and any other mechanically operated game where no attendant is required) as such games are defined in this Code, excluding stockholders who have no direct control of said operation.

"Employees of establishments where alcoholic beverages are sold at retail on the premises" shall mean bartenders, bus boys, bar managers, waiters, waitresses, security guards and greeters, and any other persons who serve alcoholic beverages to patrons for consumption on the premises.

"Taxi drivers" shall include all persons who drive any motor vehicle or conveyance used in the City for the purpose of transporting persons for hire, save and except those persons employed for hire to transport persons in interstate traffic exclusively, and those persons for hire to operate buses which operate under a City franchise.

"Alcoholic beverages" shall mean, and include, any and all distilled or rectified spirits, potable alcohol, brandy, whiskey, rum, gin, aromatic bitters, beer, wine, and every liquid or solid containing alcohol capable of being consumed by a human being.

6-5-2 POLICY: It is hereby declared to be the policy of the City, as herein expressed, that the safety, morals, good order and general welfare of the inhabitants of the City will be better protected and served by requiring the registration with the Las Vegas Metropolitan Police Department, which shall include fingerprinting and photographing of all employees of gambling houses, taxi drivers, and employees of establishments where alcoholic beverages are sold at retail and served on the premises as such employees and establishments are defined in Section 1.

6-5-3 COMPLIANCE REQUIRED: It shall be unlawful for any person to accept employment in any gambling house or as a driver or operator of any taxi cab or in any establishment where alcoholic beverages as defined in this Chapter are sold at retail and consumed on the premises unless such person shall have first registered his name and address with the Las Vegas Metropolitan Police Department and shall have had his fingerprints and photograph taken and filed with the Bureau of Identification of the City and have received a certificate showing compliance therewith.

Every person seeking to be registered under the provisions of this Chapter shall first pay to the City the sum of three dollars and fifty cents (\$3.50) as a condition precedent to having issued to him or her the certificate provided in Section 6-5-5.

Every person registered pursuant to the provisions of this Chapter seeking a replacement or reissuance of a certificate previously issued to him or her shall pay the City the sum of one dollar (\$1.00) for such replaced or re-issued certificate.

Every person seeking to be registered under the provisions of this Chapter shall first produce a birth certificate, naturalization certificate, alien registration card, or any other document satisfactorily evidencing to the Sheriff of the Las Vegas Metropolitan Police Department his or her legal residence in the United States as a condition precedent to having issued to him or her the certificate provided in Section 6-5-5.

6-5-4 TAXICAB; RESIDENCY: No person shall operate a taxicab as chauffeur thereof within the City limits of Las Vegas unless and until said person shall have been a resident within the County of Clark, State of Nevada, for a period of six (6) months immediately preceding the granting of said permit. Every person seeking said taxicab chauffeur permit shall acknowledge in writing by affidavit that he has been or will be a resident as above required for a period of six (6) months prior to the issuance of said permit.

PERMANENT REGISTRATION CARD: Upon such employee complying with the provisions of Section 6-5-3 hereof, and there being no immediate record of conviction of a felony or two (2) or more misdemeanors involving moral turpitude, the [Chief of Police] Sheriff shall issue to such employee a permanent registration card. The Bureau of Identification shall forthwith send a copy of such imprints to the Bureau of Identification of the State and one (1) copy to the Identification Bureau of the Federal Bureau of Investigation with the request that all information as to the previous record, if any, of such person be forthwith transmitted to the Bureau of Identification of the City. Upon receipt of such information, the Bureau shall forthwith notify the [Chief of Police] Sheriff. The information, if any, received as aforesaid, shall be treated as confidential and shall only be made accessible to the Mayor and Board, the City Manager, the City Attorney, the employer of such person, and to law enforcement officers.

CERTIFICATE:

- (A) The [Chief of Police] Sheriff shall issue a permanent registration certificate; however, he shall have power and authority to revoke the certificate of any person whose investigation reveals has been convicted of a felony or two (2) or more misdemeanors involving moral turpitude.
- (B) When the [Chief of Police] Sheriff shall have issued any certificate to any individual as a gambling house employee, employee of an establishment where alcoholic beverages are sold, or taxi driver, the same may be revoked at any time thereafter by the [Chief] Sheriff if such individual shall be convicted of a felony, convicted of two (2) or more misdemeanors involving moral turpitude, or convicted of a violation of any provision of the gaming or liquor control ordinances of the City of Las Vegas.
- (C) The [Chief of Police] Sheriff shall make available to each employing establishment within the City a post card with the following information typed thereon, and it shall be the duty of the payroll Clerk of each establishment to fill in the information on said card and mail it to the [Chief of Police at 400 North 1st Street,] Sheriff at 200 East Carson Avenue, Las Vegas, Nevada, within a period of five (5) days from the date said registered employee becomes employed within said establishment:

(D) Every person licensed under the provisions of this Chapter shall have in his possession at all times while working the certificate provided for herein.

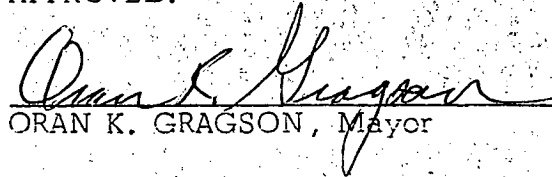
6-5-7 MISDEMEANOR DECLARED: It shall be unlawful for any person, firm or corporation operating a gambling game, a taxicab or an establishment where alcoholic beverages are sold at retail for consumption on the premises, to employ any person required to register with the Las Vegas Metropolitan Police Department by the terms of this Chapter unless such person shall have so registered with the Las Vegas Metropolitan Police Department and have a valid existing certificate.

SECTION 2. All ordinances or parts or ordinances, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby repealed.

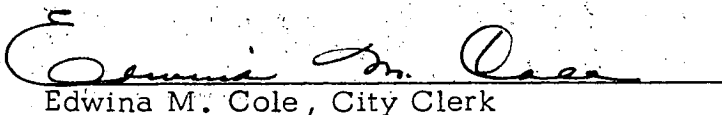

If any section, paragraph, sentence, phrase, term, word or connotation of this ordinance, or portion thereof, is for any reason held invalid, inapplicable, or unconstitutional by the Court of competent jurisdiction, such holding shall not invalidate the remaining portions of this ordinance.

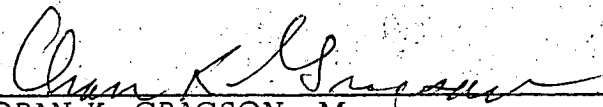

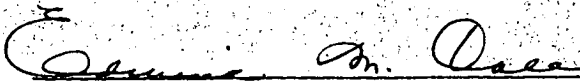
