

ORDINANCE NO. 1748

AN ORDINANCE TO AMEND TITLE XI, CHAPTER 1, SECTION 24, SUBSECTION (A), PARAGRAPH 6, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, 1960 EDITION, TO PROVIDE A \$100 FILING FEE FOR A VARIANCE APPLICATION; TO AMEND PARAGRAPH 10 OF SAID TITLE, CHAPTER, SECTION AND SUBSECTION TO PROVIDE AN APPLICANT FOR VARIANCE MAY APPEAL DECISION OF BOARD OF ZONING ADJUSTMENT WITHIN ELEVEN DAYS AFTER DATE OF DECISION OF SAID BOARD; PROVIDING OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS, NEVADA,  
DOES ORDAIN AS FOLLOWS:

SECTION 1. Title XI, Chapter 1, Section 24, Subsection (A), Paragraph 6, of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

11-1-24 (A) 6. Filing Fee: To partially defray the cost of making maps, sending out hearing notices and other incidental administrative and investigative expense involved in any application for a variance, the Secretary of the Board of Zoning Adjustment is authorized to make a uniform charge of [seventy-five dollars (\$75.00)] one hundred dollars (\$100.00) payable to the City. This charge shall be due and payable at the time of filing such application.

SECTION 2. Title XI, Chapter 1, Section 24, Subsection (A), Paragraph 10, of said Municipal Code is hereby amended to read as follows:

11-1-24 (A) 10. Notice of Decision: Not later than five (5) days following the rendering of a decision either for the granting or denial of an application for a variance, a copy of the report of the Board of Zoning Adjustment shall be mailed to the applicant and to his attorney or agent, if any, at the address shown on the application filed with the Secretary of the Board of Zoning Adjustment. A copy of said report shall also be filed with the Clerk, acting as agent for the Board of Commissioners.

The applicant or any other person aggrieved may appeal the decision of the Board of Zoning Adjustment by written request filed with the City Clerk [not less than] within

eleven (11) days after the date of decision by the Board of Zoning Adjustment. In addition, there is reserved to the Board of Commissioners the power to reverse, modify, or confirm any action of the Board of Zoning Adjustment by any member of the Board of Commissioners making a request to review said decision in any regularly conducted commission meeting within fourteen (14) days of the date of the decision of the Board of Zoning Adjustment. Such a request by any member of the Board of Commissioners shall have the same effect as the filing of an appeal by the applicant or an aggrieved person and the same procedures as set forth herein shall apply to the request for review the same as for an appeal. The filing of an appeal or the adoption of a request to review by any member of the Board of Commissioners within the time limit specified shall stay the effective date of the decision of the Board of Zoning Adjustment until such time as the Board of Commissioners has acted on the appeal as hereinafter set forth in the Chapter. Otherwise the decision of the Board of Zoning Adjustment becomes final and effective at the expiration of fourteen (14) days after the decision of the Board of Zoning Adjustment. Once an appeal has been filed with the City Clerk, it cannot be withdrawn without the approval of the Board of City Commissioners.

SECTION 3. All ordinances or parts of ordinances, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby repealed.

SECTION 4. If any section, paragraph, sentence, phrase, term, word, or connotation of this ordinance, or portion thereof, is for any reason held

invalid, inapplicable, or unconstitutional by any Court of competent jurisdiction, such holding shall not invalidate the remaining portions of this ordinance.

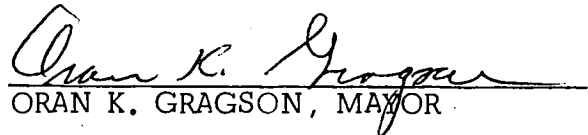
