

ORDINANCE NO. 1739

FIRST AMENDMENT

AN ORDINANCE TO AMEND TITLE I, CHAPTER 19, SECTION 1, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY REQUIRING ALL MEMBERS OF ALL ADMINISTRATIVE BOARDS TO ATTEND 75 PERCENT OF ALL REGULAR MEETINGS; PROVIDING OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. Title I, Chapter 19, Section 1 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended as follows:

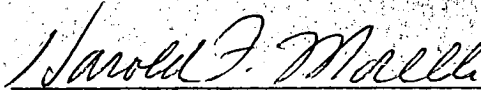
1-19-1 NEGLECT OF DUTY: Any appointive member of an Administrative Board established by the Board of Commissioners [who shall fail to attend three (3) consecutive meetings of the respective board of which he is a member shall be deemed to be in neglect of duty and such failure to attend meetings without being excused therefrom by the Chairman shall constitute prima facie evidence of neglect of duty. In the event the Chairman of any such Board shall fail to attend three (3) consecutive meetings without first having been excused by the City Manager, such failure to attend shall constitute prima facie evidence of neglect of duty.] must attend 75 percent of all regular meetings, of which they have notice, excluding excused absences. Failure to attend 75 percent of such meetings shall constitute sufficient grounds for the Board of Commissioners, at its discretion, to remove said member and declare the position vacant.

SECTION 2. All ordinances or parts of ordinances, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby repealed.

SECTION 3. If any section, paragraph, sentence, phrase, term, word or connotation of this ordinance, or portion thereof, is for any reason held invalid, inapplicable, or unconstitutional by any Court of competent jurisdiction, such holding shall not invalidate the remaining portions of this ordinance.

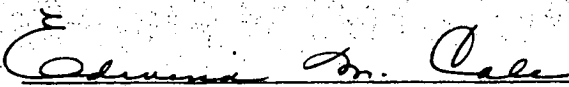
