

ORDINANCE NO. 1721

AN ORDINANCE TO AMEND TITLE V, CHAPTER 1, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY ADDING THERETO TWO NEW SUB-SECTIONS DESIGNATED (a) and (b) OF TITLE V, CHAPTER 1, SECTION 1, TO PROVIDE FOR THE ISSUANCE OF A TEMPORARY BUSINESS LICENSE PENDING APPROVAL AND ISSUANCE OF A CITY BUSINESS LICENSE; PROVIDING THE PROCEDURE FOR ISSUANCE AND TERMINATION THEREOF; PROVIDING PENALTIES FOR THE VIOLATION HEREOF; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

WHEREAS, the City of Las Vegas has determined that the policy of permitting no one to open a business pending inspections and approval of a business license may not be in the best interests of the commerce within the City of Las Vegas; and

WHEREAS, the businesses and services which seek to be licensed may be of an emergency nature to some residents of the City of Las Vegas; and

WHEREAS, the residents, tourists and people of the City of Las Vegas may be desirous of having said services and businesses open to serve the public as soon as possible so long as safety and the general welfare is insured; and

WHEREAS, there may not be sufficient time through the normal process of adopting ordinances to state and effectuate the policy of the City of Las Vegas;

NOW, THEREFORE, THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1, Title V of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended by adding thereto two new sub-sections to be designated (a) and (b) to read as follows:

5-1-1 (a). Upon the filing of a complete and accurate business license application and the payment of all fees relating thereto, the applicant may be issued a temporary business license by the Director of License & Revenue of the City of Las Vegas. Provided, however, that all inspections relating to the Uniform Fire Code, proper zoning and structural building requirements have first been made and tentatively approved by the proper department within the City of Las Vegas. This temporary business license shall permit the

applicant to engage in the business designated at the location so stated for a period of up to, but not to exceed, 60 days within which all inspections and requirements imposed upon the applicant by the various Departments of the City of Las Vegas are to be complied with. Upon recommendation by the departments within the City of Las Vegas, the Director of License & Revenue shall have the discretion to extend said temporary business license for a period of an additional 60 days. The denial by the Director of License & Revenue of the City of Las Vegas of an additional 60 day extension is appealable to the Board of City Commissioners of the City of Las Vegas. It is the applicant's burden to calendar and present any and all facts and mitigating circumstances to the next regularly scheduled meeting of the Board of City Commissioners.

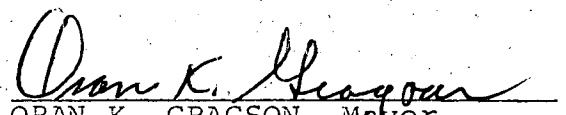
5-1-1 (b). The above stated provisions for a temporary business license shall not apply or be applicable to any privileged business license or any business which requires formal approval by the Board of City Commissioners of the City of Las Vegas.

SECTION 2. Any person, firm, or corporation violating any of the provisions of this ordinance shall, upon conviction thereof, be punished by a fine of not more than \$500.00 and/or imprisonment in the city jail for not more than six (6) months or any combination of such fine and imprisonment. Every day of such violation shall constitute a separate offense.

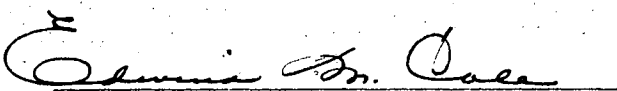
